This Forward Plan supersedes all previous Forward Plans.

The Date of Consideration indicated is the earliest date by which it is proposed the Council Cabinet will consider the matter.

Summary – An LGA Peer Review in 2019 found that the Council was extremely inconsistent in branding and messaging, as well as raising concerns about the current brands overall effectiveness. A proliferation of sub brands have also been created, without there appearing to be any overarching strategy or rationale, other than short-term promotion. This matters because it means there is a real risk the council will not get the credit for the popular services it provides – and can therefore adversely impact on its reputation and the levels of trust people have, creating a vicious circle where unfavourable views of the council are not addressed because people do not appreciate what it does. The Peer Review recommended an evaluation of the (30 year-old) Council's brand and corporate identity, to ensure it is consistent and stronger. This Cabinet report will present next steps and seek approval for funding to continue that work.
