

Report of the Strategic Director of Children and Young People

Inspection of services for children in need of help and protection, children looked after and care leavers – self-assessment and improvement plan

## SUMMARY

- 1.1 In April 2014 Andrew Bunyan, Strategic Director for Children and Young People's Services and Sarah Walker, Improvement Partner for Children and Young People's Services attended the Children and Young People's Overview and Scrutiny Board to brief members on the single social care inspection framework.
- 1.2 The framework was introduced in November 2013 and at the end of August 2014 31 authorities had been inspected under the framework, with the largest proportion being judged as 'requires improvement'...
  - Inadequate 6 out of 31 authorities (19%)
  - Requires improvement 16 out of 31 (52%)
  - Good 9 out of 31 (29%)
- 1.3 To support preparations for an inspection officers have completed a self-assessment against the key lines of enquiry in the inspection framework. Linked to this, previous inspection recommendations from the Safeguarding and Looked After Children inspection (May 2011) and the Child Protection inspection (December 2012) have been reviewed and built into the supporting improvement plan.
- 1.4 Andrew Bunyan and Sarah Walker will attend the meeting to give a presentation on Derby's self-assessment and supporting improvement plan.

#### **REASONS FOR RECOMMENDATIONS**

- 3.1 Ofsted will inspect all local authorities on a three-year cycle under the new framework. Making sure that staff and members are briefed on the requirements of the framework and the associated judgement areas is critical to Derby's preparations and a 'good' outcome.
- 3.2 The inspection framework will also assess whether Derby is meeting its' corporate
