Terms of Reference for the Review of the Evening and Night Time Economy

SUMMARY

1.1 This report considers proposals for a review of the Night Fine Economy to complement the Purple Flag scheme to tackle crime and antisocial activities linked to binge drinking in the city. It suggests a draft terms of reference for the review.

RECOMMENDATION

2.1 To consider and agree the Terms of Reference for the Review of the Night Time Economy.

REASONS FOR RECOMMENDATION

3.1 The Commission needs to identify areas which complement the Purple Flag and support the licensing policy in tasking crime and anti social issues linked to binge drinking.

SUPPORTING INFORMATION

- 4.1 The bar and pub industry is the mainstay of most town and cities at night and Derby is no exception. However there have been concerns about crime and antisocial behaviour linkes to binge drinking and extended licensing hours particularly in the city centre ever a number of years. This led to a motion being approved by the Full Council in 2008 requesting the Licensing Committee to review the Council's Licensing Policy in association with the relevant overview and scrutiny commission. The Policy was duly reviewed by Scrutiny Management Commission and a set of actions were agreed which are being implemented.
- 4.2 Also the City Council is working in partnership with local retailers and the city centre management to achieve a Purple Flag status in the city centre.

However there still have concerns about crime and disorder issues linked to binge drinking in certain parts of the city centre and members therefore wish to conduct a review in the night time economy. Draft terms of reference for the review are attached in appendix 2 for member consideration.

Terms of Reference

The review would focus primarily on crime and antisocial activities linked to the night time economy.

What the review may wish to consider

To consider the affects of late night opening of licensed premises on

- crime and antisocial behaviour activities e.g. noise; litter; chewing gum; graffiti; flyposting; vandalism; street urination and fouling; violence; anti-social behaviour; CCTV
- night time policing
- health and well-being e.g. A&E attendance as directives wit of late night drinking; alcohol related illness
- Local economy such as pubs, clubs; takeaways; public and private transport services

To consider how the night time activities could be better managed to make a positive contribution to the social and economic aspects city.
