Permits

Local authorities already issue some permits or registrations for activities under existing gambling legislation. Under the Gambling Act 2005, the Council will be responsible for issuing:

- Unlicensed Family Entertainment Centre Gaming Machine Permits
- Registration of small lottery licences
- Club Gaming Permits
- Club Gaming Machine Permits
- Licensed Premises Gaming machine Permits
- Prize Gaming Permits

These permit fees are prescribed by Central Government and the Licensing Authority has no discretion in this matter. At the time of writing the only published fees are listed below.
