#### Letter of Fire Safety Matters

# Premises: THE HAIRY DOG, 1 BECKET STREET, DERBY DE1 1HT

I visited your premises on 24 May 2021 and evaluated the fire safety provided. I am pleased to advise you that you showed adequate safety. However, I am of the opinion that you can improve that safety. The attached schedule sets out my suggested improvements. There is no time limit associated with this letter. I do not intend to return in connection with this visit.

I checked the Primary Authority Register on 28 May 2021. I found no record of The Hairy Dog in relation to Fire Safety Enforcement.

### **Outcome**

This work is necessary to make sure that escape routes (corridors, stairs and doors) can be safely used whenever they are needed.

# **Suggested Action**

Re-locate the LPG fixed installation point to a more suitable location. It should be located outdoors, away from exits and in a place where they cannot be interfered with. It should be installed as per UKLPG Code of Practice No 7 and commissioned by a competent person.

# <u>Reason</u>

The LPG fixed installation point was located indoors, on an escape route/stairway and not suitably ventilated or protected from fire.

### **Outcome**

This work is necessary to make sure that escape routes (corridors, stairs and doors) can be safely used whenever they are needed.

### **Suggested Action**

Re-locate the spare LPG cylinders to a more suitable location. They should be stored in a lockable cage outdoors. It should be stored as per UKLPG Code of Practice No 7 and suitably risk assessed by a competent person.

### <u>Reason</u>

The spare cylinders were located indoors, on an escape route/stairway and not suitably ventilated or protected by fire.

# **Outcome**


This work is necessary to reduce the risk of fire.

# Suggested Action

Inspect and test the electrical fixed wiring installations. This should be carried out by a suitably qualified and competent person, at an interval of no longer than 5 years.

# <u>Reason</u>

There was no evidence that the electrical fixed wiring installations had been inspected and tested.

#### Enforcement Notice

The Regulatory Reform (Fire Safety) Order 2005: Article 30

Premises: THE HAIRY DOG, BECKET STREET, DERBY, DE1 1HT

An authorised inspector visited your premises on 14 July 2022 and evaluated the fire safety provided. The Derbyshire Fire and Rescue Authority is of the opinion that you have failed to comply with a provision / provisions of the Regulatory Reform (Fire Safety) Order 2005 because people were unsafe in case of fire. The schedule to this Notice further explains the provision(s), with which you have not complied.

The serving of this Notice dated 15 July 2022 and numbered 697-675/SL/MH/1 is necessary to ensure that you adequately protect people in case of fire. This authority has to make sure that you provide safety. The attached schedule sets out what you must do.

I checked the Primary Authority Register on 15 July 2022. I found no record of HD Entertainment Limited in relation to Fire Safety Enforcement.

#### Timescale for Completion

You are required to take steps to remedy the matters in the schedule within a period of six weeks (from the date of this Notice). My officer will contact you in approximately five weeks to arrange a further visit. You may apply for an extension to the period of time within which you need to remedy the failure(s). The authority will grant / deny additional time according to the efforts you have made. If you require additional time, please contact my officer at your earliest opportunity.

#### Penalty for Non-compliance

If you do not comply with this Notice, you will have committed an offence and this authority will consider a prosecution against you. A prosecution could lead to you being liable to a fine, imprisonment or both, subject to the Courts.

#### Route to Appeal

You can legally appeal this Notice. To do so, you must appeal 'by way of complaint for an order to the Clerk to the Magistrates' Court in the area in which the premises are situated', within 21 days from the day on which this notice was served.

The bringing of an appeal has the effect of suspending the operation of this Enforcement Notice until the appeal is finally disposed of or (if the appeal is withdrawn), until the withdrawal of the appeal.

An alternative approach might enable you to apply an equally appropriate safety solution to better meet your needs. Any alternative you propose must meet the 'outcome(s)' stated in the schedule.

# **Additional Recommendations**

It was noted during the audit that part of upstairs of the premises is undergoing renovation to become a flat. You must obtain the correct planning permission and go through the relevant authorities to ensure that the flat is compliant with the current Building Regulations.

Before you make certain changes to the premises, you may have to apply for approval from statutory bodies and/or others having interest in them. If you have doubt about the need for approval, you should ask the relevant body. For example, you may have to apply for approval from a Building Control Body to make 'material alterations' (see www.derbys-fire.gov.uk/brma). You might also need to apply for the property owners' permission or for 'listed building consent' (see www.derbys-fire.gov.uk/lbc) among others.

### **Outcome**

This work is necessary to reduce the risk of fire.

# **Action**

Remove all ignition sources being stored in the storage room. This includes the car that is currently being repaired and restored, and the mobility scooter.

### Reason

By storing high risk hazards within a storage room full of fire loading, you are increasing the risk of a fire breaking out and spreading rapidly. This would put people within the premises at risk of fire.

This is contrary to Article 8.

### **Outcome**

This work is necessary to detect fire and raise an alarm.

# **Action**

Install smoke detection in all areas of high fire hazard. This includes the storage room that is storing the car.

This should be installed and commissioned by a competent person.

### Reason

There is currently no detection within the storage room that is storing the car. Due to the risk of a fire breaking out and it spreading rapidly due to the high fire loading, the fire would be extremely well developed before it would be discovered. This could put all people at risk of not being warned to a fire and may be affected by smoke and fire before they could escape.

This is contrary to Articles 8(1), 13(1)(a), 15(1)(a) and 15(2)(a).

### **Outcome**

This work is necessary to reduce the risk of the spread of fire.

### **Action**

High-risk areas, including the storage room where the car is being stored, should be separated from the rest of the premises by 30-minute fire-resisting construction (walls, doors and ceiling).

Consider having a compartmentation survey undertaken by a competent person who will be able assess whether the standard of fire resistance and surface finishing in the escape routes throughout the premises is satisfactory and whether it has been affected by wear and tear or alterations.

### Reason

There is no sufficient fire resisting construction separating the storage room, where the car is being stored, from the rest of the premises. If a fire was to break out there, smoke and fire would rapidly spread and affect people before they could escape.

This is contrary to Articles 8(1) and 14(2)(b).

# **Outcome**

This work is necessary to detect fire and raise an alarm.

# **Action**

Remove the cover that is covering the smoke detector on the corridor of the first floor offices.

# Reason

The smoke detector on the corridor of the first floor offices is currently covered. This means that if a fire were to break out there, the detector may not actuate and give early warning to enable people to escape quickly.

This is contrary to Articles 8(1), 13(1)(a), 15(1)(a) and 15(2)(a).

#### Outcome

This work is necessary to reduce the risk of the spread of fire.

#### Action

Relocate the LPG cylinders throughout the building (including the ones that are being stored by the food van) to a properly designed and located storage area away from the premises or in a building that is dedicated for LPG. If this cannot be achieved, they should be limited to 15kg in no more than two cylinders and kept in a safe, secure and well-ventilated place where they cannot be interfered with, they can be kept upright (with valve protection fitted), they are away from sources of ignition and/or ignitable materials; and are away from any corrosive toxic or oxidant materials. They must never be located on any corridor or stairway or circulation space that will be used as an escape route, this includes escape from the flat that is currently being renovated.

### Reason

LPG cylinders are being stored inappropriately and excessively. If a fire were to break out, these cylinders could exacerbate the fire or explode. This would put persons at risk.

This is contrary to Article 8.

### **Outcome**

This work is necessary to provide sufficient escape routes (corridors, stairs and doors) for people.

### <u>Action</u>

Seek the advice of a competent person to calculate the occupancy capacity for the Kennel Room.

### Reason

The current occupancy capacity for the Kennel Room appears to be excessive for the size of the room, the number of exits available and the potential risk of fire spread due to the wall linings. Overcrowding could lead to people not being able to reach safety before being affected by smoke or fire.

This is contrary to Articles 8(1), 14(2)(c) and 15(1)(a).

# **Outcome**

This work is necessary to detect fire and raise an alarm.

# **Action**

Ensure that the fire alarm is being properly tested. This should be undertaken on a weekly basis and recorded to demonstrate compliance.

### Reason

The fire alarm has not been properly tested. This means that it could fail without warning or at the moment it is needed most and that people would be at risk in case of fire.

This is contrary to Articles 8(1) and 17(1).

## <u>Outcome</u>

This work is necessary to make sure that escape routes (corridors, stairs and doors) can be safely used whenever they are needed.

# **Action**

Ensure that the emergency lighting is being properly tested. This should be undertaken on a monthly basis and recorded to demonstrate compliance.

# Reason

The emergency lighting has not been properly tested. This means that it could fail without warning or at the moment it is needed most and that people would be at risk in case of fire.

This is contrary to Articles 8(1) and 17(1).

### **Outcome**

This work is necessary to help people understand what to do if fire breaks out.

### **Action**

Provide your employees with instruction and training, so that they know the fire precautions you have put in place. They must also be familiar with what they need to do in case of fire to ensure that they are safe and can keep other people safe. This includes undertaking regular fire drills. You should record all staff training to demonstrate compliance.

### Reason

There were no records available to show that the staff are being trained regularly and are aware of their responsibilities and of the fire safety measures in the premises, which you have taken to keep them and others safe.

This is contrary to Articles 8(1), 19(1), 21(1) and 21(2).

Dear Sir/ Madam.

We are writing to you on behalf of the Hairy Dog in Derby who are one of our long-established members.

Music Venue Trust is a UK registered charity established in 2014 that acts to protect, secure, and improve the UK's grassroots music venue circuit. We provide advice to the government, the cultural sector and the music industry on issues impacting the network of venues and are the nominated representative that speaks on behalf of the Music Venues Alliance, an association of more than 900 such venues from across the UK.

It should be noted that more than 35% of grassroots music venues (GMVs) have closed in the last 20 years.

Under the banner of Music Venue properties, a Charitable Community Benefit Society that we have created, we have identified nine venues around the UK for a pilot project. The aim of Music Venue Properties is to preserve these venues as grassroots music venues by removing the venues from the commercial market and placing them into a form of benevolent community ownership to secure their long-term future. Music Venue Properties aims to do so by raising £2.5 million to buy the freeholds of each venue, selling shares to music fans and ethical investors through a community share offering. The Hairy Dog is one of the 9 pilot venues in this project and so it is a very important venue in our membership.

Music Venue Trust therefore fully supports the application by the Hairy Dog to be able to hold mixed ages shows both for live music shows and for wrestling performances. Nationally, there has always been trepidation for venues to host shows targeted at under 18's. The difficulties faced include stringent licensing requirements, including ones explicitly preventing any person under the age of 18 into venues whilst alcohol is also being served. These conditions have generally started to be relaxed, for example some of the big regional and national promoters insist on only promoting shows in venues that can be 14+.

Currently the Hairy Dog is subject to the following conditions "Children under the age of 18 are not permitted on the premises after 20:00 hours" The application before is to amend this condition to



Except in the following circumstances.

- 1. A live performance or an artist/s, boxing or wrestling event is taking place, and
- 2. They are accompanied by an adult

In the circumstance of 1 & 2 above, they are only permitted on the premises until midnight. For the purposes of the Licensing Act

- (a)"child" means an individual aged under 16,
- (b) a child is unaccompanied if he is not in the company of an individual aged 18 or over. Therefore currently the venue is permitted unaccompanied persons to the venue if they are 16 and 17 so actually this application affords better legal protection in respect of crime and disorder for these age groups that are currently in place at the venue.

Grassroots venues are essential cultural spaces. They are spaces where artists and bands get their first opportunities to perform live and hone their skills as performers. They are crucial to their communities because they widen access to culture at an accessible and affordable level for those in their local communities. Grassroots Music Venues like The Hairy Dog enable audiences to enjoy an intimate live music experience and form a bond with the artists, so they continue to champion them.

Music Venue Trust believe that live music events that are fully risk assessed and well managed are safe spaces for young persons to attend and enjoy culture. The lack of investment in facilities for younger people means that there is often a lack of activities available for young people. Allowing safe access to live music or organised sports events such as wrestling in a well-managed licensed venue, with security, CCTV, with full operating procedures and risk assessment, to young persons accompanied by an adult is a safer activity than the alternative of having no activities for young people to attend and enjoy.

It is the aim of Music Venue Trust to protect, secure and improve grassroots music venues, therefore we fully support the venue's application to vary their operating hours as we believe this will help ensure the sustainability and resilience of Hairy Dog, a thriving grassroots music venue.

We therefore encourage the Council licensing team and other responsible authorities to work with the premises to develop operating procedures so that this application can be granted as applied for. If the application does go before the Licensing Sub-Committee, we will happily provide additional evidence in respect of other venues where the proposed conditions operate whilst promoting the licensing objectives.

The MVT are also willing to offer best practice advice and help developing procedures and risk assessments for any proposed shows if it is required.
