20/21 Apologies

The Mayor noted that Council was being held in the Derby Loves You Venue, to ensure that all attendees could remain socially distanced during the ongoing Covid-19 pandemic.

It was reported that although the venue was large enough to accommodate all councillors and members of the public safely, given rising Covid-19 case rates locally, it was considered a sensible precaution to reduce the number of councillors present. This was to ensure that in the event of councillors being subsequently required to self-isolate, the democratic processes of the Council could continue to function.

28/21 Minute extract 08/21 from the meeting of the Audit and Governance Committee held on 16 June 2021.

A minute extract from the meeting of the Audit and Governance Committee held on 16 June 2021 was presented to Council. The minute recommended the Annual Report of the Audit and Accounts Committee from the preceding municipal year for approval.

It was moved by Councillor West and seconded that the minute be approved. The recommendation was put to the vote and carried.

29/21 Minute extract 33/21 of the Council Cabinet meeting held on 14 July 2021

A late item was presented for consideration, in respect of a minute extract from the Council Cabinet meeting held on 14 July 2021.

The Mayor stated that he had previously agreed that the minute extract be considered urgently, as it was in the public interest to allow the recommendations to be progressed expediently.

The minute recommended amendments to the Treasury Management Strategy to include Derby Homes Ltd. as an approved source of short and long term borrowing for the Council.

It was moved by Councillor Roulstone and seconded by Councillor M Holmes that the minute be approved. The recommendation was put to the vote and carried.

30/21 Report of the Independent Remuneration Panel

A report of the Independent Remuneration Panel (IRP) was presented to Council for consideration. The report detailed thirteen recommendations in respect of councillors' allowances and expenses, which had been compiled following a comprehensive review undertaken since August 2020.

Several aspects of the IRP's report were highlighted for consideration by councillors:

- The IRP recognised the difference between public service and employment and had taken that into consideration in preparing its recommendations
- The IRP noted that no significant changes had been made to the Councillors' Allowances Scheme in over ten years, which had resulted in a scheme that no longer reflected the roles and responsibilities associated with becoming an elected member.
- The IRP urged councillors to reflect on their duty to ensure becoming a councillor remains a viable option for people from all backgrounds.
- The IRP felt strongly that Derby's councillors were under-remunerated for their role and noted that the Council compared unfavourably with several of its regional comparators. It was noted that it was in the long-term interest of the city to set a scheme that continues to attract a high calibre of councillor candidates.
- The IRP's recommendations sought to address discrepancies within the existing scheme and seek to ensure that all councillors are treated equitably in the support they receive from the Council.

It was noted that the Corporate Services Scrutiny Review Board had recently concluded a review of Gender Representation within Derby City Council and had made several additional recommendations in respect of the Councillors Allowances and Expenses Scheme.

Minute extract 33/20 of the Corporate Services Scrutiny Review Board meeting held on 11 March 2021 was therefore presented at Appendix 3 of the substantive report for consideration alongside the recommendations of the IRP. The minute extract detailed the findings of a report of the Gender Representation Task Group, which had examined barriers to entry for women in local government since 2017.

Councillors were invited to consider and make resolutions on the two sets of recommendations. The Mayor proposed that the recommendations of the IRP were considered before the recommendations of the scrutiny board were moved for debate.

It was moved by Councillor Barker and seconded by Councillor Pearce that the recommendations of the IRP were agreed in full. The recommendations were put to the vote and carried.

Resolved:

- 1. To approve the thirteen recommendations of the Independent Remuneration Panel:
 - That the Basic Allowance is increased to £11,523 per annum.
 - That an index link is adopted so that the Basic Allowance increases in line with the Local Government Pay Award in the 2022/23, 2023/24 and 2024/25 financial years.
 - That the Special Responsibility Allowance for the Leader of the Council is increased to £34,569 per annum and that all SRAs are increased on a pro-rata basis as detailed at Figure 10 of this report.
 - That an index link is adopted so that Special Responsibility Allowances increase in line with the Local Government Pay Award in the 2022/23, 2023/24 and 2024/25 financial years.
 - To request that the Independent Remuneration Panel conduct a further review of the relativity of Special Responsibility Allowances during the 2021/22 municipal year, pro-rated against the Leader's allowance established at recommendation three.
 - That the rates payable for travel expenses are amended to ensure consistency with equivalent entitlements for Derby City Council employees.
 - That the Councillors' Allowances and Expenses Scheme is amended to give effect to the seven component recommendations in respect of Dependent Carers Allowance, contained within the report.
 - To request the introduction of a Parental and Carers' Leave policy for councillors at the earliest opportunity.
 - That annual summaries of the amounts claimed for Dependent Carers Allowance are reported separately to all other allowances and expenses.
 - To undertake a cross-party communications initiative to highlight the valuable role of elected councillors and to encourage residents from all backgrounds to consider standing as candidates.
 - To amend the Councillors' Allowances Scheme to provide discretion for SRAs to be withheld in circumstances where mandatory training has not been completed within a reasonable timescale, as detailed in the report.
 - That the payment of the Mayor and Deputy Mayor's purse is openly and transparently reported alongside the annual summaries of councillor allowances and expenses; and, that a

- process is introduced for payments from the purse to be drawn down and receipted, as expenses are incurred, following the payment of an initial lump sum.
- That an annual bursary of £750 is introduced for the Deputy Youth Mayor, to accompany the existing £1000 bursary received by the Youth Mayor.
- 2. To approve with immediate effect the Councillors' Allowances and Expenses Scheme for 2021/22, as set out at Appendix 4 of the report.

It was moved by Councillor Peatfield and seconded by Councillor Dhindsa that recommendations one to three contained within minute extract 33/20 of the Corporate Services Scrutiny Board be approved. It was noted that following the earlier agreement of the recommendations of the IRP, the fourth recommendation of the Board had been superseded.

The recommendations were put to the vote and carried.

This comes after many years of below average educational performance in the city and which, in 2018-19, showed a downward trajectory in secondary schools and, in 2019, was below the expected standard in primaries.

Council also notes that the Government's Education Recovery Commissioner, Kevan Collins, and the Bright Future Task force of education experts, recommended a £15 billion national plan for education catch-up funding, in response to which the Government plan to provide just one tenth of that sum. 99% of children will receive no catch-up funded tutoring whatsoever. In Derby, just £1,437,210 has been provided in the summer payment to Derby schools for catch-up work which, given

the 44,965 children in Derby's schools, amounts to a paltry £31.96 per pupil. The Education Opportunity Area Board has described Derby as a social mobility cold spot; these levels of catch-up funding risk freezing the children of Derby out of any viable future.

Council further notes that the Council still has a statutory responsibility for overall education outcomes.

Given the detrimental effects of the Covid pandemic on children and young people's education, and the urgent need to deliver better education outcomes in Derby, Council resolves that the Leader of the Council should:

- 1. immediately contact the Secretary of State to demand catch-up funding for Derby at the level recommended by Kevan Collins and provide evidence of that communication to Full Council
- 2. write to the Secretary of State to urge him to develop a 5-year strategy for pandemic recovery measures in education
- 3. early in the autumn term, contact Derby schools to request feedback on catch-up provision, notably how many children and young people are receiving funded catch-up tutoring and help, and to obtain details of the kind of help being delivered.
