Councillor Wood vacated the meeting after consideration of DER/04/13/00390 (1 Abbey Yard) in minute number 84/12.

The Chair amended the order of business to consider agenda item 7 (recorded in minute number 83/12) after item 5.

78/12 Apologies

Apologies for absence were received from Mr D. Armstrong, Mr J. James and Mr J. Sharpe.

79/12 Late Items

The report concerning applications to be determined by the committee was updated to include application number DER/02/13/00178 (Kings Chambers, 34 Queen Street). Consideration of this item is recorded in minute number 84/12.

80/12 Declarations of Interest

Mr Ling declared an interest in application numbers DER/04/13/00423 and DER/04/13/00424 (Silk Mill Industrial Museum) owing to his position as a trustee of the Derby Museums' Trust. Although the appointment did not constitute a disclosable pecuniary interest, Mr Ling favoured vacating the meeting during consideration of the applications in the interests of absolute transparency.

81/12 Confirmation of the minutes of the meeting held on 4 April 2013

The minutes of the meeting held on 4 April 2013 were agreed as a correct record and signed by the Chair.

82/12 Report on Applications Determined Since the Last Meeting

The Conservation Officer presented a report on behalf of the Strategic Director of Neighbourhoods, regarding planning applications which had been determined subsequent to the committee's consideration.

Resolved to note the report.

83/12 Proposals by the Liversage Trust within the Nottingham Road Conservation Area

The committee received a presentation from Mr John Brittain, Ms Yvonne Taylor and Mr Peter Whelan on behalf of the Liversage Trust. The presentation outlined the issues facing the Trust in its continuing work to retain and enhance both the street scene and the provision of facilities located within the Nottingham Road conservation area. The committee understood that the Trust was committed to making long-term investments and working with the council to continue to enhance the conservation area.

The committee was informed that the Trust was particularly concerned about the implications arising from the need to replace doors and windows. The Trust had expressed a preference for the use of UPVC frames and requested feedback in respect of the draft proposal. Furthermore, the presentation invited comment in respect of the Trust's future draft development proposals. It was proposed that future improvements could include conversion of the Liversage Arms (including a change of use to a residential category), demolition of outbuildings to create approximately 10 car parking spaces and tree planting.

The committee debated the favourable attributes of seasoned timber frames in comparison to UPVC frames. Although sympathetic to the particular needs of elderly residents, for example security and ease of use, the committee suggested that alternatives to UPVC were available. The committee commended the Trust in respect of its determination to enhance the character of the environment and advised the Trust to investigate alternative options; particularly timber framed windows complete with double glazing and locks. The committee also recommended the installation of four panel wooden doors and raised no objection (in principle) to the demolition of the outbuildings.

Resolved to commend the Trust's endeavours to preserve and enhance the conservation area and to recommend the Trust to consider the installation of

timber framed double glazed replacement windows, together with timber four panel doors.

84/12 Report on Applications to be Considered

The Conservation Officer presented a report on behalf of the Strategic Director of Neighbourhoods. The report requested the committee's consideration of planning applications which were due to be determined by the Planning Control Committee or the Strategic Director of Neighbourhoods under delegated power. The committee had regard to the aspects of the applications which would affect the character, appearance or setting of a world heritage site, conservation area, buildings of architectural or historic interest, ancient monuments and other sites of archaeological interest.
