# Late item - Area Panel Funding Application for Chapel Lane Lighting

#### SUPPORTING INFORMATION

- 1.1 Area Panel 1 is asked to consider this application for funding as a matter of urgency. An incident during the weekend of 9/10 October 2004 off Chapel Lane, Chaddesden has left the local community feeling shocked and concerned.
- 1.2 The new process for area panel funding as outlined in the Council Constitution requires applications to be submitted in time to be appraised by the Area Panel Funding Appraisal Panel before the Area Panel makes its decision. It is proposed to present the application to the Area Panel without following the new process because of the seriousness of the recent incident, the need to address the fears of the local community, the need to improve the local lighting and security immediately and the fact that there is no funding available in the 2004/5 street lighting budget.
- 1.3 Area Panel 1 budget allocation for 2004/5 is £29,000. The panel also has an additional budget of £1,418 carried forward from 2003/4, which means that a total budget of £30,418 is available for allocation to projects during this financial year. As at 27 October 2004 there is £29,218 available to allocate, however applications totalling £8,788 are being considered by Area Panel 1 on 27 October in the report Area Panel Budget Proposals 2004/5.
- 1.4 Area Panel 1 is asked to consider whether to support the following application for funding received from:

#### Appendix 1

#### **IMPLICATIONS**

#### **Financial**

1.1 Area panels must consider priorities within the area when considering requests for funding. Not all requests that meet the criteria will be considered a priority. When supporting or rejecting an application over £1,000, Area Panel 1 must give reasons for its decision.

## Legal

- 2.1 Area Panel 1 has delegated authority to use its budget for local environmental and community purposes.
- 2.2 Section 19 of the Local Government (Miscellaneous Provisions) Act 1976 empowers the Council to offer grants to voluntary and other organisations to provide any recreational facilities.
- 2.3 Any decision involving the making of a grant or loan over £1,000 to any voluntary body is deemed to have a significant impact on two or more wards and is therefore a key decision.
- 2.4 After a key decision has been taken, the Director of Corporate Services must publish a record of every executive decision taken at that meeting within two days of that meeting. The record must include a statement of the reasons for each decision and any alternative options considered or rejected at the meeting. No action will be taken on any such decision for five clear days from the date of publication.

**Project:** Lighting on Chapel Lane

Total cost of project: £1,450

## **Description:**

Most recently we had the unfortunate occurrence of the female body found at the bottom of Chapel Lane near to the Chaddesden brook. We would like two extra streetlights in Chapel Lane, because the two existing lights do not give enough light to cover all the area.

The new lights will improve community safety and will encourage safe walking to local amenities. They will help address the fears of the local community and provide a well-lit footpath that will encourage community participation in the area.

Also local school children from Lees Brook College, Cavendish Close Nursery/Infants/Juniors and Chaddesden Park Infants/Juniors are all in the area.

Some over grown shrubs and trees need to be cut back at the same time. Officers have visited the site and some of foliage that needs cutting back is on private property and the responsibility of the individual householders. Officers will inform local residents by letter to have these works completed. The trees are on council owned land and a request to assess them will be passed on to Commercial Services Department for their attention.

Development and Cultural Services have confirmed that they will maintain the new streetlights and pay for the energy costs for the new lighting.
