Constitutional Appointments and Outside Bodies

SUMMARY

1.1 This report proposes various changes to Constitutional Appointments and Outside Bodies.

RECOMMENDATION

- 2.1 To note that Dr Richard Crowson is statutorily appointed as a representative of the Southern Derbyshire Clinical Commissioning Group on the Health and Wellbeing Board, and to note the updated membership at Appendix 1.
- 2.2 To consider a submission by the Labour Group that Councillor Anderson be appointed as the council's representative on the Derby and Sandiacre Canal Trust.
- 2.3 To consider a submission by the Labour Group that Councillor Hezelgrave be appointed as the council's representative on the Midland Railway Trust.
- 2.4 To consider a submission by the Labour Group that Councillor Bolton be appointed as Chair of the Chaddesden Neighbourhood Board in place of Councillor Winter.

REASONS FOR RECOMMENDATION

- 3.1 Under the Health and Social Care Act 2012, the local clinical commissioning group makes two statutory appointments to the Health and Wellbeing Board. Following the retirement of the GP Chair Dr Sheila Newport, the Southern Derbyshire CCG has nominated governing body member Dr Richard Crowson as her replacement.
- 3.2 Appointment to outside bodies and neighbourhood chairs are reserved to Council. They are normally made at the annual meeting but can be reconsidered where a proposal is received.

Health and Wellbeing Board

4.1 The following biography of Dr Richard Crowson is taken from the Southern Derbyshire Clinical Commissioning Group Website:

Dr Crowson is a GP partner at Macklin Street Surgery in the city centre where he has been working since 2007. He has been a GP for 15 years working both in the UK and New Zealand. He was the GP for Derby's asylum seeker practice from 2003 - 2005. His clinical practice has always been mainly with deprived and urban populations. He believes passionately in quality general practice, and his main concern is to develop and maintain excellent, sustainable and equitable primary care services.

Appointments to outside bodies

4.2 Council appointed Mr Mark Tittley to both the Derby and Sandiacre Canal Trust and Midland Railway Trust at its meeting on 18 May 2016. It is within Council's gift to amend its appointments and the proposal to change the appointments was received on 3 October 2016.

4.3 Council appointed Councillor Winter as Chaddesden Board Neighbourhood Chair at its meeting on 18 May 2016. It has been requested by the Labour Group that its nomination be changed to Councillor Bolton so this must be determined by Council.
