

## **Council Cabinet Decisions made on 16 October 2013 relating to the remit of the Planning, Housing and Leisure Board**

### **SUMMARY**

- 1.1 This report outlines the decisions made by Council Cabinet on items relating to the Planning, Housing and Leisure Board. Its aim is to keep members informed on decisions made on items relevant to the Board and to highlight the development of items that are on-going and that members may wish to include in the work programme for future scrutiny.

- 3.2 To ensure that the Board is kept up to date with developments made in relevant On-going work areas that may merit future scrutiny.

#### **90/13 Draft Core Strategy – Consultation on Full Draft Plan**

- 4.2 The Council Cabinet considered a report on the Draft Core Strategy – Consultation on Full Draft Plan. Work had progressed on the Core Strategy since last year's consultation on the 'Preferred Growth Strategy' (PGS). A draft plan had now been produced which set out the detailed policy wording and infrastructure requirements for the sites consulted on last year. It also included detailed policy wording for a wide range of topic policies covering regeneration, the economy, affordable housing, the city

centre, shopping, transport, the environment and the River Derwent, including the 'Our City Our River' project. Council Cabinet approval was sought to undertake consultation on this draft plan.

#### 4.3 Decision

1. To authorise consultation on the draft Core Strategy as set out in the overview in Appendix 2 of the report and the main document on CMIS from October 2013 onwards in accordance with the consultation principles set out in the report.
2. To authorise the Strategic Director for Neighbourhoods, following consultation with the Cabinet Member for Planning, Environment and Public Protection, to finalise the consultation document and supporting material.
3. To agree that whilst Derby City Council remained committed to joint working, it did not support either of the proposed options for a reserve site on the edge of Derby at Lowes Farm, Chellaston and Newhouse Farm, Mickleover. Further, to authorise the Strategic Director for Neighbourhoods, together with the Cabinet Member for Planning, Environment and Public Protection to formulate a response to South Derbyshire to this effect.

#### 4.4 Reasons

1. To enable consultation to take place.
2. To enable the consultation document to be finalised and for minor amendments to be made to the text.
3. To respond to South Derbyshire's consultation that Derby City Council did not support either of the options proposed as a reserve site around Derby.
