ANNEX 1 – MANDATORY CONDITIONS

SUPPLY OF ALCOHOL

- 1.No supply of alcohol may be made under the premises licence -
- a) at any time when there is no designated premises supervisor in respect of the premises licence; or
- b) at any time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

DOOR SUPERVISION

3. Each individual required to be at the premises to carry out a security activity must be licensed by the Security Industries Authority.

MANDATORY CONDITION IMPLEMENTED ON 28 MAY 2014.

- 1. A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 —
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula $\frac{1}{n}P = D + (DxV)$

Where — P is the permitted price,

- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,

- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

MANDATORY CONDITIONS IMPLEMENTED 1 OCTOBER 2014

- 1. (1). The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises."
- (2) An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –
- (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to –
- (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
- (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
- (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective.

- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective.;
- (d)) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner).
- (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The Designated Premises Supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
- (a) holographic mark or
- (b) an ultraviolet feature
- 4. The responsible person must ensure that –
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –
- (i) beer or cider: 1/2 pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises: and
- (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

- 1. No entry or re-entry to the premises after 23:00.
- 2. No unaccompanied children will be allowed on the premises and not after 23:00 hours.

- 3. You must apply a policy requiring the production of 'proof of age' from any person appearing to those selling or supplying alcohol to be under the age of 18 and who is attempting to buy alcohol.
- 4. No off sales of alcohol for consumption off the premises will be permitted after 23:00.
- 5. To be an active member of Pubwatch and display signs through the premises.
- 6. All inclusive nights or other irresponsible drinks promotions will not be permitted.
- 7. No persons carrying sealed or opened bottles or glasses will be admitted to the premises at any time and no persons will be allowed to take open containers of drinks from the premises.
- 8. Person who appear drunk or under the influence of drugs will not be admitted at any time.
- 9. All recommendations of the Derbyshire Fire & Rescue Service will be promptly acted upon.
- 10. An adequate and appropriate supply of first aid equipment will be available on the premises.
- 11.A log will be maintained of all incidents/accidents which may occur on the premises.
- 12. The premises will be ventilated by the use of intake and extractor fans.
- 13. All gas and electrical appliances on the premises will have current safety certificates.
- 14. All exit doors will be easily opened.
- 15. Means of escape will be maintained unobstructed and clearly identifiable with emergency lighting and illuminated exit signs.

ANNEX 3 - CONDITIONS IMPOSED BY GENERAL SUB-COMMITTEE ON 26 NOVEMBER 2009

CONDITIONS RELATING TO THE PREVENTION OF PUBLIC NUISANCE

- 16. You must ensure that all windows and doors remain closed except the front entrance door, which may be used for access and egress on occasions when live music/amplified music or anything of a similar description is played.
- 17. Prominent, clear and legible notices must be displayed at all exits requesting customers to respect the needs of local residents and to leave the premises and the area quickly and quietly.
- 18. The licensee or a nominated representative should receive and respond to complaints throughout the duration of all noise generating events.
- 19. The licensee or nominated representative should monitor the noise from time to time outside noise sensitive premises during every event involving amplified music or speech. If as a result of such monitoring it is considered that the noise levels are excessive, immediate action should be taken to reduce the volume to acceptable levels.
- 20. The aim should be for noise to be inaudible outside noise sensitive premises after 23:00 hours. A record of these checks and of any action taken as a result should be maintained in a log book kept specifically for that purpose. This log book should be made available for inspection by a police officer or authorised officer of the licensing authority upon request.
- 21. The licensee or nominated representative should monitor the effect of patrons leaving the premises from time to time and at least once a week. A record of the monitoring and of any matters giving rise to concern should be maintained in a log book and shall be made available to a police officer or authorised officer of the licensing authority upon request.
- 22. Before live music is performed at the premises a thorough assessment and subsequent management exercise should be undertaken in order to minimise the potential impact of any noise created. This should include arranging and directing speakers, instruments, vocalists etc away from doors/windows and also directed away from sensitive receptors. i.e. residential premises.





- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

 (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;

- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence,
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- 3. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
- (2) The Designated Premises Supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy
- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
- (a) holographic mark or
- (b) an ultraviolet feature
- 4. The responsible person must ensure that -
- (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –

EXHIBITION OF FILMS

1 No film shall be exhibited unless:

a. it has received a "U", "PG", "12A", "15", or "18" certificate of the British Board of Film Classification; or

b. it is a current newsreel, which has not been submitted to the British Board of Film Classification.

2 "18" Films

No person apparently under the age of eighteen years shall be admitted to any exhibition at which there is to be shown any film which has received an "18" certificate from the British Board of Film Classification.

3 "15" Films

No person apparently under the age of fifteen years shall be admitted to any exhibition at which there is to be shown any film which has received an "15" certificate from the British Board of Film Classification.

4 "12A" Films

No person apparently under the age of twelve years shall be admitted to any exhibition unless accompanied by an adult at which there is to be shown any film, which has received a "12A" certificate from the British Board of Film Classification.

5 "PG" Films

Some scenes contained at which there is to be shown any film, which has received a "PG" certificate from the British Board of Film Classification, may be unsuitable for young children.

6 "U" Films

Films suitable for all is any film, which has received a "U", certificate from the British Board of Film Classification.

7 Permission of Licensing Authority

Notwithstanding the above, a film may be exhibited, or persons, or any class of person, may be admitted thereto if the permission of the licensing authority is first obtained and

ANNEX 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

- 1. All door supervisors must display their name and carry proof of registration at all times.
- 2. The maximum number of people on the premises must not exceed 125. 75 persons on the ground floor (lounge only) and 50 persons on the ground floor.
- 3. There should be no consumption of alcohol or other beverages in any external area, save for the area marked on the plan hatched in blue for the purpose of showing the approved external area for consumption only.
- 4. Save for the main front entrance of the premises and access doors leading to the smoking/consumption area to the rear of the premises (hatched blue on the attached plan), all of the doors by way of access will be utilised only as fire doors and will not be used for the access/egress of members of public.

ANNEX 3 - CONDITIONS SET BY LICENSING SUB-COMMITTEE

SCHEDULE OF ADDITIONAL AGREED CONDITIONS AT DERBY MAGISTRATES COURT ON 20 JANUARY 2011

- Full training shall be provided to all staff on commencement of employment relating to all age-restricted products sold and any system or procedures they are expected to follow in the course of dealing with these goods.
- 2. Refresher training shall be provided at regular intervals at least every 6 months.
- 3. Records detailing the training provided shall be kept on the premises for production, on request, to a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 4. All records must be written and shall be retained on the premise for a minimum of 12 months.
- 5. A challenge '25' Proof of age scheme shall be operated at all times.

- 6. Anyone attempting to purchase alcohol (or other age restricted product) that appears under the age of 25 years shall be asked to produce a proof of age.
- 7. Clear, prominent and unobstructed signage informing customers of the proof of age scheme in operation, shall be displayed at:
 - All entry points
 - · Points of sale.
- 8. A system of recording sales refused under the proof of age scheme shall be operated at all times.
- 9. The refusal book/log shall be kept on the premises and shall be produced upon request of a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 10. The records relating to the refusal book/log shall be retained on the premises for a minimum of 12 months.
- 11. The Designated Premises Supervisor shall ensure that a written incident log is maintained within the premises and details of all known incidents are recorded within the log. This log shall be kept on the premises for a period of not less than 1 year and shall be produced upon request of a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 12. Suitable and sufficient written risk assessments and operating policies to include one for drugs shall be kept up to date and shall be produced upon request of a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 13. The Designated Premises Supervisor shall ensure that a clear, prominent and legible notice is displayed at the entrance of the premise explaining to customers that they may be subject to a search as condition of entry.
- 14. There shall be displayed at the premises notices both internally and externally stating that there is a zero tolerance policy towards drugs, so that any drugs on the premises will be seized and the offender reported to the Police and banned for life.

- 15. The Designated Premises Supervisor shall, on a regular basis, contact the Derbyshire Constabulary Licensing Team to report whether or not any incidents of drugs, violence or disorder have occurred either inside or immediately outside (and relating to) the premises. Contact shall continue until such time as the Derbyshire Constabulary consider it no longer necessary for this measure to be adhered to.
- 16. The Designated Premises Supervisor shall maintain a suitable receptacle ('a drugs safe') for the secure retention of any suspected illegal substances ('drugs') found or seized on the premises.
- 17. The Designated Premises Supervisor shall record in writing and inform Derbyshire Police of any searches conducted on any person that results in a seizure of drugs or offensive weapons. This record will be kept for a minimum period of 12 months and shall be made available upon the request of a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 18. Staff will search the premises regularly for concealed drugs. A written record shall be maintained which will record any search of the premises whether the same resulted in the finding of suspected illegal substances or not. This record will be kept for a minimum period of 12 months and shall be made available upon the request of a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 19. The Premises Licence Holder will assess the premises and agree a plan with the Police for the removal or sealing up of locations where drugs may be concealed, such as, but not limited to, toilet cisterns, roof panels and bar seating.
- 20. Ultra Violet lighting will be provided in all toilets where public have access. This will minimise the opportunity for drug use in the toilet area.
- 21. The Designated Premises Supervisor and any staff left in sole charge, or intended to be left in sole charge, of the premise shall have obtained a suitable certificate in Drugs Awareness or other similar course as agreed with Derbyshire Police. This course shall be successfully taken within 28 days of being designated in the relevant post.

- 22. Licensable activities shall be restricted to the areas edged red on the plan lodged with the Licensing Authority. The plan shall be submitted to the Licensing Authority and Chief Officer of Police. All other areas, excluding the toilets, corridors leading to emergency exits and emergency exits, shall be secured so that they are not accessible to members of the public whilst the premises is open for the purposes of licensable activities as authorised by the Premises Licence or any other such authority within the Licensing Act 2003.
- 23. The car park area to the rear of the premises shall be secured, so that it is no longer open for use as an external licensed area or car park whenever the premises are open to the public. This shall not prevent the car park being used for uses unrelated to the premises provided a suitable barrier is in place to prevent access from the Premises to the car park area save as an emergency exit.
- 24. External lighting to the front of the premises shall be maintained to give suitable illumination to the front of the premises, to the reasonable satisfaction of the police.
- 25. All external doors and windows in the premises must remain closed at any time when the nature of regulated entertainment may give rise to public nuisance except for the duration of access and egress or in an emergency.
- 26. The Premise license holder or the responsible person shall use their best endeavours to prevent noise from regulated entertainment, including repetitive bass noise, being audible from within noise-sensitive premises with their windows open in a typical manner for ventilation
- 27. The Designated Premises Supervisor shall ensure that clear, prominent and legible notices must be displayed internally at all exits, requesting customers and other users to leave the premises and the area local to the premises quietly and in an orderly manner respecting the needs of local residents.
- 28. The Designated Premises Supervisor shall be an active member of a local "Pub Watch" scheme (so long as one exists) and adhere to the scheme's Governing Rules.
- 29. Anyone who appears to be intoxicated or behaves in an unsatisfactory manner shall not

be allowed admission to the premises. Entry will be refused to any person who is known by staff working at the premises to have been convicted of an offence of drunkenness, violent or threatening behaviour or the distribution or supply of illegal substances.

- 30. Should information be provided by the police of any individual to be banned from the premises, such individuals shall be refused entry and placed on a banned list from the premise. This banned list shall be kept on the premises and shall be produced upon request of a Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003.
- 31. No children under the age of 16 years shall be allowed access to the licensed area of the premises unless accompanied by a responsible adult over the age of 18 years old.
- 32. No person under the age of 18 years old will be allowed on the premises after 20:00 when the premise are being exclusively or primarily used for the supply of alcohol for the consumption on the premises, the only exceptions being family orientated events, pre arranged private functions and staff for the purpose of work.
- 33.A CCTV system shall be installed and the recording system must be maintained in good working order and any faults repaired as soon as possible. (It is recommended that all maintenance paperwork be kept to show that the Designated Premises Supervisor has shown all due diligence in maintaining the system).
- 34. The CCTV recording system must be operating at all times when the premises are open for licensable activities.
- 35.All CCTV recordings must be retained for a minimum of 28 days. A Police Officer or other authorised person as detailed within Section 13 of the Licensing Act 2003 can view any recordings at any reasonable time and obtain a copy if required.
- 36. The premises licence holder, Designated Premises Supervisor, and designated members of staff must be able to retrieve and copy any recording/images at the time of asking or within 48 hours if so required. (The police will not meet the cost for a recording or materials used for a reproduction of the image in respect of any crime and disorder; all costs are to be met by the Designated Premises Supervisor. If the incident was unrelated

to the premises, the retrieval, if a cost is incurred, would be met between the agencies requiring the image).

- 37. The CCTV recording unit is to be kept secure, to be opened only by the premises licence holder or authorised, designated member of staff.
- 38.Installed CCTV cameras/monitors are to be positioned so as to ensure all areas to which the public have access are covered (save for any toilet area).
- 39. All digital recordings to be made in real time, time lapse not to be used; the recordings will be fit for the purpose.
- 40. No consumption of alcohol or smoking will be allowed to take place at the front of the premises save for the times when an authorised pavement licence allows such activity.
- 41. The Designated Premises Supervisor will regularly assess the need for the provision of door supervision in conjunction with the police and provide sufficient staff as deemed necessary.
