The forum considered a report from Pam Thompson, Consultation Support Officer on the 2008/08 Work Programme.

37/08 Progress on the Pakistani Recruitment Project

The Forum considered a report from the Director of Resources on Progress on the Pakistani Recruitment Project. The Council's annual workforce and recruitment statistics showed reductions in people from this community securing employment and this was beginning to have a negative impact on representation. Positive action measures were needed as a priority because this community is the largest minority ethnic community according to 2001 Census and it is also one of the long established communities in Derby.

Members of the forum suggested that the Pakistani Centre be used for future workshops of the project and that members of the forum receive details of future events. It was also requested that statistics of people engaging with the project were provided to forum members.

The forum thanked Tariq Iqbal for his continued work on the recruitment project.

Resolved to note the report.

38/08 Derby Campaign Against Racism and Fascism DCARF

The Forum received an oral report from Zbigniew Wojcik on the Derby Campaign Against Racism and Fascism Conference. Members of the forum were invited to attend the conference on Saturday 21 February at the St James Centre. The campaign was launched in August t campaign on a wider basis against racism and fascism in the Derby areas.

39/08 Community Grants Budget

The forum received a presentation from Katy Wing, on the Grant Funding for Minority Communities. It was reported that grant funding was a partnership approach and aimed to support positive outcomes for communities. The forum were informed that Council grant funding currently supporting minority communities includes the Community Grants Budget and Adult Social Services grant funding. It was noted that around 23% of the Community Grants Budget goes to BME community groups and 56% of the funding to BME groups targets all BME Communities but the remaining 44% targets specific BME Communities. Details of how to apply for grant funding were provided to the forum.

Members of the forum raised concerns that the same community groups were accessing funding year on year. It was reported that in order to fund new priorities either additional funding needs to be found or some organisations currently funded would need to be decommissioned. It was noted that, although some organisations have received funding for a long time, this does not necessarily mean that their services are no longer needed.

Members noted that the process to apply for funding needs to be simple as community groups who were applying didn't have the correct skills to fill in complicated forms. It was explained by the officer that the application forms had recently been changed to make the process as clear as possible.

Members were informed that a review process is carried out by officers during the final year of funding to decide whether to recommend to Cabinet to continue, change or stop the funding. Members asked for the details of the groups that have been funded over recent years to be provided to forum members.

It was suggested that there should be a mechanism to support new communities who should be guided and supported into mainstream funding.

The Forum asked for details of grants to be brought to the next meeting, with a breakdown of who the recipients are; how much they are receiving and for how long; as there was a suggestion that the process should be opened up.

Resolved to note the presentation and receive feedback from the chair and Katy Wing at a future meeting of the forum.

40/08 Regeneration funds coming to Derby and the impact on BME communities

The forum agreed to defer this item to a future meeting.

41/08 Open discussion

Members of the forum requested than item on homelessness be added to current work programme to include details of the night shelter on Green Lane.
