Termination of Approved Garage Contract

SUMMARY

- 1.1 Derby City Council had a contractual agreement with MOT Place (Derby) Ltd for the inspection and testing of hackney carriages and private hire vehicles, as one of a number of approved testing garages for the licensed vehicle fleet within the city.
- 1.2 In Sept 2017, the Driver and Vehicle Standards Agency (DVSA), formally known as Vehicle and Operator Services Agency (VOSA), notified the Licensing Team that the company were not authorised to carryout MOT's on behalf of the Secretary of State.
- 1.3 The contract with MOT Place (Derby) Ltd was terminated with immediate effect (22 September 2017).

- 4.3 Following consultation with Legal Services and the Council's Procurement Team the contract was terminated in accordance with clause 25 of the contract for material breach of the contract.
- 4.4 The contract with MOT Place (Derby) Ltd was terminated with immediate effect on 22 September 2017.
- 4.5 The Authority now has a contract with five Approved Garages.
