## **New Derby City PCT**

From 1 October 2006 Central and Greater Derby Primary Care Trusts were replaced by a single Derby City Primary Care Trust. This follows a national consultation process to support the government's vision of 'Creating a Patient-led NHS'.

Because Central and Greater Derby PCTs have already been working together, there has been a smooth transition to the new organisation.

Prem Singh remains the Chief Executive and John Beswarick, Chair of Central Derby PCT, has been appointed Chair of Derby City PCT. The new Non Executive Directors are John Wain, George Tansley, Jasvinder Sanghera, Shokat Lal, Evonne Williams and John Atkins.

#### **Drug Treatment Consultation**

Derby Community Safety Partnership, working in partnership with the PCT, reviewed adult drug treatment services within the city in autumn 2005. Initial consultation with stakeholders resulted in a new way of providing drug treatments being proposed. This is now formally being consulted upon.

The consultation period will run from 6 November 2006 until 31 January 2007.

# **Healthcare Commission Annual Health Check**

The Healthcare Commission has announced its annual performance rating for 2005/06. The annual ratings aim to give the public an accurate picture of local NHS healthcare organisations and how they are performing.

Both Central and Greater Derby PCTs were the only PCTs in the East Midlands to receive a rating of 'good' for use of resources - placing them in the top 8% nationally.

For quality of services Central Derby's overall rating was 'fair', along with the majority of the country's PCTs, and Greater Derby's rating was 'good'. The results for resources and quality combined mean Greater Derby PCT were the best in the East Midlands, and in the top 3% nationally. Central Derby PCT were placed in the top third of East Midlands PCTs overall.

Chief Executive Prem Singh commented:

"Considering the wide range of standards and targets, the Derby PCTs have performed well in a number of areas. There is clearly still work to do in some areas, but we are confident that we are in a strong position to improve on these in the coming year."

### **United Health Europe Contract**

UnitedHealth Europe (UHE) will be providing services for patients of the

Normanton Medical Centre following the signing of contracts with Central and Greater Derby PCTs on 7 September 2006.

UHE were selected as the preferred provider following the retirement of local GP Dr Paul and have since been working with the PCTs to establish the exact nature of the services to be provided. During contract negotiations the PCTs have managed the practice and, with the existing practice team, ensured that services have continued to be provided.

The PCTs worked closely with UHE to ensure a smooth handover, resulting in continuity of service and no disruption to patient care. Local patients have been informed of the new arrangements and UnitedHealth Europe will be liaising with patient representatives to get their views on service requirements.

In time, UHE plans to extend the surgery's opening hours and provide a greater range of outreach services to meet the needs of the local community, particularly those living with long-term conditions.
