12/07 Derby Safeguarding Children's Board: Annual Review
2004-2006 and Business Plan 2007-2008

The Cabinet Member considered a report from the Corporate Director for Children and Young People detailing the annual review and business plan produced by the Derby Safeguarding Children's Board.

Resolved to note the annual review of the activity of Derby Safeguarding Children Board's partnership arrangements to safeguard children and young people and the key actions for the coming year.

13/07 Findings from the Strategic Review of the Teenage
Pregnancy Partnership

The Cabinet Member considered a report from the Corporate Director for Children and Young People detailing the findings of the strategic review of the Teenage Pregnancy strategy.

Resolved

- 1. To note the findings of the strategic review of the Teenage Pregnancy strategy and the move from a teenage pregnancy partnership structure to a teenage pregnancy commissioning framework, as part of the city's wider children and young people's commissioning arrangements.**
- 2. To note the nine strategic objectives of the reviewed strategy:**
 - **Implement the commissioning framework**
 - **Prioritise vulnerable young people and hotspots**
 - **Involve young people and young parents**
 - **Work with parents and carers**
 - **Manage and use information**
 - **Ensure quality**
 - **Contribute to work on self-esteem and emotional well-being**
 - **Contribute to work on raising aspirations, improving attendance and attainment**
 - **Develop the workforce at all levels.**

14/07 Further Development of Extended School-Based Health Services through Derby Teenage Pregnancy Partnership

The Cabinet Member considered a report from the Corporate Director for Children and Young People on the development of extended school-based health services through Derby Teenage Pregnancy Partnership.

Resolved to support the principle that all secondary educational establishments, mainstream and special and the Pupil Referral Unit (PRU), have the opportunity of delivering extended school-based health services and that the C scheme be added to the menu of options available, subject to appropriate consultation and approval.

15/07 Every Disabled Child Matters

The Cabinet Member considered a report from the Corporate Director for Children and Young People regarding the Children's Trust Charter for disabled children, their families and carers. The charter was launched at the Local Government Association and the Association of Directors of Social Services.

Resolved

- 1. To approve that Derby City sign up to the 'Every Disabled Child Matters' charter.**
- 2. To ask the Disabled Children's Strategic Planning Group to create an action plan for implementation of the charter.**

16/07 Adoption and Fostering Inspection Report

The Cabinet Member considered a report from the Corporate Director for Children and Young People highlighting the outcomes of the Adoption and Fostering Inspection Report.

Resolved

To note and acknowledge the positive progress made in these two service areas.

To refer the report to the next meeting of the Corporate Parenting Sub-Commission for information and comment.

17/07 Schools Recycling Pilot

The Cabinet Member considered a report from the Corporate Director for Children and Young People providing details of a schools recycling pilot that would be commencing at 15 schools in the city from September 2007. This selection reflects a spread of schools types and area, and also includes schools that have already expressed an interest in taking part in recycling activities.

Resolved

- 1. To introduce a comprehensive recycling programme in Derby's schools in order to maximise the diversion of schools waste from landfill and to contribute to the carbon minimisation objectives of the City Council. In order to enable the provision of a sustainable service, to pilot a scheme with a small number of schools in Derby so that any practical service delivery issues can be "ironed out" before mainstreaming the activity City-wide.**
- 2. To that end, to include the following schools in a pilot Schools Recycling Scheme from the September term 2007, subject to checks on site suitability:**
 - Borrow Wood Infants and Junior Schools - Spondon**
 - Chaddesden Park Infants and Junior Schools - Chaddesden**
 - Ashgate Primary School - Mackworth**
 - Cavendish Close Infants and Junior Schools - Chaddesden**
 - Alvaston Infants and Junior Schools -- Alvaston**

- Littleover Community School - Littleover
- Griffe Field Primary School – Littleover
- Pear Tree Infant and Junior Schools

3. To provide a collection service for the purposes of the pilot scheme, for the following materials:
