# DESIGNATION OF ALCOHOL FREE ZONE CITY CENTRE

# RECOMMENDATION

- 1.1 To approve the designation of land in the City Centre listed in Appendix 2 as an Alcohol Free Zone.
- 1.2 To authorise the Director of Corporate Services to make the necessary Order; advertise it in a local paper and erect signs in the designated area.

# SUPPORTING INFORMATION

### Background

2.1 The Council has previously made byelaws which regulate the consumption of alcohol in certain public areas in the city. Three areas are currently covered, the City Centre, Sinfin and Spondon. However these byelaws will automatically cease to have effect by 2006.

#### **New Legislation**

- 2.2 In September 2001 the Government introduced new powers for local authorities to restrict anti-social drinking in public places by designating an area as an Alcohol Free Zone (AFZ).
- 2.3 The new designation procedure has two main advantages over the existing byelaws. Firstly it gives the Police much greater enforcement powers, including the power of arrest. Secondly the designation process is less onerous; byelaws could only come into force if confirmed by the Home Office and a great deal of supporting documentation had to be submitted.

# **Effect of Designation**

2.4 The effect of designation as an AFZ is that the Police will have the power to require a person in the designated area not to drink where a Police Officer believes that the person is, has or intends to so do. The Officer can also require the person to surrender any alcohol. Failure to comply with the Officer's request without reasonable excuse will be an arrestable offence.

# Criteria for Designation

- 2.5 The new law is not intended to lead to a complete ban on drinking in the open air but rather to restrict drinking which is associated with nuisance or annoyance to the public.
- 2.6 Before making an AFZ Order the Local Authority should be satisfied that public nuisance, annoyance or disorder have been associated with public drinking in the area concerned and that a Designation Order is appropriate.
- 2.7 The Home Office guidance stresses that local authorities will want to satisfy themselves that their new powers are not being used disproportionately or in an arbitrary fashion and comments that, "clearly there should be evidence of an existing problem with an assessment of the likelihood that the problem will continue unless these powers are adopted".

# **Existing Zones**

- 2.8 Five areas in the City have so far been designated as Alcohol Free Zones:
  - North Parade and the surrounding area (April 2003)
  - Alvaston shopping precinct (October 2003)
  - Oakwood shopping precinct and surrounding area (May 2004)
  - Chaddesden Park and the surrounding areas (August 2004)
  - Part of Normanton (August 2005).

# **City Centre Designation**

2.9 The area of the City Centre currently covered by the byelaws is shown on the plan at Appendix 3 and this was the starting point for the proposed new AFZ. However, following consultations with the Police and Councillors it was decided to extend the proposed zone to include the additional areas shown on the plan at Appendix 3 because of the alcohol related incidents in these areas. A large scale map showing the areas to be designated will be displayed at the Council meeting.

# Justification for Designation

- 2.10 In support of the proposal the Police have submitted a letter from Inspector Graham McLauglin and a report from Sergeant Alan Sandeman, who is in charge of the City Centre policing team. The report attached at Appendix 4 states that "there have been 999 Crimes of Violence reported to the Police in the City between 1 January to 17 October 2005. These range from assaults to street robberies to public order offences, many of which are exacerbated by alcohol. For the same period there have been 1899 calls for anti-social behaviour, which include rowdy behaviour, aggressive begging and street drinking".
- 2.11 In relation to that part of the proposed AFZ that falls into the Police area known as the Stockbrook neighbourhood; the Area, Inspector Gary Parkin comments, "This is an area of high crime and anti-social behaviour. A great deal of the low level criminality is associated with problematic public drinking by gangs of teenagers which leads to crime in and around the Stockbrook Park area.

There is also a well documented problem of anti-social behaviour around Abbey Street and Monk Street, Derby by a number of offenders who are usually drunk or drinking. There is an increase of crime in that area as persons make their way home from the City Centre". He adds, "An alcohol free zone would allow the Police to control the behaviour of these offenders and improve the lives of the community in the Stockbrook area".

### **Other Consultees**

- 2.12 In addition to consulting the Police, the Council must before making a Designation Order:
  - consult licensees within that area or those who may be affected by it
  - take reasonable steps to consult the owners and occupiers of private land identified in that Order.
- 2.13 Letters of consultation have therefore been written to 122 licensed premises (Appenix 5) in the area and to private landowners. A letter detailing the proposals has also been sent to Ward Councillors and Derby Community Safety Partnership.

# **Public Notice**

2.14 A public notice has also appeared in the Derby Evening Telegraph on 24 October 2005 setting out the effect of the Order and inviting any representations by 21 November 2005. This is attached at Appendix 6.

### **Response to Consultations**

2.15 A summary of responses to the consultation process, most of which are very supportive of the proposal, are attached at Appendix 7.

# **Next Steps**

- 2.16 Should Council approve the making of the AFZ for the City Centre, the decision would have to be published in the local newspaper (Derby Evening Telegraph) and signs erected (to ensure the public were made aware of the restrictions on public drinking) before the Order takes effect.
- 2.17 It is hoped that we can use some of the signage erected when the byelaws come into force but some will need replacing and new ones will be needed for the areas not previously covered.
- 2.18 In total therefore it is currently estimated that about 30 new signs will be needed. The exact location of these will be fixed in consultation with the Police and our own planning and highway officers.

# When Come into Effect

2.19 It is hoped to bring the Order into effect on 23 December 2005.

#### Financial

- 1.1.1 The cost of advertising the proposed designation was £646.10 and the same sum will be spent again if the designation is approved. It is estimated that the signs will cost approximately £2,500.00 to order and install.
- 1.2 There is no specific provision within the Council's 2005/2006 revenue budget. Attempts will be made to contain expenditure within the existing budgets.

#### Legal

 Section 12 – 16 of the Criminal Justice and Police Act 2001 gives local authorities the power to designate AFZ and the procedure to designate is set out in the Local Authorities (Alcohol Consumption on Public Places) Regulations 2001.

#### ALCOHOL FREE ZONES

The Council are considering introducing an Alcohol Free Zone in the City Centre. The streets/land proposed to be designated are shown on the attached notice. I have also included a plan for identification purposes.

The effect of the designation if introduced will be that a police officer will have the power to require a person on designated land not to drink alcohol where the officer believes that that person is, has or intends to. The officer can also require the person to surrender any alcohol. Failure to comply with the officer's request without a reasonable excuse will be an arrestable offence.

I would stress that the designation is not intended to be a complete ban on drinking in the open air, it is intended to restrict drinking where it is associated with nuisance and annoyance to the public.
