- (1) Councillor Shanker to move, Councillor Banwait to second:

'Derby residents are having their finances squeezed with the rising cost of living and local economic growth is being stifled by excessive and indiscriminate cuts by the Con-Dem Government. Council therefore calls on the Con-Dem administration, to lobby their ministerial colleagues in Government, to reverse January's damaging VAT rise for a temporary period, to provide immediate help for struggling Derby families and pensioners, and our high streets'

(2) Councillor Skelton to move, Councillor F Winter to second:

'Council notes with concern the current unsustainable arrangements for the funding of adult social care. It further notes that the Coalition Agreement acknowledges that an urgent solution must be found.

Council welcomes the findings of the Commission on Funding of Care and Support (known as the Dilnot Report).

Council therefore agrees to write to the Prime Minister. The Deputy Prime Minister and the Leader of the Opposition, urging them to use the Dilnot Report as the basis for finding a cross-party consensus on designing a new system for the funding of adult social care'

(3) Councillor Carr to move, Councillor Tuplin to second:

'Council

- welcomes recent changes announced, by Norman Baker MP, to Department for Transport rules, making it easier for councils to introduce 20 mph speed limits.
- notes that a commitment is being shown to road safety

in other local authority areas, such as Liverpool, Warrington and Portsmouth, to reduce the number and severity of accidents, by increasing the number of residential roads with a 20 mph speed limit.

 values the positive improvement in road safety and reduction in the frequency and numbers killed and seriously injured on roads that reducing the speed limits in residential areas brings

And therefore asks the Cabinet Member for Planning and Environment to consider introducing into the Highways and transport work programme, the preliminary work necessary to bring 20 mph speed limits on many residential side streets.'

(4) Councillor Hillier to move, Councillor Dhindsa to second:

'The Derby Family Intervention Project was set up in November 2007, to work with the most vulnerable families, to bring stability into their lives, to prevent homelessness and to help improve opportunities for children and young people. This service has already seen cutbacks and continues to be undermined, contrary to the recent repackaged proposals to 'transform the lives of the country's most troubled families' (DCLG, Dec 2011).

Council therefore calls upon the Cabinet to instigate a review, to examine what has worked well in this project and what gaps now need to be filled; highlighting opportunities for development, new funding streams, and the impact this work has on the community in which these families live, so that vulnerable groups and individuals are not put at risk by the harsh changes in Policy imposed by Government.'
