Report on the Call-In of the Council Cabinet Key Decisions – Prioritisation of Heritage Lottery Projects in Derby, and St Helen's House – Council Cabinet 18 October 2005

RECOMMENDATION

- 1 The Scrutiny Management Commission and the Culture and Prosperity Commission recommends that:
 - a) The Prioritisation of Heritage Lottery Projects in Derby, and
 - b) St Helen's House

be returned to Council Cabinet in order that they can reconsider their original decisions.

SUPPORTING INFORMATION

- 2.1 At a joint meeting on 31 October 2005, the Scrutiny Management Commission and the Culture and Prosperity Commission considered call-ins relating to the decisions on the Prioritisation of Heritage Lottery Projects in Derby and on St Helen's House that were made by Council Cabinet at its meeting on 18 October 2005 (Minute Numbers 148/05 and 149/05 refer).
- 2.2 In accordance with the Protocol on Call-In the joint meeting considered submissions from, and asked questions of, the relevant Council Cabinet members and the Assistant Director Culture. The joint meeting also heard evidence from the Chair of the St Helen's House Trust.
- 2.3 The joint meeting considered whether the decisions of the Council cabinet had breached any of the principles of decision making set out in Rule OS33.

Conclusions of the Commission

2.4 The Commission concluded that the Council Cabinet's decisions in respect of Prioritisation of Heritage Lottery Projects in Derby and of St Helen's House had not been made in accordance with principles (d), (e) and (f) of Rule OS 33 the Council's Constitution.

Recommendations of the Commission

- 2.5 The Scrutiny Management Commission and the Culture and Prosperity Commission recommended that:
 - a) The Prioritisation of Heritage Lottery Projects in Derby, and
 - b) St Helen's House

be returned to Council Cabinet in order that they can reconsider their original decisions
