12/09 Rickshaws/Private Hire Licence/Traffic Regulations

Olu Idowu gave an update to the Forum on Rickshaws/Private Hire Licence and Traffic regulations. He reported that the Rickshaw licence had been returned by the licensee. As he is now unlicensed, he therefore could not travel through the pedestrianised area and had the same status as any other cyclist. It was reported that the Traffic Regulation Order was still in place. The Forum requested that it should be rescinded.

The Forum raised concerns about cyclists riding in the pedestrianised area. Forum members cited examples of accidents and near misses that they had
