7/10 Quorum Arrangements for Derby City SACRE

8/10 Application for Determinations Regarding Collective Worship in Derby Schools

SACRE considered applications for determinations from Pear Tree Community Junior School, Dale Community Primary School and Arboretum Primary School.

Resolved:

- 1. to approve renewal applications for Determinations from Pear Tree Community Junior School, Dale Community Primary School and Arboretum Primary School**
- 2. to request that schools provide information on faith percentages rather than ethnic background in future applications.**

9/10 Feedback from SACRE Members Attending National Conferences

Ruth Dolby gave feedback to SACRE following her attendance at a National SACRE conference. She reported that one of the speakers of the conference, Bruce Gill, was willing to attend the Derby City SACRE and provide help and advice to the committee.

It was reported that Warwick University was conducting research into internet resources on community cohesion and inter-faith issues, the results of which could prove useful to SACRE.

Attention was also drawn to the RE-silience project, which aimed to provide mentoring to secondary schools on how to handle contentious RE issues. Members agreed that at least two Derby Schools should take up places on the scheme.

It was requested that schools be made more aware of the Jewish religious calendar, as pupils were being marked as absent from schools when unable to attend due to holy days. Ruth Dolby suggested that she could make available poster guides on the Jewish life cycle for this purpose.

SACRE noted the feedback.

10/10 To note OFSTED's 'Transforming Religious Education' Report

Graham Falgate reported that OFSTED conducts subject inspections over a two year cycle and then publishes a report highlighting key findings. One Derby school, Lees Brook Sports College was featured in this report. He added that West Park School had recently had an RE subject inspection and they would feature in the next published report in two years. It was reported that both Derby City schools were judged by OFSTED to be either "satisfactory" or "good" and both had good features. Members were encouraged that in spite of difficult financial circumstances, Derby City Council still had an RE advisor and thought this to be useful in helping teachers at ground level.

SACRE noted the report.

11/10 Parental Withdrawal from Children's Visits to Inner City Places of Worship

Laura Connolly outlined her concerns regarding parents withdrawing their children from visits to inner city places of worship, suggesting that this may be due to parents worrying about the reasons for or contents of visits. It was suggested that it may be useful to produce a guide for parents regarding the purpose of planned visits so that they could take informed decisions before the trip was arranged. It was added that schools should be open and honest with parents and make clear that visits were for educational purposes. The Open Centre asked for SACRE's support in three matters to actively promote opportunities for pupils to meet people from different backgrounds:

1. The drawing up of material to be provided to parents before visits;
2. To provide guidelines to head teachers in relation to withdrawal;
3. Determine the best way to find out why parents withdraw their children from school.

Resolved:

1. **to defer the decision to consider the proposals until the next meeting of SACRE.**
2. **to bring suggestions of best practice back for discussion at the next SACRE meeting.**
