## 34/04 Derwent Valley Mills World Heritage Site.

The Commission considered a scoping report for the review of the way in which Derby city Council promotes the part of the Derwent Valley Mills World Heritage Site that lies within the City boundary.

The report contained background information on the sites in Derby and information on the Derwent Valley Mills World Heritage Site Management Plan.

The plan seeks to advise and influence the management of the site in line with its objectives.

The suggested objective of the Commission's review should be to examine the actions that have been and will be taken to promote the part of the World Heritage Site that lies within the City boundary and, by implication, to see what else might be done to promote that part of the site.

The stakeholders for the review were noted as:

- a) Derby City Council (including Derby City Partnership)
- b) The Derwent Valley Mills Partnership
- c) The Mill Owners
- d) The Public
- e) Residents of Darley Abbey

The Commission considered the suggested methodology and provisional timetable for the review.
