## 24/04 Apologies for Absence

## 25/04 Late Items Introduced by the Chair

The Chair accepted a report from Shirley Howard on the Community Awards EID Ceremony. The Chair also read out a letter from Phil Barefoot who would like to give a presentation to the Committee in January 2005 on the Derby Physical Activity Strategy. Further to minute 20/04, a copy of the Council Cabinet report and minute extract from 9 November 2004 on 'Affordable Childcare in the City – response to the Women's Advisory Committee, was circulated.

## 26/04 Declarations of Interest

## 27/04 Minutes

The Minutes of the meeting held on 5 October 2004 were agreed as a correct record and signed by the Chair, subject to the inclusion of Councillor Latham's apology for absence.

## 28/04 Racial Harassment Complaints received by Derby Homes

Shahid Ashrif, Housing Equalities Advisor, Derby Homes, presented a report on racial harassment complaints received by Derby Homes from 1 April 2003 to 1 April 2004. It was noted that an annual report would be submitted to the Committee in the future. Mr Ashrif explained how the procedure for handling complaints by Derby Homes Tenants worked. All complaints for harassment, whether on the basis of race, gender, sexuality, age, HIV and religion were recorded.

In total nineteen complaints of racial harassment had been received in the period covered by the report and brief details of the complaints and outcomes were noted.

Discussion took place on Police involvement, including the future impact of Community Support Officers, although it was noted that only nine would be deployed in Derby.

It was noted that victims of harassment often asked to be re-located and relocation funding was available to support them.

It was also noted that the majority of perpetrators were young people and a way of tackling this problem would be through formal and community education.

## 29/04 Hands on Hands Initiative and Healthy Living

Frances Regan, Communicable Disease Control Officer, presented a briefing note on the Hands on Hands initiative. The initiative aimed to educate parents and children on how to reduce the risk of young children contracting and spreading infectious disease.

The initiative was aimed directly at those who were at greater risk due to their vulnerability, experience of poverty or social exclusion. The project had been very well received and evaluation had been very positive. Statistics for 2004 showed cases of infectious disease down on last year.

Hands on Hand initiative continued to be part of the Safety First Schools Roadshow, which is a multi-agency safety event for 10-11 year olds.

# 30/04 Community Safety Strategy Development for the next three years

Sharon Squires, Director, Derby Community Safety Partnership, gave a presentation on the 2004 Crime Audit for Derby.

The presentation contained the following information:

- Crime statistics
- Link between drugs and crime
- Under-reporting in domestic violence and hate crime
- Crime hotspots in the City
- Anti Social Behaviour
- Drug and alcohol misuse, problems with shortage of GP's willing to prescribe Methadone in the City
- Youth Offending
- Strategies for reducing crime, anti-social behaviour and drug and alcohol misuse

Positive aspects of the audit were that Derby had been perceived as a relatively safe place to live and 75% of survey respondents viewed their neighbourhood as a very good or good place to live.

It was noted that crime had increased as a result of longer drinking hours but the Partnership were currently lobbying the Council on this issue in advance of the Council becoming responsible for liquor licensing,

Pam Thompson, Consultation Support Officer, distributed a proposed programme for the International Women's Day on 5 March 2005. It was noted that the proposals were subject to finance being secured and that the event had to be costed.
