Topic Review Update

SUMMARY

- 1.1 Earlier in the year the Children and Young People Board chose to look at how we can provide more integrated mental health support for children in the City.
- 1.2 This report highlights progress to date and sets out the draft recommendations.

REASONS FOR RECOMMENDATION

- 3.1 The recommendations need to be considered by the Board prior to going to Cabinet.
- 3.2 The Board Members who attended the evidence gathering are still considering the evidence they heard and have decided to try to meet with the parents of service users therefore recommendations may be added or amended.
- 3.3 The full Board will have an opportunity to comment on the recommendations; however, as this is the last meeting of the municipal year it is recommended that the four Board Members - who heard all the evidence - are granted authority to sign off the final report before it progresses to Cabinet.

SUPPORTING INFORMATION

4.1 Earlier in the year the Children and Young People Board chose to look at how we can provide more integrated mental health support for children in the City.

- 4.2 On 16 February 2015 several Board Members attended a day of evidence gathering with witnesses from the Clinical Psychology Service, CAMHS and Community Paediatricians.
- 4.3 A number of draft recommendations were produced following this session, these are attached in appendix 2.
- 4.4 It has been suggested by Members that it would be beneficial to hear from the parents of service users from each of the services and further recommendations may stem from this. At the time of writing this report an evidence gathering session with service users was being explored.
