REVIEW OF POLLING DISTRICTS AND POLLING PLACES (ACTING) RETURNING OFFICER'S PROPOSALS

To improve voting facilities for our electors and, as far as possible, to make polling stations accessible, the Council is carrying out a full city review of polling districts and places. Our last review was completed in December 2011. The Electoral Administration Act 2006 requires us to carry out a review every four years. The final review recommendations will be scheduled to be approved at Council on Wednesday 29 January 2014. The review has been carried out in accordance with guidance issued by the Electoral Commission.

The current polling place review now enters its second stage. Representations made during the first part of the review consultation to the (Acting) Returning Officer are available to view in a separate document.

The main issues considered in the development of the proposals for polling districts and polling places are that:

- No more than 2,500 electors should poll at any one polling station (not including postal voters); however there can be more than one polling station in a polling place.
- The location, size and layout of a polling station when deciding the number of electors to be allocated.
- Proposed future developments in the city that will increase the number of houses and the potential number of electors in a ward or polling district over the next four years.
- Accessibility to polling places for disabled people receives full consideration.
 We are consulting with and requesting feedback from electors, councillors, members of the public, organisations representing disability groups, polling staff and inspectors and will take all feedback into account.
- Whether the proposed polling places avoid barriers for the voter including major roads, rivers, steep hills etc.
- Feedback received following recent elections raised by members of the public, elected members or the police about particular polling places is considered appropriately.

The (Acting) Returning Officer presents below revised proposals for polling districts and polling places following on from the initial consultation period.

Alternative suggestions in relation to polling districts and polling places are welcomed together with reasons for any alternative proposals so that they may be given full consideration.

Comments on the revised proposals are invited no later than **Friday 10 January 2014.**

Allestree Ward

Following comments received during the review consultation process about the suitability of The Woodlands Hotel as a future polling place, a review of polling arrangements in the Allestree Ward has taken place. As a result it is proposed reduce the number of polling districts in the Allestree Ward from 5 to 4 which will also result in a financial saving in terms of polling station staffing costs.

It is proposed that the current AL2 polling district be merged with other polling districts in the ward so that no polling district contains more than 2,500 polling station electors.
