- 6. provide an annual report to full Council on their workings and make recommendations for future work programmes

- 7. carry out any other statutory duties and responsibilities allocated to local authority scrutiny committees.
- 4.2 The terms of reference for this board cover the service areas below, and fully encompasses both the Communities, Neighbourhoods and Streetpride Cabinet Member portfolio and the Leisure, Culture and Tourism Cabinet Member portfolio:
 - Community Cohesion & Safety
 - Neighbourhood agenda
 - Highways and Grounds Maintenance
 - Street Cleansing
 - Refuse and Waste Management
 - Environmental Health, Trading Standards, Bereavement Services and Food Safety
 - Housing Enforcement
 - Building Control
 - Leisure Facilities
 - Libraries
 - Culture(including Derby Live)
 - Tourism
 - Parks/Golf/Nature Reserves
