# Taxi Licensing Administration & Compliance Activities – Q1 2017/18

\*Other serious defects can include:

- Meter seals missing/damaged/tampered with
- Meter calibration incorrect/overcharging
- Door wind check straps weak operation
- Misaligned doors
- Water ingress into passenger/luggage compartment
- Unable to access engine/boot compartments
- Loose/deteriorated engine drive belts
- Battery insecure
- Illuminated warning lights on instrument panel
- Dirty interior/exterior
- Broken/insecure seat bases/backs
- Worn/defective seat belts

- Radiator coolant leak(s)
- •Engine oil leak
- Exhaust system blowing/leaking
- •Engine fuel leak(s)
- Engine misfires
- •Excessive smoke emission from exhaust
- Missing trim exposing sharp edges
- •Grab handles insecure
