The Chair withdrew from the meeting as he had already declared an interest.

Jeff James gave a presentation to the Committee on the proposal to develop this building to ground floor retail units with residential accommodation on the upper two floors. Discussion was held as to the proposed height of the building and how the design would fit in with the surrounding area and the use of the triangle of land between King Street and Quaker Way.

Jeff James Left the meeting whilst the Committee discussed this matter further as he also declared an interest in the property.

Committee was not currently convinced that the building could not be saved and adaptively reused. The Committee felt there needed to be specific attention to context and any new building should blend in with the setting of a number of heritage assets (both designated and non-designated - listed and locally listed buildings, and the Strutt's Park Conservation Area) which is part of the significance of these buildings. Committee stated that it might be concluded through this evaluation that the height be reduced to better reveal significance and respond to context.

The committee:

- 1) Resolved that they would like to see a full feasibility / viability study of the existing building presented to a further meeting
- 2) Resolved that would like to see height ofbuilding on the new building proposal reduced
- 3) Resolved that the new building design needed more attention to detail in order to fit in with the surrounding buildings.
