# 21/04 Applications determined since the last Report dated 2 July 2004

Harry Hopkinson, Team Leader, Built Environment, introduced a report which set out the applications that had been determined since 2 July 2004.

It was noted that officers took into account the comments from the Committee when making their recommendations to the Planning Control Committee. It was agreed that many of the Conservation Area Advisory Committee's recommendations on smaller applications were agreed by Planning Control Committee.

### 22/04 Committee Report

The Committee considered a report of the Assistant Director – Development, about applications received and resolved to make the following comments:

#### **Arboretum Conservation Area**

- a) Code No. DER/704/1389 To raise height in one section of existing fence to 4 metres and other sections to 5 metres on land at Arboretum Recreation Ground adjacent to Reginald Street.
  - No objection, subject to conditions relating to appropriate detailing of the fence materials and the support posts.

#### **City Centre Conservation Area**

- b) Code No. DER/804/1582 Restoration of Fire Escape, Industrial Museum, 32 Full Street.
  - No objection, subject to conditions minimising the replacement and accurately reinstating the fire escape. Should the works involve any excavation for new foundations, then it was recommended that an archaeological evaluation should be carried out.

#### **Darley Abbey Conservation Area**

c) Code No. DER/804/1575 – Infilling of a door opening and removal of link to adjacent pottery, 4 Mill Cottages, Darley Abbey Mills, Darley Abbey

Code No. DER/804/1579 – Change of use to residential, 4 Mill Cottages, Darley Abbey Mills.

- No objection to the change of use subject to details of the conversion work being to the satisfaction of the Council's Conservation Officer.

- d) Code No DER/804/1547 Alterations to rear extension at 11 Darley Street, Darley Abbey.
  - No objection subject conditions requiring the reduction in the size of the three-light roof-light to a two-light roof-light and satisfactory detailing to the satisfaction of the Council's Conservation Officer.

#### **Friar Gate Conservation Area**

- e) Code No. DER/804/1580 + DER/804/1581 Alterations and sub-division of property into 2 dwellings with some demolition and conservatory, kitchen and bedroom extensions at 3 Vernon Street.
  - No objection to the principle to the proposal subject to satisfactory detailing, but do object to the following elements:
    - demolition of the outbuilding in the absence of any justification
    - the addition of a new dormer window
    - the erection of the new internal boundary wall.

#### **Mickleover Conservation Area**

- f) Code No. DER/804/1599 Extension to dwelling house (conservatory) and alterations to existing vehicular access at 4 The Green, Mickleover
  - No objection subject to satisfactory and appropriate detailing.

#### **Strutts Park Conservation Area**

- g) Code No. DER/804/1520 Conversion from house in multiple occupancy to single dwelling house at 13 Kedleston Road
  - No objection.
- h) Code No. DER/804/1509 Installation of replacement front door and erection of side gate at 61 Duffield Road
  - No objection in principle but the Committee suggests amendment to the design of the front door and side gate to secure designs more contemporary with the age / style of the property.
