- (1) Councillor Bayliss to move, Councillor Russell to second:

'Council notes the disproportionate impact that the Government's austerity programme has had in Derby, compared to other local authority areas. Council is dismayed that the cumulative impact of in-year cuts to funding in 2011-12 and 2012-13 amounts to £75.77 per person, as opposed to a few pounds, or even pence, in other parts of the country.

Council demands a Fair Deal for Derby.

Council agrees to lobby Government to ensure the cumulative impact of cuts is shared across all local authority areas, rather than being based on a postcode lottery.'

(2) Councillor Atwal to move, Councillor Skelton to second:

'Derby has a good reputation for Hackney taxis being readily available for members of the public. Derby needs to maintain this reputation.

Council believes that good relations with the taxi trade is key to achieving this and calls for –

- the re-instatement of regular trade meetings with the taxi trade, as were held when the Liberal Democrats led the Council
- an attitude of open-minded listening to, and action on,

reasonable requests made by the taxi trade

- all members to commit themselves to developing a constructive relationship with the taxi trade, based on mutual respect, openness and transparency.'
- (3) Councillor Russell to move, Councillor Stanton to second:

'Council notes with grave concern, changes to Council Tax Benefit, which result in local authorities across England being forced to reduce benefit payments by ten per cent, irrespective of demand, from April 2013.

Council strongly opposes the imposition of this draconian change, which pays no regard whatsoever to the needs of claimants, and particularly the impact it will have on society's poorest people, while the Government centrally is offering tax breaks to Britain's highest earners.

Council recognises the efforts of officers to liaise with colleagues across the county, and particularly with Nottingham City Council and Leicester City Council, to develop a proposed scheme that makes the best of a very bad situation.

Council resolves to continue to consult the public and work closely with local authorities across the county and region on this matter, to deliver the fairest scheme possible.

(4) Councillor Dhindsa to move, Councillor Martin to second:

'Council recognises the excellent work undertaken by organisations such as Remploy in supporting disabled workers into employment.

Council recognises its social responsibility towards people with disabilities in our wider communities.

Council resolves to continue to take steps to ensure job opportunities are actively promoted to people with disabilities and that progress is reported back to the Council Cabinet member.'
