# **General Licensing Fees and Charges 2024/25**

## **Purpose**

- 1.1 The Public Protection Service annually reviews its fees and charges across the range of services it provides. This is to ensure that they reflect the cost of delivering services and that any inflationary cost increases are considered.
- 1.2 The proposed fees and charges for 2024/25 commencing 1 April 2024 are set out in Appendices 1 and 2. Appendix 3 outlines the fees that are set wholly by statute. The amounts charged are either set by statute or are based on recovering the costs incurred.
- 1.3 All charges are outside the scope of VAT.

#### Recommendations

- 2.1 To approve the proposed fees and charges for 2024/25 set out at Appendix 1 and Appendix 2.
- 2.2 To note the statutory fees and charges made under the Licensing Act 2003 set out at Appendix 3.

### Reason

3.1 To ensure that the fees and charges for services provided during the next administrative year comply with and can be justified based on statutory cost recovery principles, where applicable.

## **Supporting information**

- 4.1 As part of the 2024/25 budget preparation, the Licensing Team has reviewed it's fees and charges. This annual review is necessary to ensure that:
  - Any additional costs (or efficiencies) of providing the service are incorporated
  - Fees and charges reflect the cost of delivering the service

The proposed general licensing fees and charges for 2024/25 are set out in the appendices set out in the report.

- 4.2 Appendix 1 sets out the proposed fees for the licences, registrations and permits the service administers and are based on cost recovery and due to internal savings, it has been possible to keep the increase to a minimum.
- 4.3 Appendix 2 sets out the proposed fees chargeable under the Gambling Act 2005. Where permitted, these are based on cost recovery and up to the maximum permitted level. Some of these fees and charges are set by statute however due to internal savings, it has been possible to keep the increase to a minimum.
- 4.4 Appendix 3 sets out all fees chargeable under the Licensing Act 2003. All these fees and charges are set in statute.

#### Public/stakeholder engagement

5.1 None, the proposed fees and charges are either statutorily set or calculated on recovering the cost of running the service.

## **Legal implications**

8.1 Unless otherwise stated, the fees and charges set out in Appendices 1 and 2 are not fixed in statute and are set at the discretion of the local authority. Except for discretionary services, the generally applicable principle is that non-statutorily prescribed fees and charges must be set at a level that properly reflects the cost of delivering the service.
