## Dear Sir/Ma'am

Please accept this correspondence as notification that it is the intention of the Chief Officer of Police for Derbyshire, to object to the Temporary Event Notice (TEN) submitted to Derbyshire Constabulary on Tuesday 20 September 2022 in relation to the premises known as Colombo House, Colombo Street, Derby DE23 8IW. This premises is unlicensed for any Licensable activities namely, the sale by retail of alcohol, late night refreshment, regulated entertainment, or the sale of alcohol on behalf a club.

This objection notice relates to an event taking place on the 5 November 2022 to 6 November 2022 between the hours of 2100hrs and 0300hrs. The proposed licensable activities at the event which is described as a Deez Entertainment Old School Classic Party. The planned licensable activities are the sale by retail of alcohol, regulated entertainment, and late-night refreshment.

The Notice has been given by Micheal DOUCE 29/01/1966 who does not hold a personal licence. It is submitted that, when having regard to the proposed hours relating to licensable activities detailed in the TEN, when balanced with the proposed steps to promote the licensing objectives, the proposed Notice if allowed without challenge could undermine all four of the Licensing objectives.

It is the view of the Chief Officer of Police that this notice, if granted without suitable and adequate safeguards, in this case by the addition of suitable and proportionate conditions (which cannot be enforced on a TEN without being able to transfer from an existing Premises Licence) could cause unwanted alcohol fuelled anti-social behavior, and crime and disorder into the early hours of the morning.

It can reasonably be expected that a high proportion of the guests attending this premises, until the early hours of the morning, will consume an amount of alcohol to make them intoxicated/drunk which would undermine the Four Licensing Objectives.

It is the understanding of the Chief Officer of Police that this objection notice is submitted in accordance with Section 104 (2) of The Act. Further, that as this notice was given as a 'late notice' as defined in Section 100A (3) of The Act, the Chief Officer of Police would respectfully invite the Licensing Authority to give a counter notice to the premises user as required by Section 104A of The Act due to the fact that enforceable conditions cannot be added to the
