Report of the Strategic Director of Neighbourhoods

GeneralLicensing Feesand Charges2015/16

SUMMARY

- 1.1 The Neighbourhoods Directorate annually reviews its fees and charges across its range of services. This is to ensure that the fees and charges reflect the cost of delivering services, that inflationary cost increases are taken into account, and that budget income targets are achieved.
- 1.2 The proposed fees and charges for 2015/16 are set out in Appendix 2. The amounts charged are either set by statute or are based on recovering the costs incurred.
- 1.3 All charges are outside the scope of VAT.

RECOMMENDATION

2.1 To approve the changes in fees and charges for 2015/16 as set out in Appendix 2.

REASONS FOR RECOMMENDATION

3.1 To ensure that the fees and charges for services provided during the next administrative year comply with and can be justified on the basis of statutory cost recovery principles, where applicable.

SUPPORTING INFORMATION

- 4.1 As part of the 2015/16 budget preparation, Departments within the Neighbourhoods Directorate have reviewed their fees and charges. This annual review is necessary to ensure that:
 - Any additional costs (or efficiencies) of providing the service are incorporated
 - Fees and charges reflect the cost of delivering the service

- 4.2 The proposed general licensing fees and charges for 2015/16 are set out at Appendix
 2. Some of the fees are set nationally and cannot be changed by the Council regardless of any inflationary cost increases.
- 4.3 However, for some fees, further work has been undertaken to reflect the actual cost of the licensing process which has resulted in increases or decreases. The final column of Appendix 2 identifies where this has occurred.

Fee and charges related to the Gambling Act 2005 have not been included and will be submitted on a separate report.
