Urgent Non-Executive Decision Made by the Chief Executive

SUMMARY

1. This report asks the Council to note the urgent non-executive decision taken by the Chief Executive, in consultation with the political group leaders, since the last meeting of the Council.

 - 1. To update the Scheme of Delegations to include:
 - a) Taking enforcement action against unsatisfactory housing conditions and
 - b) Promoting standards within the private rented sector under the areas of responsibility of the Strategic Director, Neighbourhoods.
 - 2. To give the Director of Environment and Regulatory Services (in addition to the Director of Housing and Advice Services) responsibility for appointing any members of staff to act as authorised or proper officers under the following Acts, insofar as the appointment relates to the functions listed in point 1:

REASONS FOR RECOMMENDATION

3.1 Following the corporate restructure in May 2010, the Housing Standards team was

moved from the Adults, Health and Housing Directorate to the Environmental and Regulatory Services Department in the Neighbourhoods Directorate. Consequently, the Strategic Directors of Neighbourhoods and Adults, Health and Housing both have responsibility for different aspects of the functions listed in point 1.

SUPPORTING INFORMATION

- 4.1 In the Council's Constitution the Chief Executive has delegated authority to make decisions on behalf of the Council, in cases of urgency, in the discharge of any non-executive function of the Council other than those delegated to another officer or those which by law can be discharged only by full Council. The Chief Executive always consults, and seeks the agreement of, the political group leaders on proposed decisions.
- 4.2 This report advises Council of the following decision taken by the Chief Executive in accordance with this delegated authority:
