193/08 Council Tax Base

The Council Cabinet considered a report on Council Tax Base. The Council had to calculate the 'Council Tax Base' for 2009/10 as a means of raising council tax income from Derby council tax payers. The tax base was an estimated figure which equated to the effective number of domestic properties in terms of 'Band D' in the Council's area during the year. It was used to translate total council tax income requirements in a headline charge for Band D properties in the city. Charges for other bands were calculated as defined fractions of the headline charge. Due to the continued growth in the number of domestic properties over the past year, the Council Tax Base could be increased from 69854 to 70187.03 Band D equivalent properties.

Decision

To recommend Council, pursuant to the report and in accordance with the Local Authorities (Calculation of Council Tax Base) (Amendment) (England) Regulations 2003 (SI 2003/3012), to approve the council tax base for the year 2009/10 as 70187.03 band D equivalent properties in accordance with the methodology and estimates shown at appendices 2 and 3 of the report.
