## 98/07 Building Schools for the Future Part 2

The Commission received a report on Building Schools for the Future Part 2, outlining the draft strategy for change (Part 2). Members were told that the strategy would be presented to a future Cabinet meeting, but due to the tight timescales would need to be presented to the Building Schools for the Future before that could happen. It was noted that any significant changes to the bid proposed by Cabinet would have to be resubmitted to Building Schools for the Future for approval, and this could potentially lead to the funding being lost.

It was reported that the results of the Gateway reviews used to inform the strategy had been to the last project board meeting, and the commission agreed it would be useful to see the review results at the next meeting.

## 100/07 Primary Strategy for Change

The Commission received a report on the Primary Strategy for Change. It was noted that the Strategy would provide £10 million over the next 2 financial years and then £3 million per year until 2018. The strategy document was required to be able to access available funding for schools and therefore there was a fairly prescriptive format. It was noted that the strategy focussed on schools where there was a backlog of maintenance and where no organisational change would be required.
