Report of the Director of Public Health

Public Health Outcomes Framework Detail Report

SUMMARY

- 1.1 An overview of current performance across the Public Health Outcomes Framework was presented at the Health and Wellbeing Board held on 16th January.
- 1.2 The report showed Derby's performance against each available indicator ranked in relation to the other 152 local authorities. Those indicators where Derby performed amongst the top 20% local authorities and bottom 20% of local authorities was reported.
- 1.3 Further update and detail was requested on the following indicators:
 - Fuel poverty
 - · Low birth weight of term babies
 - Infant mortality
 - Take up of NHS Health Check programme.
- 1.4 **Fuel poverty** Derby performs significantly worse on this measure than the national, regional and 'family' group comparators, although has followed a similar trend and saw a slight reduction in the latest reported figures.
- 1.5 **Low birth weight of term babies** Derby performs significantly worse than England and the regional average but comparatively to its family group.
- 1.6 **Infant mortality** Derby performs significantly worse than England and the regional average but comparatively to its family group.
- 1.7 There is notable variation between Derby wards on all the above indicators.
- 1.8 **Take up of NHS Health Check programme** Derby performs significantly worse on this measure than the national, regional and family group comparators. A primary reason for this is that the proportion of the eligible population offered a Health Check is comparatively high in the city. This means that although there may be a similar proportion of the overall eligible population taking up Health Checks (previous indicator definition), the proportion of those eligible offered and taking up is lower. There is considerable variation between general practices in the level of uptake.
