Refreshing Derby's Local Area Agreement

SUMMARY

- 1.1 This report describes progress made in refreshing Derby's Local Area Agreement, LAA, for 2006 and presents the first draft of the Agreement for consideration by Members.
- 1.2 Derby's pilot LAA started on 1 April 2005 and covered three areas of activity or blocks:
 - Children and Young People
 - Healthier Communities and Older People
 - Safer and Stronger Communities
- 1.3 There are a number of changes which will impact upon the refreshed LAA for 2006:
 - In line with Government guidance, it has been agreed to introduce a fourth economic block 'Economic Development and Enterprise'.
 - The opportunity to align the LAA with the work of the Area and Neighbourhood project board, supporting the Council's priority of reducing inequalities across the Derby City areas.
 - The introduction of a 'single pot' for funding streams.
- 1.4 Future governance arrangements for the LAA are being considered as part of the Derby City Partnership review taking place from January to March 2006.
- 1.5 Subject to any issues raised at the meeting, I support the following recommendations.

RECOMMENDATIONS

- 2.1 To note the progress made in refreshing Derby's Local Area Agreement.
- 2.2 To approve the draft Local Area Agreement as the basis for further negotiation.
- 2.3 To give delegated authority to the Chief Executive, in consultation with the Leader of the Council and the Directors of Community & Regeneration and Resources, to negotiate the Local Area Agreement on behalf of the Council and its partners.
- 2.4 To receive further reports to confirm the Council's approval before the Agreement is entered into.

Refreshing Derby's Local Area Agreement

SUPPORTING INFORMATION

- 1. Background to Derby's Local Area Agreement
- 1.1 Derby was chosen as one of just 21 areas to pilot the Government's new concept of Local Area Agreements, LAAs. The Council has worked closely with other partners through Derby City Partnership, DCP, in establishing and developing the agreement. The Community Strategy and DCP's '2020 Vision' provides the context and priorities for the LAA.
- 1.2 Derby's pilot Local Area Agreement LAA took effect from 1 April 2005 and covers three main areas of activity...
 - Children and young people tackling disadvantage and better integration of services to improve educational attainment, promote healthier lifestyles and give better support to families with young children. A key feature of this block is to underpin integrated service delivery and to tackle disadvantage in line with our work on the Children Act 2004 and developing our Children and Young People's Plan.
 - Safer and stronger communities this block takes a broad view of community safety, going beyond the traditional focus on crime and disorder by looking to reduce incidence and fear of crime and anti-social behaviour, making Derby an even better place to live by providing cleaner, greener and safer public places, encouraging active citizenship and reducing economic, social and environmental disparities between Derby's communities.
 - **Healthier communities and older people** improved health outcomes and enabling vulnerable adults and older people to live more independent lives.
- 1.3 It was agreed that the performance indicators and targets included in Derby's Second Generation Local Public Service Agreement LPSA2 and the Neighbourhood Renewal Strategy would form part of the LAA. Both the LPSA2 and Neighbourhood Renewal indicators have been finalised recently and will be reflected throughout the LAA blocks.
- 1.4 LAAs are three-year agreements but are subject to an annual review when it should be possible to amend outcomes and targets and extend the range of funding streams in the LAA if we wish to do so.

1.5 The latest timetable for review and re-negotiation of the LAA for 2006 – referred to as the 'refresh' – is attached at **Appendix 2**. This has been agreed with senior Government Office officials.

2. Key changes

- 2.1 The new guidance issued by ODPM formalises the establishment of a fourth block Economic Development and Enterprise focusing upon sustainable economic development, business growth and regeneration. Derby is already developing proposals around Local Enterprise Growth Initiative LEGI funding and it has been decided that the LEGI Steering Group should in effect become a shadow 4th block management group for the LAA.
- 2.2 The refresh provides an opportunity to align the LAA more closely to the Community Strategy and neighbourhood renewal agenda. We are placing special emphasis on five neighbourhoods, Osmaston, Normanton, Sinfin, Stockbrook and the Austin estate in our approach to reducing inequalities across the city area. All of these neighbourhoods, and the city centre, will benefit from a joined up approach to resident engagement, community safety and liveability. This work is being overseen by the partnership Area and Neighbourhood Project Board, which will also review the Council's Area Panels, to enhance councillors' community leadership roles, and examine opportunities for closer partnership working and strategic planning at locality level.
- 2.3 Government Office has recently confirmed that Derby will become a 'single pot' LAA. The 'single pot' in effect means that it will not be necessary to group either outcomes or funding streams under the four blocks, so areas will have the freedom to spend any funding on achieving any outcome agreed as part of the LAA subject to any mandatory outcomes, indicators and targets associated with particular funding streams.
- 2.4 The 'single pot' or otherwise is unlikely to fundamentally change the content of our LAA for 2006-07, but may affect structural arrangements and presentation and offer some additional flexibility in the use of funding and make it easier to integrate the LAA with the Community Strategy, particularly around the Area and Neighbourhood working initiative.

3. Progress in refreshing the LAA for 2006-07

- 3.1 The initial review process began with a series of workshops to consider the future direction of the LAA. The first workshop took place on 1 November, attended by members of the DCP's Strategy Co-ordination Group and LAA Steering Group. The group evaluated what we have achieved with our LAA so far. Discussion focused on the following areas...
 - Relationship with the Community Strategy the LAA is seen as one of the key delivery vehicles for the Community Strategy. Improving the links to Community Strategy priorities, and also the Corporate Plan would assist in delivering key outcomes.

- Governance arrangements there was concern that duplication was occurring between DCP cities and LAA block management groups. It was agreed that the proposed review of DCP in early 2006 provided an opportunity to align governance arrangements more closely.
- Block structures greater flexibility between blocks would promote progress in tackling cross cutting issues – particularly in light of the single pot.
- Freedoms and flexibilities the need to secure further freedoms and flexibilities to support the LAA, with a rationalisation of the number of targets and indicators.
- 3.2 Following the workshop on 1 November and discussions around implications of the single pot, it was decided to postpone the wider consultation with partners and stakeholders planned for 15 November. Instead, this second session was attended by members of the Steering Group and Strategy Co-ordination Group to focus upon the development of sub-outcomes, performance indicators and funding streams for each block.
- 3.3 Initial proposals arising from these workshops were approved by the Strategy Coordination Group on 24 November. The key outcomes were circulated to Members and partners during December to give them the opportunity to comment on the proposed outcomes, indicators and funding streams.
- 3.4 The Steering Group and project teams comprising officers from the Council and other partners through Derby City Partnership DCP has prepared a draft 'refreshed' LAA for Derby, which has been forwarded to the Government Office for the East Midlands GOEM to initiate negotiations. A summary of the main outcomes we want to achieve through our refreshed LAA is attached at **Appendix 3**.

4. Governance arrangements

- 4.1 It has been agreed with Government Office that governance arrangements for the LAA will be considered during the review of Derby City Partnership, which will take place in early 2006.
- 4.2 Two workshops will be arranged during January and February to consider LAA governance and commissioning arrangements in light of the review of DCP taking place from January to March 2006. The workshops will cover...
 - Purpose and structure of the partnership
 - Management and commissioning arrangements for the LAA.
- 4.3 Implementation is likely to take effect during April and May 2006.

5. Next steps

5.1 Agreement negotiations will take place with Government Office and Government Departments throughout the first few months of 2006. The final agreement must be submitted by 24 February, with Government ministers due to sign at the end of March.
