21/20 Declarations of Interest

28/20 Minute extract 06/20 of the Standards Committee meeting held on 7 July 2020

The Mayor introduced a minute extract from the Standards Committee meeting held on 7 July 2020, recommending amendments to the procedures for the assessment and review of allegations of breaches of the Councillors' Code of Conduct, which required approval by Council.

It was moved by Councillor S Khan, and seconded by Councillor Atwal, that minute 06/20 of the Standards Committee be approved.

29/20 Motion: Support for the aerospace industry

Councillors Bettany, Shanker and Willoughby left the meeting at this point.

The following motion was moved by Councillor Skelton, and seconded by Councillor Naitta:

Derby City Council acknowledges the key role played by the Aerospace Industry in the local Derby economy and community, in particular the important contribution that Rolls-Royce and its supply chain has had for the last 120 years. The company, whose name is synonymous with world-beating quality, has helped put Derby on the global map.

The Council is all too aware that the current and continuing global Covid-19 pandemic has hit Rolls-Royce, and the whole aviation sector, hard. The 'locking down' of countries, and few aircraft flying, has resulted in an immediate dramatic reduction to Rolls-Royce's income which is heavily dependent on 'power by the hour' agreements.

These aerospace companies currently find themselves in the difficult position of having to make a large number of job reductions for this highly skilled workforce, and the impact that this will have on the overall Derby economy and the personal livelihoods of people across Derby and beyond.

Council notes with regret that the UK government has provided no specifically targeted assistance package for this key industry to survive the coronavirus crisis. This is in contrast to the governments in France, Germany and Spain that have all taken steps to secure the future of their aerospace and aviation industries.

To this end, Council moves to:

- 2) Submit departmental carbon reduction quarterly internal reports and an annual external report.*
- 3) Introduce a Climate Implications section in the standard report template no later than 30th September 2020. The Climate Implications section will assess the impact the decision taken will have on carbon output and climate impact. The Climate Implications section should include but be not limited to;*
 - a) Unmitigated carbon footprint consequences*
 - b) Carbon mitigation options considered*
 - c) Final carbon impact of project, plan or decision*
