66/09 Question and Answer Session with the Chief Executive of Derby City Council

The Chief Executive addressed the Forum on the transformation programme, outlining how the programme would take an evidence based approach to deliver improved services and greater efficiency. He added that a review of employee performance was in progress, identifying the training needs and skills gaps of employees. It was reported that he expected the programme to result in better consultation with communities and a more direct relationship with Neighbourhood Boards.

The Chief Executive also congratulated the Forum on its excellent attendance levels and range of members, stressing that it would have an opportunity to help shape the future priorities of Derby City Council.

The Chair reminded the Forum of its duty to engage with the Council, suggesting that members should consider joining Neighbourhood Boards.

71/09 Welcome Pack: Community Safety Partnership

The Forum received a presentation from Pop Gill on the progress of the Welcome Pack. It was reported that the key headings and entries of the pack had been

decided and that they were consulting with the relevant groups on the content. The Forum expressed concern that hard copies of the pack would only be available in English, with translations available on CD and electronically. Councillor Berry stressed the need for the pack to be understandable and in Plain English. Pop Gill said he would investigate producing hard copies in all languages, but that this may be difficult due to financial constraints. It was suggested that an executive summary of the pack in all languages would be helpful.

## **72/09      Funding for New Communities**

The Forum received a presentation from Pop Gill on the Migration Impact Fund. It was reported that the initiative had originally secured funding for two years and concerns were raised regarding the sustainability of the project after this time, although it is hoped it would continue.

The Forum received a presentation from Nigel Groom on support for new arrivals. He reported that access to education and fear of discrimination in schools were problems for some families. It was suggested that it would be helpful to record incidents of discrimination in schools and officers stressed that they needed to be informed about such incidents in order to act.

The Forum received a report from Hazel Lymbery on the Be Inspiring Project Fund. It was reported that in addition to the projects listed, £20,000 had been allocated to a Teenage Pregnancy Partnership. The Forum welcomed the initiative, but questions were raised about why individual proposals were not allocated funding and how they were assessed. Hazel Lymbery undertook to respond on a case-by-case basis outside of the Forum.

The Forum received a report from Gill Collinson on Derby City PCT. The Forum heard that the PCT was operating in a difficult financial climate and a changing landscape due to the change of Government, with cuts in the NHS budget expected. The Forum enquired as to who was winning the PCT's commercial contracts and it was agreed that a list would be provided, without the value of each contract being disclosed due to commercial confidence.

**The Forum resolved to note the reports.**

**Gill Collinson to provide the Forum with a list of organisations that have been awarded commercial contracts by Derby City PCT.**
