Ours is an ethnically and culturally diverse community. 39% of our pupils are muslim, 27% christian, 10% sikh and 24% other.

Currently all pupils participate fully in collective worship and this is largely due to the multi faith nature of these occasions.

2. Does the decision to apply for a determination have widespread support among parents, pupils, Governors and staff?
Yes.

Positive feedback from parents shows they too enjoy the multi-faith nature of our regular celebration assemblies.

3. How will the decisions be made and recorded, on the balance of material used from different faith traditions, within collective worship, and what practical arrangements will be made for the conduct of collective worship?

An act of collective worship takes place daily, either all together as a whole school, in year groups or in classes. These follow the half-termly SEAL (Social and Emotional Aspects of Learning) themes and are supported by additional work in class, which develop the pupils emotional intelligence and address barriers to learning such as self esteem, perseverance and relationships. Acts of collective worship are led by all school staff.

Throughout the school year, all classes participate in the celebration of major festivals such as Eid, Diwali, Christmas, Hannukah and Easter. Each class presents an assembly based on a celebration to

the school and parents. In addition, all pupils visit the places of worship of all major faiths as part of the RE curriculum.

Parents currently do not remove their children from assembly because of the current determination. It is a question that it often raised on entry to school.

2. Does the decision to apply for a determination have widespread support among patents, pupils, Governors and staff?

Governors debated the issue at their meeting on 14th where parent governors were in attendance. There was full support for a continued determination. Staff support is consistent with an application and the school council have expressed their support.

3. How will the decisions be made and recorded, on the balance of material used from different faith traditions, within collective worship, and what practical arrangements will be made for the conduct of collective worship?

Currently there is an established programme of assemblies. The themes are managed by our RE Co-ordinator and support the PSHE curriculum in school using SEAL materials and our school's 4 R's – Resilience, Relationships, Resourcefulness and Reflectiveness. Staff Inset time has been managed to ensure all staff are able to lead assemblies within these themes.

Faith assemblies are celebrated throughout the year and reflect our current ethnic make up.

Pupils are encouraged to reflect on their personal faith as a result of assembly themes.

Visitors are encouraged and supported by the co-ordinator to plan for their presentations.

Assemblies are seen as an intrinsic part of our school ethos and are used positively to promote the school's belief systems.

Collective worship will continue to take place daily for each child, four times a week in the school hall and once in their class area. Collective worship will continue to be conducted by the head teacher and senior staff according to the termly plan which is drawn up and ensures

Learning to Learn Presentation

Barbara Webster (ICT and Learning to Learn Coordinator) joined the meeting and outlined the six main principles of the Learning to Learn concept that Arboretum had begun to adopt. Barbara and staff advised that since the launch in September Learning to Learn had been received very positively both with the children and with the staff.

80.09 Head Teacher's Report

Governors discussed pupil's absence/attendance in great detail. A Cruickshank outlined the processes in place with regard to extended leave and advised that the school has adopted zero tolerance for requests in line with the Local Authority. A Cruickshank meets with parents who have requested extended leave to look at each case individually and to discuss any exceptional circumstances, however, if leave is taken and has not been authorised by the school then either a penalty notice will be issued to the parents or the child may be taken off the roll for the school. A Cruickshank also advised that there is a significant problem with many odd days being taken off sick by children. A Cruickshank will look at the child's attendance record, if there are any concerns then evidence of the child's illness will be needed. Education Welfare Officers are involved where needed and attendance meetings are conducted with parents.

Governors discussed the impact of penalty notices and how they can work but they also bring other issues such as children being cared for by older siblings in order to attend school whilst parents are abroad.

Free school meals could be a way to encourage children to stay in school as many go home for lunch and then do not return for the afternoon session. Free school meals are also used as an indicator by the Government and have an impact on funding for the school. A Cruickshank also advised that should a child be eligible for free school meals, then this could lead to further funding enabling the child to attend out of school hours activities.

Governors agreed it would be a useful exercise if the absence statistics were split into ethnic groups — this could be useful in targeting groups who have the highest absenteeism and help the school be proactive trying to

	encourage these groups into school and full attendance. A Cruickshank to talk to Robin Mitchell for breakdown of groups.	AC
