The Pledge

SUMMARY

1.1 The Pledge is a promise made by Derby City Council to all Derby City children in care and leaving care. The Pledge is part of Derby's commitment to give children in care and leaving care the best opportunities they can have in life. All adults who work for and with the Council will make a commitment to work to the Pledge at all times.

The Pledge was conceived by the Derby City Children in Care Council throughout 2012

- 1.2 The current Pledge needed to be refreshed. The current Pledge has 28 commitments. It was felt that these needed to be updated and be more aspirational
- 1.3 From June 15 August 15 the looked after children have been asked to highlight their top ten priorities, which will form the new Pledge.
- 1.4 It is planned that the updated Pledge will be launched and implemented early 2016

REASONS FOR RECOMMENDATION

- 3.1 There is an expectation for all local authorities to work with children and young people to develop a 'pledge' for the children in their care. The pledge is a statement about the support and services children in care can expect to receive
- 3.2 Care Matters (2006) identifies underpinning principles that Local Authorities must adhere to in complying with the basic statutory duties relating to Looked After Children. It places a responsibility on Local Authorities to ensure children in care have been consulted and involved in developing the pledge and the regular review of the 'pledge'
