#### **General notes**

The shortfall was secured through NRF funding, but this has been tapered over the past two years and 2009/10 will be the final year of NRF match funding for CGB.
- No inflationary rise between 2002/03 and 2003/04.
- In 2004 we started awarding 3 year funding agreements, in accordance with best practice guidance and Compact commitments.
- Between 2004/05 and 2005/06 only 3 year funded organisations received inflation, 1 year funded organisations did not receive an inflationary increase.
- Inflation not passed on for 2006/07.
- Inflation was given in 2007/08.
- Older and Disabled Peoples Grants (ODPG) programme for small grants was transferred from ASS to CGB in 2007. These small grants are not included in the above fist, which includes only mainstream CGB funded organisations.
- Inflation was given in 2008/09 and 2009/10.

## **Corporate and Adult Services Voluntary and Community Sector** Grant Funding for 2009/10

## SUMMARY

1.1 This report sets out Corporate and Adult Services grant funding, from the Community Grants Budget (CGB), Adult Social Services and joint funding with partner agencies, to be provided to voluntary and community sector organisations in 2009/10.

### RECOMMENDATION

- 2.1 To approve the proposed grant funding allocations for Corporate and Adult Services, set out in Appendix 2 of this report, subject to the final decision on the revenue budget made by Council.
- 2.2 To provide an inflationary increase of 2.5% across all Council grant funding.
- 2.3 To advertise new grant funding opportunities to meet the day support needs of older people from the Indian community and to address the other identified gaps in grant funded support.
- 2.4 To extend the Older and Disabled People's Groups programme for small grants, which aim to reduce social isolation and promote well-being.
- 2.5 To approve the changes to joint funding arrangements set out in this report.

## **REASON FOR RECOMMENDATIONS**

- 3.1 Voluntary and community sector grant funding plays a key role in supporting corporate priorities, strengthening communities and delivering preventative services to vulnerable people. Recommendations for changes to grant funding arrangements are based on the results of reviews, incorporating value for money considerations, strategic priorities and anticipated increases in demand for some grant funded services, as a consequence of the economic downturn.
- 3.2 The recommended inflationary increase has been considered carefully in consultation with NHS Derby City and takes into consideration affordability as well as recent and projected inflationary changes.

## SUPPORTING INFORMATION

1.1 This report sets out recommendations for Corporate and Adult Services grant funding, from the Community Grants Budget (CGB), Adult Social Services (ASS) and joint funding with partner agencies, to be provided to voluntary and community organisations in 2009/10.

### 1.2 **Derby Compact and principles of Voluntary and Community Sector funding**

The Council is committed to complying with the principles and commitments set out in the Compact and related Codes of Practice. In the case of multi-year funding agreements, the Council has undertaken to consult with voluntary sector organisations prior to any reduction in funding and also to provide a minimum of three months notice. The Council is also committed to taking a strategic approach to voluntary sector funding and to strengthening our joint commissioning arrangements with partner agencies, to ensure that voluntary sector funding is targeted as effectively as possible and delivers value for money for service users and communities.

- 1.3 A 2.5% inflationary increase is being recommended for all Council grant funding. For joint funding agreements where Derby City Council does not assume the lead responsibility for administering the funding, the inflationary increase is normally determined by the lead agency. The Council has been liaising with NHS Derby City with a view to awarding the same inflationary increase on grant funding. However, it is possible that some of the figures in Appendix 2 may need to be adjusted, once the inflationary increases of lead agencies have been confirmed.
- 1.4 In-depth reviews are undertaken with organisations in the final year of three year funding agreements. Each year, approximately one third of grant funded organisations undergo a final year review. These reviews have moved to a self-assessment model, providing an opportunity for funded organisations to assess their own performance. These reviews look at the governance and management of each organisation, the service provided under the funding agreement, the extent to which the intended outcomes have been achieved and how services meet strategic priorities. All services are also monitored on an ongoing basis and continued funding is dependent both on satisfactory outcomes from monitoring processes and on the outcomes of final year reviews.
- 1.5 The joint funding for Adult Social Services consists of commitments between Derby City Council and one or more partner agencies, principally NHS Derby City (Derby City Primary Care Trust). There are also some county-wide joint funding arrangements in place. All jointly funded services are subject to ongoing monitoring and a programme of final year reviews.

## OUTSTANDING ISSUES FROM 2008/09 CABINET REPORT

1.6 Funding agreements for the following organisations were extended for one year only in 2008/09, to provide an opportunity to renegotiate service specifications and / or to work with organisations to address specific issues identified during final year reviews.

**Alternatives Activity Centre** - we are satisfied that the organisation is delivering a quality service, which meets the needs of its client group and that they are committed to modernising and developing their services, in line with the Learning Disability Modernisation Programme. Renewed three year funding is therefore recommended.

**Padley Day Service** - detailed work has been undertaken with the organisation, in partnership with NHS Derby City and Housing Services. We are satisfied with the progress made and recommend renewed three year funding, under a joint funding arrangement, with NHS Derby City acting as the lead agency and with the continued involvement of Housing Services, as the lead commissioner for the Council on homelessness. There is a possibility of securing additional funding on a short term basis, through LPSA2 reward money.

**Ukrainian Day Service** and **Opieka** - in consultation with NHS Derby City, it has been agreed that the issues identified during the final year reviews are being satisfactorily progressed. Derby CVS has been providing support to the two organisations. Renewed three year funding is recommended for both organisations, but with the funding reallocated to provide a more equitable split across the two organisations and communities. Revised service specifications will be needed, to give clarity as to costs, services and value for money. Following discussions with NHS Derby City, it is also recommended that the Council acts as the lead agency for both these joint funding agreements from 2009/10.

1.7 **Day support, luncheon clubs and social groups -** funding for day support services, luncheon clubs and social groups in 2008/09 was conditional upon organisations working towards applying a reasonable minimum level of service user contributions of £2.50 per person per day for services providing a main meal, or £1 per person per day for drop-in services or social groups. In the case of CGB funded luncheon clubs and social groups, funding agreements were extended for one year only and the groups had the option of either raising service user contributions or increasing their income from other sources, to move them towards sustainability. A resource pack was made available and training was offered to CGB funded luncheon clubs and social groups. This training was delivered in partnership with Derby CVS.

## OLDER AND DISABLED PEOPLE'S GROUPS GRANTS

1.8 The Older and Disabled People's Groups funding programme assists with revenue costs associated with providing activities and services for older or disabled people, with low level social care needs. The primary purpose of these small grants is to support voluntary and community groups, by assisting them to provide early intervention services, which reduce social isolation, promote well-being and prevent or delay the need for higher level social care interventions.

For several years, the budget for this grant funding programme has remained static, at £8,000 per annum. These grants provide excellent value for money, where a combination of Council grant funding, service user contributions and fundraising activities enables the groups to be sustainable. There is no difference between the type of support provided by CGB funded luncheon clubs and social groups and the support offered by organisations funded through the Older and Disabled People's Groups programme.

It is recommended that the Older and Disabled People's Groups programme is extended in 2009/10, increasing the maximum grant payable from £500 to £4,000 per annum and the overall budget from £8,000 to £50,000. It is also recommended that grants should be awarded for a three year term, instead of the current annual awards. This is in accordance with the Compact commitment to move to three year grant funding arrangements as standard. These small grants will continue to be subject to a lighter touch monitoring process, appropriate to the level of funding.

Voluntary organisations which have previously received CGB funding for luncheon clubs and social groups will be eligible to apply to this expanded Older and Disabled People's Groups programme. With the increased service user contributions, the maximum grant payable should be sufficient to make these groups sustainable. The criteria will be reviewed and grants will be awarded on the basis of quality and value for money.

It is recommended that the existing small CGB grant to Derbyshire Community Foundation, an independent body which administers grant funding, should be used to support the administration of the Older and Disabled People's Groups programme. This will provide independent input and expertise on the Appraisal Panel for these small grants - see also 1.17, below.

### **RECOMMENDATIONS FOLLOWING FINAL YEAR REVIEWS**

- 1.9 Final year reviews were undertaken with 17 organisations during 2008/9. These organisations are listed below, together with a brief summary of each of the recommendations from the reviews.
- 1.10 **Age Concern Derby and Derbyshire** CGB and ASS funding to be rolled into one three year funding agreement, with two service specifications. The advocacy service specification will need to be revised. NHS Derby City has been approached with a view to securing match funding.
- 1.11 **Derbyshire Advocacy Service** funding from DCC and NHS Derby City to be rolled into one funding agreement to simplify administration, with DCC acting as the lead commissioner.
- 1.12 **Derbyshire Carers Association** funding from DCC and NHS Derby City to be rolled into one funding agreement, with separate service specifications, containing greater clarity as to roles and funded posts.
- 1.13 **Headway** following discussions with NHS Derby City, it is recommended that the joint funding with health and the separate NHS Derby City funding for the BME project is rolled into one agreement, with NHS Derby City acting as the lead agency.
- 1.14 **MHA Care Live at Home Project** there is a lack of co-ordination between the various schemes in the city and a lack of consistency concerning service user contributions. The targeting of services and resources across the city as well as the staffing structure needs further discussion and negotiation. The recommendation is to roll over the funding for one year, pending these negotiations. Following discussions with NHS Derby City, it is also recommended that the Council takes over as the lead agency and paying body.
- 1.15 **Business in the Community -** recommendation to renew funding for a further 3 year period.
- 1.16 **Derby Community Accountancy Service** this service provides good value for money and is recommended for a further three year term.

- 1.17 **Derbyshire Community Foundation** at present, this small grant is a notional contribution to the Chief Executive's salary. It is proposed that the purpose of the funding is redefined to provide administrative support for the Older and Disabled People's Groups funding programme (see 1.8, above). The organisation is amenable to this proposal, which would give DCC a tangible outcome for the funding and would help to align the Older and Disabled People's Groups programme with other small grant funding programmes across the city, particularly the Grassroots Grants programme, ensuring that they complement each other, rather than duplicate.
- 1.18 **Asian Advisory Service -** renewed three year funding is recommended, with a revised funding agreement focused on supporting people from new and emerging communities, promoting community cohesion and citizenship and meeting language needs.
- 1.19 **Disability Direct** it is recommended that CGB, ASS and joint funding with NHS Derby City are rolled into one three year funding agreement, with separate service specifications and with the Council acting as the lead agency and paying body. Funding for advice is to be focussed on disability casework and Disability Discrimination Act advice on goods and services. A referral protocol with the Community Legal Advice Centre (CLAC) will need to be implemented.
- 1.20 **SUPORT -** this Sinfin based organisation has been operating as a social enterprise for many years and has the potential to generate more of its own income. A three year agreement is recommended, but this is conditional upon an income generation plan being produced in the first half of 2009/10, setting out how the organisation will move towards a position where it is less dependent on grant funding by the end of the three year term. The objective is to free up resources in future years to reinvest in other social enterprise activity elsewhere in the city.
- 1.21 West Indian Credit Union the common bond for the credit union is membership of the West Indian Community Association (WICA). This creates a barrier for new members who either cannot afford, or do not wish, to join WICA. The organisation itself has been considering whether to widen its common bond. The current recession is likely to increase the need for this service. However, it will only be justifiable to continue supporting the organisation financially if it changes its common bond to make it more accessible to the wider community. Renewed three year funding is recommended, but this is conditional upon the organisation widening its common bond during year 1 of the funding agreement, as a minimum to include all Normanton residents, or alternatively to make it city-wide. The organisation will be encouraged to approach the more recently established city wide credit union, with a view to reaching agreement as to how their services can best support the needs of the community.
- 1.22 West Indian Community Association renewed three year funding is recommended, with a revised service specification and new output and outcome measures.

- 1.23 **Chinese Welfare Association -** the Chinese community is widely dispersed across the city and members of the community use the organisation as a central hub. The final year review process identified needs which are largely invisible to statutory services. First generation members of the community, who have language barriers, can be particularly isolated and excluded from mainstream services. Continued three year funding is recommended, aimed at reducing social isolation and removing barriers to accessing services. The organisation will be encouraged to apply for an Older and Disabled People's Groups grant, to help reduce social isolation amongst older members of the Chinese community.
- 1.24 **Derwent Social Club** this is a very small grant of £1,344, for a group of people with learning disabilities. The group would meet the criteria for the Older and Disabled People's Groups programme. It is recommended that the CGB funding is not renewed, but that the group is invited to apply to the Older and Disabled People's Groups programme, which is subject to a lighter touch monitoring process.
- 1.25 **Relate** renewed three year funding is recommended, but subject to increasing access to the service by people from minority ethnic communities. The organisation also needs to be proactive in publicising the fact that it is not just for married, heterosexual couples, but for all members of the community. Expectations concerning contributions / fees need to be explained at the outset and the availability of its bursary scheme needs to be published.
- 1.26 **Derby CVS** renewed three year funding is recommended, but rolling the CGB, ASS and joint funding agreement with NHS Derby City into one, to simplify administration, with separate service specifications where needed. It is recommended that the Council, as the larger contributor, takes on the role of the lead agency. Work will need to be undertaken to develop improved outcome measures, to ensure that the impact of services is fully captured.
- 1.27 **Derby Millennium Network** it is recommended that the funding agreement with DMN is rolled over for one year, to allow time to undertake a detailed review of the organisation and its services, in partnership with NHS Derby City.

## NEW GRANT FUNDING OPPORTUNITIES – ADULT SOCIAL SERVICES

### 1.28 Indian Community Day Support

A consultation exercise is being undertaken in partnership with Derby Racial Equality Council to identify the day support needs of older people from the Indian community, in the context of developing a more person-centred approach to older people's services. It is recommended that a sum of £60,000 is set aside in the 2009/10 budget to address the needs of older people with a low to moderate level of risk to their independence. A service specification will be drawn up, based on the findings from the consultation exercise and a new funding opportunity will be advertised, to commence as early as possible in the 2009/10 financial year. Funding applications will initially be appraised by Council officers. It is recommended that the final decision as to the chosen service provider is delegated to the Cabinet Member.

### 1.29 Carers' services and dementia services

**Carers Grant Funding** - although it is no longer ring-fenced, the Carers Grant is still targeted on carers support. A panel meets to make recommendations on Carers Grant funding for holiday grants and a range of other breaks and services for carers.

Alzheimers Disease Society – funding for carers' breaks is currently paid to this organisation, which in turn purchases the service from Crossroads. Following discussions with both organisations, it is recommended that this funding should be paid directly to Crossroads.

It has been identified that there are currently insufficient resources to support carers and people with dementia. It is therefore recommended that a sum of  $\pounds 20,000$  is set aside in the 2009/10 budget as part of a wider strategy to help address these needs.

### **GRANT FUNDING PRIORITIES – CGB**

- 1.30 In the 2008/9 Cabinet Report, two priorities for new CGB grant funding were identified, where CGB funding needs to do more to address inequality and discrimination. It is therefore recommended that a sum of £20,000 is set aside in the 2009/10 budget to begin to target the following identified gaps in provision, at 1.31 and 1.32.
- 1.31 **New and emerging communities** there is at present very little grant funding available to target the support needs of emerging and smaller ethnic minority communities in Derby. It is recommended that the recent 'Derby Population Migration and Community Profile', produced by the Community Safety Partnership, is used as a starting point to prioritise these needs. The Community Safety Partnership will be asked to assist with the appraisal of new grant funding applications, to ensure a joined up approach, aimed at promoting community cohesion, social inclusion and improving access to mainstream services. Equalities monitoring for grant funded services will also be improved, to provide more accurate data as to how emerging communities are currently being supported through existing grant funding arrangements.
- 1.32 **Lesbian, Gay, Bisexual and Transgender communities** there is currently no designated funding to address support needs and tackle discrimination for people who are Lesbian, Gay, Bisexual or Transgender. It is therefore recommended that projects aimed at addressing these needs are invited to apply for funding during 2009/10. Improvements to equalities monitoring should also help to identify how grant funded services are currently supporting LGB&T people. Work will be undertaken during 2009/10 to identify the needs of LGB&T people and a dialogue will be needed with partner agencies and LGB&T groups to help inform future commissioning intentions.

### OTHER CHANGES TO JOINT FUNDING ARRANGEMENTS

1.33 **Derbyshire MIND Rosehill Club** - a new day service for people with mental health problems is currently being commissioned and should commence during 2009/10. The service is being procured through a competitive tendering process and Derbyshire MIND has the opportunity to bid for increased funding to deliver a modernised day service under a contractual arrangement. It will be important to ensure a smooth transition to the new service. A minimum of three months formal notice will be needed to bring the current joint funding agreement for the Rosehill Club to an end. This does not affect the grant funding for MIND's advocacy service.

**Derbyshire MIND Advocacy Service** - it is recommended that the funding agreement for the advocacy service is rolled over for one year, pending detailed negotiations aimed at ensuring value for money.

1.34 **Derbyshire Association for the Blind** - it is recommended that the ASS grant funding agreements with Derbyshire Association for the Blind and the joint funding with NHS Derby City are rolled into one, with the Council taking on the role of lead agency and paying body. This has been discussed with NHS Derby City.

### IMPLICATIONS

### Financial

- 1.1 The full cost of the services listed in Appendix 2 can be met within the grant funding budgets for Corporate and Adult Services, subject to the final decision on the revenue budget made by Council and the availability of £24,839 transitional Neighbourhood Renewal Fund (NRF) money. Transitional NRF monies are being made available as match funding for the Community Grants Budget (CGB) on a tapered basis: 75% of the original allocation was provided in 2008/9, 30% will be available in 2009/10 and nil in 2010/11.
- 1.2 It is possible that a few very minor cost pressures may arise for jointly funded services, where partner organisations act as the lead agency, in the unlikely event that they award a different inflationary increase, following dialogue and awareness of our intentions.
- 1.3 Payment of the approved funding will be subject to compliance with Funding Agreements.

### Legal

- 2.1 Powers to provide funding in the above circumstances are granted under the National Assistance Act 1948, the Health Services and Public Health Act 1968 and the National Health Services Act 1977.
- 2.2 Each organisation receiving a grant will be required to enter into a Funding Agreement with the Council.

### Personnel

3. There are no personnel implications for the Council. However, there may be some personnel issues in the Voluntary and Community Sector, arising from changes to grant funding allocations and service specifications for some grant funded services.

### **Equalities impact**

- 4.1 The services and activities of the organisations named in this report support all communities, in particular people from minority ethnic communities, adults with physical disabilities and sensory impairment, older people, people with learning disabilities and people with mental health problems.
- 4.2 The Equality Impact Assessment undertaken last year is being reviewed. All the recommended actions have either been completed, or are being progressed. The recommendations for increased grant funding in this report aim to address identified gaps in provision, to target specific areas of inequality and disadvantage.

- 4.3 Grant funding aims to support all strands of equality and all communities and groups in Derby. All funded organisations are required to implement equal opportunities policies. Monitoring forms have been revised during 2008/9 to give more accurate equalities information, to identify whether funded organisations are reaching all sections of the community, under each of the equality 'strands' age, disability, race, faith, gender, sexual orientation and language. This includes capturing data as to how funded services are being accessed by recent arrivals from BME, refugee / asylum seeker and migrant worker communities.
- 4.4 Funded organisations will be consulted on these new monitoring forms with a view to implementing them during 2009/10. A flexible, proportionate approach will be needed, reflecting the size of organisations and the levels of funding involved.

### Corporate objectives and priorities for change

5. This accords with the Council's objectives of promoting strong and positive communities and protecting and supporting people.

## **Corporate and Adult Services Voluntary and Community Sector Grant Funding for 2008/9**

## SUMMARY

- 1.1 This report sets out Corporate and Adult Services grant funding, from the Community Grants Budget, Adult Social Services and joint funding with partner agencies, to be provided to Voluntary and Community Sector organisations in 2008/2009.
- 1.2 Subject to any issues raised at the meeting, I support the following recommendation.

### RECOMMENDATION

- 2.1 To approve the proposed grant funding allocations for Corporate and Adult Services, set out in Appendix 2 of the report, subject to the final decision on the revenue budget made by Council.
- 2.2 To approve the transitional arrangements arising from the loss of Neighbourhood Renewal Fund NRF monies, identified in the main body of this report.
- 2.3 To approve the recommendation to work with Indian voluntary & Community Sector organisations and the Indian community to identify day service needs.
- 2.4 To note the other identified priorities for future funding from the Community Grants Budget CGB.

## REASON FOR RECOMMENDATIONS

3.1 An inflationary increase of 2% is being recommended for all Council grant funding. Voluntary and Community Sector grant funding continues to play a key role in supporting corporate priorities, strengthening communities and delivering preventative services to vulnerable people. Despite budgetary pressures faced by the Council, cost savings have therefore been kept to a minimum. Recommendations for changes to levels of grant funding are based on the results of in depth reviews, which considered both value for money and strategic priorities. In future, these reviews will move to a self-assessment model, to provide an opportunity for funded organisations to assess their own performance.

- 3.2 Transitional NRF monies will be made available on a tapered basis, 75% in 2008/9, 30% in 2009/10 and nil in 2010/11. The transitional arrangements detailed in this report will, where appropriate, allow organisations sufficient time to seek alternative sources of income, or identify other means of sustaining their activities.
- 3.3 There is a lack of culturally appropriate provision for older people from the Indian Community with a low to moderate risk of losing their independence. There are a number of lower level luncheon club services for the Indian community, but there is currently no provision for higher level needs.
- 3.4 An Equality Impact Assessment revealed specific areas where the Community Grants Budget programme is currently not providing funds to address inequality and discrimination. These gaps in provision will need to be addressed as and when opportunities arise to reinvest in new priorities.

## **Corporate and Adult Services Voluntary and Community Sector Grant Funding for 2008/9**

## SUPPORTING INFORMATION

- 1.1 This report sets out the recommendations for Corporate and Adult Services grant funding, from the Community Grants Budget, Adult Social Services and joint funding with partner agencies, to be provided to Voluntary and Community Sector organisations in 2008/09.
- 1.2 Corporate and Adult Services grant funding is normally subject to three year Funding Agreements. Following consultation with the Voluntary and Community Sector, a new process has been introduced, whereby in-depth reviews are undertaken with organisations in the final year of their Funding Agreements. These reviews look at the governance and management of each organisation, the service provided under the funding agreement, the extent to which the intended outcomes have been achieved and how services meet strategic priorities. All services are monitored and reviewed on an ongoing basis and continued funding is therefore dependent on satisfactory outcomes from monitoring processes, as well as on the outcomes of final year reviews.
- 1.3 The joint funding for Adult Social Services consists of commitments between Derby City Council and one or more partner agencies, including Derby City Primary Care Trust, Derbyshire County Primary Care Trust and Derbyshire County Council. The majority of these funding arrangements were first supported through the Joint Finance programme with Southern Derbyshire Health Authority. All jointly funded services are subject to ongoing monitoring and a programme of final year reviews. For some of these joint funding agreements, Derby City Council and Derby City PCT have agreed to enter into city wide, rather than county wide funding arrangements from 1 April 2008 (see Appendix 2 for details).
- 1.4 A 2% inflationary increase is being recommended for all Council grant funding. For joint funding agreements where Derby City Council does not assume the lead responsibility for administering the funding, the inflationary increase is determined by the lead agency. The Council has been liaising with Derby City Primary Care Trust with a view to awarding the same inflationary increase on grant funding. However, it is possible that some of the figures in Appendix 2 may need to be adjusted, once the inflationary increases of lead agencies have been determined.

### 1.5 **Compact and principles of Voluntary and Community Sector funding**

The Council is committed to complying with the principles and undertakings set out in the Compact and related Codes of Practice. In the case of multi-year funding agreements, the Council has undertaken to consult with Voluntary Sector Organisations prior to any reduction in funding and also to provide a minimum of 3 months notice. The Council is also committed to taking a strategic approach to Voluntary Sector funding and to strengthening our joint commissioning arrangements with partner agencies, to ensure that Voluntary Sector funding is targeted as effectively as possible and delivers Best Value for service users.

### 1.6 CGB review

A review was undertaken of CGB processes and the Voluntary and Community Sector was consulted about proposed changes over a twelve week period. The resulting changes to CGB processes were approved by Chief Officer Group on 5 September 2007. One of the aims of the review was to ensure that the Council's administrative processes were as efficient, effective and transparent as possible, whilst also supporting an appropriate balance between maintaining the sustainability of the sector and providing scope for meeting the changing needs and priorities of our communities.

An Equality Impact Assessment and an analysis of the funding for luncheon club provision formed part of this review. One of the changes to processes was the introduction of more in-depth reviews, to be undertaken in the final year of three year funding agreements. Final year reviews have been undertaken with approximately one third of CGB funded organisations. In future, these reviews will move to a selfassessment model, to provide funded organisations with the opportunity to assess their own performance.

## 1.7 Equality Impact Assessment and priorities for new CGB funding

CGB funding aims to support all six strands of equality through the requirement for all funded organisations to implement Equal Opportunities Policies. Most CGB funded organisations support people from all communities and groups in Derby. However, the Equality Impact Assessment revealed two main areas where the CGB programme is currently failing to address inequality and discrimination.

There is currently some CGB funding aimed at addressing issues of inequality, social exclusion and discrimination for settled BME communities, disabled people, older people and women. However, it is evident that the needs of new and emerging communities in Derby are not currently being adequately addressed through the CGB programme. The Equality Impact Assessment identified that the CGB programme also needs to promote the implementation of recent anti-discrimination legislation with respect to Lesbian, Gay, Bisexual and Transgender (LGB&T) communities.

- Emergent Communities the Council needs to do more to support the developing voluntary and community sector within emerging communities. Equal opportunities monitoring also needs to be improved to capture how currently funded services are being accessed by recent arrivals from BME, refugee / asylum seeker and migrant worker communities.
- LGB&T Communities there is at present no CGB funding which specifically addresses Lesbian, Gay, Bisexual and Transgender issues. There is little evidence of support to these communities through existing CGB funded organisations, as data on sexual orientation is not currently captured systematically. Where appropriate, equal opportunities monitoring needs to capture how currently funded services are being accessed by LGB&T communities.

As and when opportunities arise and funds can be reinvested in new priorities, the specific needs of new and emerging BME communities, and of LGB&T communities, should be addressed. This would assist in reducing inequality, tackling discrimination and promoting social integration for these communities.

## **RECOMMENDATIONS FOR CHANGES TO GRANT FUNDING ALLOCATIONS**

1.8 Following final year reviews, a number of changes to current grant funding allocations are being recommended. This takes into consideration both value for money and changing priorities and patterns of need.

### 1.9 Reviews of CGB funded luncheon clubs and similar services

The reviews of luncheon clubs and similar services identified whether minimum standards and terms and conditions of funding were being met, whether services were delivering value for money and whether they were achieving the desired outcomes of reducing social isolation, strengthening communities and promoting independence and well being. The focus should not be on providing a meal as such, but on the desired outcomes for older people and for communities. The pattern and level of funding for these services has been largely historical and there is currently duplication and fragmentation of services.

There are comparable services in the city, which are sustainable without reliance on Council grant funding. Owing to the loss of transitional NRF funding, cost savings will need to be identified from CGB in 2008/9, 2009/10 and 2010/11. It is therefore recommended that all CGB funding agreements for luncheon clubs, social groups and drop-in services are extended for 1 year only, to allow these groups sufficient time to increase their income from other sources, in particular, by applying a reasonable minimum level of service user contributions. To assist in making these groups sustainable, a resource pack has been produced and the Council will liaise with Derby CVS and Derby Millennium Network regarding the support they can give to assist groups to make their services sustainable, without future reliance on Council grant funding.

A standard service specification will be drawn up for CGB funded luncheon clubs and drop-in services and progress will be monitored against the findings from the recent reviews. Payments will only made for the second half of 2008/9 subject to progress on minimum standards and conditions contained within the service specification. Some shortfalls have already been identified through the recent review process with organisations.

1.10 **Ukrainian Day Centre and Opieka** - the Ukrainian Day Centre is not in reality a day care service, but a luncheon club, which is significantly over-funded in comparison with other similar services. The reviews for both these organisations identified a number of similar issues, including concerns regarding the employment of staff, which will need to be addressed as a condition of future funding.

There are close links between these two organisations and the communities they serve. Opieka receives joint funding for a befriending service for both the Polish and Ukrainian communities. Both organisations receive CGB funding for luncheon clubs. All funding agreements for these organisations will need to be extended for one year only, to give the Council and the PCT time to discuss with these organisations how best to support the future needs of these communities.

- 1.11 **Derby Racial Equality Council** there is no longer a requirement for employment casework to be provided by this organisation, since this work will be delivered under contract by the Community Legal Advice Centre. Funding therefore needs to be refocused on new priorities, including a contribution towards the Racial Harassment Officer post. A revised service specification will need to be developed. There is also a particularly high level of funding provided to this organisation for back office functions, such as administration. The recommendation is therefore to reduce the overall level of funding and to refocus more of the available funding on front line services. Funding will need to continue at the current level for the first six months of 2008/9, to assist the organisation to manage this transition. The second six monthly payment will be reduced by £7,000 and the subsequent full year effect of this reduction will be £14,000 per annum.
- 1.12 **Derbyshire Association for the Blind** the CGB funding was previously for a personal assistant to the former Chief Executive, who was visually impaired. However, since the current Chief Executive is not visually impaired, there is insufficient justification for continuing to provide this funding through CGB. Six months notice will be given before this funding is withdrawn. Other grant funding from Adult Social Services for Derbyshire Association for the Blind will continue.
- 1.13 **Derby Community Transport Social Car Scheme** this scheme is no longer operating therefore notice has already been served that the funding for this service will come to an end on 31 March 2008. The organisation receives substantial alternative funding from the Council.
- 1.14 **Alternatives Activity Centre** a relatively small proportion of match funding for the Employment Scheme was awarded from CGB. The project was mostly funded through the European Social Fund and the Learning and Skills Council. This external funding will come to an end on 31 March 2008, therefore the organisation has been notified that the match funding from CGB will also end on 31 March. The organisation is currently awaiting the outcome of a bid for replacement funding for the Employment Scheme.

It is recommended that the Adult Social Services funding for the day service continues, although the service specification will need to be refocused, as the service needs to be more closely aligned with the modernisation of Learning Disability services. It is therefore recommended that the existing service specification is renegotiated for the 2008/9 financial year.

If, during this period, the service provided by Alternatives Activity Centre does not effectively complement in-house services and deliver against Valuing People priorities, a new service would need to be procured under a competitive tendering process, to deliver a service under contract. Alternatives Activity Centre would still have the opportunity to bid for the contract and would need to be provided with adequate notice to bring the current grant funding agreement to an end. However, the current recommendation is that the Adult Social Services funding agreement is extended for one year, with a revised service specification. 1.15 **Padley Group -** a review of the Padley Day Service for homeless people was undertaken jointly with Derby City Primary Care Trust, which funds the service under a separate funding agreement. This review identified a number of concerns regarding the operation and management of the service. Padley is currently involved in discussions with partner agencies concerning the future of this service and how it could complement the new Milestone House assessment centre. It is recommended that the funding for the Day Service is extended for one year, pending the outcome of these discussions and to enable a joint decision to be taken with the PCT.

The Development Centre services are completely separate from the Day Centre and provide therapeutic activities for people with learning disabilities. It is recommended that this funding should be renewed for a further three year period, under a revised service specification. However, there has also been additional funding for a woodwork project for people with physical disabilities, which is due to end on 31 March 2008. The intention was that this service would become self-sustaining, but additional time is needed for the organisation to identify an alternative means of continuing this project. It is therefore recommended that the funding for the woodwork project is extended for a further six month period, from 1 April 2008 to 30 September 2008.

1.16 **Sahahra -** the review of this service concluded that Sahahra is currently only able to offer its service to a relatively small number of older people from the Pakistani community. The service is suitable for older people who have been assessed as having a low to moderate risk of losing their independence. In order for the service to potentially reach more people and target its resources as effectively as possible, it is recommended that service user contributions should be increased so that they are comparable with other similar services. Assessment processes need to ensure that services are targeted where they are most needed.

### 1.17 Hadhari

A contract with Hadhari for a Supported Luncheon Club expired during the course of 2007/8 and a grant funding agreement was established for the remainder of the financial year. The service is comparable to the day service provided by Sahahra and is therefore more appropriately funded by means of a grant, rather than a contract. The service aims to meet the needs of older people from the African Caribbean community who have a low to moderate risk of losing their independence. A new service specification has been agreed and the recommendation is to fund this service on a standard three year funding agreement.

### 1.18 Indian Community Day Services

There is currently no service for the Indian community comparable to the above day services for the Pakistani community (Sahahra) and the African Caribbean community (Hadhari). There are numerous low level luncheon club services for the Indian community, but nothing for older people who are at a higher level of risk of losing their independence. Within the Indian community, care is often provided in extended families, therefore a service is needed which provides respite for carers, as well as supporting older people to maintain their independence. It is therefore recommended that officers work with Indian VCS organisations and the Indian community to identify the low to moderate day service needs of the community during the year. Following this, a service specification is drawn up and funding opportunities identified.

- 1.19 **MIND Rosehill Club** Derby City Primary Care Trust is the lead agency for this funding agreement and a new service specification has been developed for modernised day services for people with mental health problems, with a view to procuring a new service during 2008/9, to commence in 2009/10. It is intended that the service will be procured through a competitive tendering process and Derbyshire MIND will have the opportunity to bid for increased funding to deliver a modernised day service under contract. A minimum of three months formal notice would be needed to end the current grant funding agreement for the Rosehill Club. This does not affect the grant funding for the advocacy service.
- 1.20 **Carers Grant Funding** funding allocated to the Voluntary and Community Sector from the Carers Grant has not previously been included in Cabinet Reports on grant funding, since this was a separate, ring-fenced allocation from Central Government. However, the Carers Grant is no longer ring-fenced, therefore the decision-making process is now being brought into line with other Adult Social Services grant funding, to ensure a consistent approach. Although it is no longer ring-fenced, the Carers Grant is still targeted and in 2008/9 will form part of the Local Area Agreement.

A panel meets to make recommendations on Carers Grant funding for holiday grants and a range of other breaks and services for carers. There is one recommendation for a change to the current allocations, which are listed separately in Appendix 2. The change relates to a new service to be provided by Derbyshire Carers Association as part of Derby's New Deal for Carers Emergency Scheme for Unpaid Carers. Funding for this scheme became available as part of the Carers Grant with effect from 1<sup>st</sup> October 2007. The additional funding for Derbyshire Carers Association will ensure the provision of an emergency planning, information, signposting and support service for carers and will provide a key element of the new scheme for Derby.

## IMPLICATIONS

## Financial

- 1.1 The full cost of the services listed in Appendix 2 can be met within the grant funding budgets for Corporate and Adult Services, subject to the availability of 75% of the 2007/8 NRF allocation and to the final decision on the revenue budget made by Council. However, some minor cost pressure may arise for jointly funded services, where partner organisations act as the lead agency, in the unlikely event that they award a different inflationary increase following dialogue with DCC and awareness of our intentions.
- 1.2 Payment of the approved funding will be subject to compliance with Funding Agreements.

### Legal

- 2.1 Powers to provide funding in the above circumstances are granted under the National Assistance Act 1948, the Health Services and Public Health Act 1968 and the National Health Services Act 1977.
- 2.2 Each organisation receiving a grant will be required to enter into a Funding Agreement with the Council.

#### Personnel

3. There are no personnel implications for the Council. However, there may be some personnel issues in the Voluntary and Community Sector, arising from changes to grant funding allocations and service specifications for some grant funded services.

### **Equalities impact**

4. The services and activities of the organisations named in this report support all communities, in particular people from BME communities, adults with physical disabilities and sensory impairment, older people, people with learning disabilities and people with mental health problems.

### Corporate objectives and priorities for change

5. This accords with the Council's objective of promoting strong and positive communities and protecting and supporting people.

# Community Grants Budget Voluntary and Community Sector Grant Funding for 2007/8

#### SUMMARY

- 1.1 This report sets out Community Grants Budget grant funding to be provided to Voluntary and Community Sector organisations in 2007/2008.
- 1.2 Subject to any issues raised at the meeting, I support the following recommendation.

#### RECOMMENDATION

- 2.1 To approve the proposed grant funding for the Community Grants Budget (CGB), set out in Appendix 2 of the report subject to the final decision on the revenue budget made by Council.
- 2.2 To approve a review of the CGB application and decision making process, to ensure maximum efficiency, effectiveness and transparency and to balance the need for sustainability with the need to meet strategic priorities. An analysis of the funding for luncheon club provision will need to form part of this review. Owing to the difficult financial position faced by the Council, further savings of at least £10,000 will need to be found during the course of 2007/8. This will be the subject of a subsequent report.
- 2.3 To approve the transfer of grant funding for Derwent Stepping Stones from the Community Grants Budget to Children and Young People's Services.
- 2.4 To confirm that, since Asian Over 60's has not met some of the key requirements of the Community Legal Service Quality Mark Standard following a recent audit, 6 month's notice will be given to the organisation to provide them with a final opportunity to comply with the standard and to implement improvements to financial procedures. If, after this time, these conditions of funding have still not been met, the grant funding for the advice service will come to an end.

#### REASON FOR RECOMMENDATION

3.1 An inflationary increase of 2.5% is being recommended for all Council Voluntary Sector grant funding for 2007/8. This inflationary increase is necessary to ensure that services do not become unsustainable.

- 3.2 The Council restructuring and the mid-year decision to relocate the Community Grants Budget within Corporate and Adult Social Services, left insufficient time for the usual CGB application process. The recommendations contained in this report are therefore based on the results of monitoring and review processes, rather than an application process.
- 3.3 The recommendation to transfer the grant funding for Derwent Stepping Stones to Children and Young People's Services is to ensure that this funding agreement is managed within the most appropriate department.
- 3.4 Asian Over 60's is the only grant funded advice service which did not achieve the full Community Legal Service Quality Mark. The organisation was very late in securing a provisional Quality Mark, therefore its implementation of the standard was never audited by the Legal Services Commission. It is an established Council policy that meeting the Quality Mark Standard is a condition of grant funding for all organisations providing advice services and the organisation has had over 2 years since the provisional Quality Mark in which to implement the requirements. A six month notice period will provide the organisation with a final opportunity to comply with the Quality Mark Standard and other conditions of funding.

# Community Grants Budget Voluntary and Community Sector Funding for 2007/8

#### SUPPORTING INFORMATION

- 1.1 This report sets out the recommendations for Community Grants Budget funding to be provided to Voluntary and Community Sector organisations in 2007/8.
- 1.2 The mid-year decision to transfer the management of the Community Grants Budget to Corporate and Adult Social Services left insufficient time to undertake the lengthy application and appraisal process. The recommendations for continued Community Grants Budget funding for 2007/8 are therefore based on the results of monitoring and review processes, rather than the usual application process. It is therefore recommended that, subject to satisfactory monitoring and review, the grants listed at Appendix 2 should be rolled over to the 2007/8 financial year, pending a review of the Community Grants Budget process (see 1.5, below).
- 1.3 An inflationary increase of 2.5% is being recommended for all Council Voluntary Sector grant funding for 2007/8. Owing to the significant budgetary pressures faced by the Council, inflationary increases were not provided for the previous financial year. However, this exacerbated existing cost pressures within the Voluntary Sector. An inflationary increase for 2007/8 is necessary, both to avoid unacceptable risk to the sustainability of services and in order to comply with the spirit and letter of the Council's Compact with the Voluntary Sector.

#### 1.4 Compact and principles of Voluntary Sector funding

The Council is committed to complying with the principles and undertakings set out in the Compact and related Codes of Practice. In the case of multi-year funding agreements, the Council has undertaken to consult with Voluntary Sector Organisations prior to any reduction in funding and also to provide a minimum of 3 months notice. The Council is also committed to taking a strategic approach to grant funding, to ensure that Voluntary Sector funding is targeted as effectively as possible and delivers Best Value for service users.

#### 1.5 CGB review and the need to make cost savings

One of the aims of the proposed review of the CGB process is to ensure that the Council's administrative processes are as efficient, effective and transparent as possible, whilst also supporting an appropriate balance between maintaining the sustainability of the sector and providing scope for meeting the changing needs and priorities of our communities. An analysis of the current funding for luncheon club provision will need to form part of this review. Owing to the budgetary pressures faced by the Council, it will also be necessary to identify at least a further £10,000 in cost savings to be made during 2007/8, as part of this review.

#### 1.6 Community Legal Advice Centre

The Council has been in discussion with the Legal Services Commission concerning the development of a Community Legal Advice Centre (CLAC) in Derby. It has been proposed that the some of the existing Community Grants Budget funding for advice services should form part of the financial envelope for the CLAC. The Council is currently in the process of consulting organisations concerning the implications of the CLAC proposals. The final recommendation concerning the CLAC and CGB funding for advice organisations will be included in a later Cabinet Report, once the consultation with advice providers has been concluded.

#### 1.7 Derwent Stepping Stones

For some years, this grant funding has been managed through the Community Grants Budget. However, it is recognised that Derwent Stepping Stones provides a key service for children and families in the Derwent area, forming part of the Children's Centre and being located in the Area 1 pilot for Integrated Children's Services. It is therefore recommended that this grant funding should transfer to Children and Young People's Services, to ensure that it is managed by the department with the relevant strategic responsibility for children's services.

#### 1.8 Asian Over 60's

There has been a long history of financial and service delivery concerns with this organisation. Over recent months, there have been a number of meetings and discussions involving Councillors, Senior Officers and the organisation itself, in an attempt to resolve these concerns. An audit has been undertaken to look at the financial management of the organisation, the luncheon club provision and drop in services and, in particular, whether the advice service meets the required Quality Mark Standard. Whilst some improvements are being made to the financial management and governance of the organisation, the findings from this review confirmed that the organisation is not meeting some of the key Quality Mark requirements. It is Council policy that funding for all advice services is dependent upon compliance with this standard, therefore 6 months notice will be given to allow the organisation a final opportunity to comply with the Quality Mark Standard and to meet other conditions of funding.

#### 1.9 **Emergent Communities**

Recent discussions with representatives of emergent communities in Derby have been held, jointly with the Community Safety Partnership, to consider both community cohesion issues and how the Council can better support the developing voluntary and community sector within emerging communities. The results were reported back to the Minority Ethnic Communities Equalities Forum (formerly MECAC) on 16<sup>th</sup> November. It is proposed to bring these considerations into the review of the CGB grants application and decision making process, to ensure that grants are effectively targeted and used to support all parts of Derby's communities.

2. None.

#### IMPLICATIONS

#### Financial

- 1.1 The total cost of the grant funding recommendations listed at Appendix 2 can be met within the Community Grants Budget allocation for 2007/8, subject to:
  - the final setting of the Council's budget in March 2007
  - the continued availability of NRF funding to meet 50% of the costs of grants which transferred from the former Social Services Department, as per the 17 January 2006 Cabinet Reports.
  - identifying cost savings of at least £10,000 to be made during the course of 2007/8. This will be the subject of a subsequent Cabinet Report.
- 1.2 Payment of the approved funding will be subject to compliance with Funding Agreements.

#### Legal

- 2.1 Powers to provide funding in the above circumstances are granted under the Children Act 1989, the National Assistance Act 1948, the Health Services and Public Health Act 1968 and the National Health Services Act 1977.
- 2.2 Each organisation receiving assistance will be required to enter into a Funding Agreement with the Council.

#### Personnel

3. The Voluntary Sector Team will be considering how best to manage Corporate and Adult Social Services grant funding, along with its lead responsibility for the development of Voluntary Sector policy and strategy, within existing staffing levels.

#### **Equalities impact**

4. The services and activities of the organisations named in this report provide support across all communities, particularly those experiencing disadvantage and social exclusion.

#### Corporate objectives and priorities for change

5. This accords with the Council's objective of promoting strong and positive communities and protecting and supporting people.

## Community Grants Budget 2006/07

#### SUMMARY

- 1.1 We have considered a number of options for the allocation of the Community Grants Budget CGB grants to voluntary sector organisations for 2006/07.
- 1.2 A total of 45 organisations have applied for CGB funding in 2006/07. The CGB now has an assumed budget of £851,491 in 2006/07, subject to the setting of the Council's budget in March 2006.
- 1.3 Subject to any issues raised at the meeting, I support the following recommendations.

#### RECOMMENDATION

- 2.1 To continue funding 13 organisations on a three year basis 11 of whom will be in their final year of CGB funding in 2006/07, to begin funding a further 2 organisations on a three year basis and to fund 10 organisations on a one year basis during 2006/07.
- 2.2 To approve the allocation of the Community Grants Budget grants to voluntary sector organisations for 2006/09 as outlined in this report and detailed in the appendices.
- 2.3 To approve grants to existing CGB funded organisations at the same level as they were funded in 2005/06, with no inflationary increase.

#### **REASON FOR RECOMMENDATION**

3. The Community Grants Budget is limited, so the Council is not able to support all the organisations which applied for funding in 2006/7. Continuing to fund existing CGB funded organisations is the option which will cause the least disruption to the voluntary organisations supported by the Council.

## Community Grants Budget 2006/07

#### SUPPORTING INFORMATION

- 1.1 The Community Grants Budget provides core revenue funding of £2,000 and above for voluntary and community organisations in Derby. Organisations' service areas need to fit within one of the CGB criteria below to be eligible for funding.
  - To support voluntary and community sector infrastructure organisations that provide development support to the voluntary and community sector **or**
  - To strengthen communities by:
    - $\circ$  providing advice, information or advocacy, or
    - o supporting new and emerging communities, or
    - supporting activities designed to develop socially excluded communities or access to services for those communities, or
    - supporting organisations that have a specific role in taking forward neighbourhood development.
- 1.2 Organisations applying for three-year funding must meet one of two additional criteria
  - Organisations which are concerned with supporting voluntary and community sector infrastructure, city-wide or in Neighbourhood Renewal Strategy priority neighbourhoods

Or

- Organisations which play a strategic role in helping people to access information and advice on a city-wide basis.
- 1.3 There were 32 applications received for funding from the CGB, and 13 currently three-year funded organisations being considered for continued funding. The 32 applications alone requested £822,035 for 2006/07. The recommendation process has assumed a base budget for both one year and three-year grants of £851,491.

- 1.4 From the 2004/05 approval round, 11 organisations were approved for three-year funding starting from April 2004. During the 2005/06 approval round, two further organisations were approved for three-year funding starting April 2005. We have carried out the mid-term review on the 11 organisations that started their three-year grant in 2004 and verifications of all procedures being in place on the two organisations that started in 2005. Appraisal Panels have recommended that all 13 organisations are fit for purpose and that they continue to receive CGB funding.
- 1.5 We have implemented a number of developments and changes to the CGB process this year. This included much wider publicity of the grant, building on the publicity of the previous year. From this, we had 20 new applicants applying to CGB.
- 1.6 In the Cabinet report for 2005/06 grants, four organisations were subject to conditions to be met in the first six months of the year. Failure to have met this would have resulted in loss of half of the remaining grant. These organisations were: Derby Asian Women's Training, Derby Women's Centre, the Play and Recycling Centre; and Derby Shopmobility. All four organisations met the conditions within the timescale.
- 1.7 Other organisations which were approved for funding had other conditions or follow up support. Progress on these was taken into account in this year's appraisal process.
- 1.8 Appraisal Panels met in October 2005 to consider the 32 applications and the current 13 three-year funded organisations. Following the previous year's appraisal process, a full review was carried out of the CGB process. Part of the review covered clarifying the criteria between CGB and other Council grants made by Social Services and Education. The review process overall led to significant improvements in criteria, the scoring and appraisal process and the timetable. It also led to wider publicity of the grant and agreement that one-year grants were for that period only and all applications were assessed on merit. All aspects of the review were discussed in the Compact Forum with the Voluntary Sector. In June 2005, Cabinet approved revised CGB criteria arising from the review.
- 1.9 Each application was scored throughout by the Appraisal Panel. Certain sections of the application required minimum scores to be reached in order to be recommended for CGB funding. The sections requiring a minimum score to be reached are:
  - proposed outcomes
  - project monitoring
  - management
  - financial management
  - equality in organisation.

The Legal Services Commission Quality Mark is a compulsory requirement for all information and advice giving organisations.

1.10 Following discussion with the Cabinet Member for Adult Services we are proposing not to fund any new organisations applying to the CGB.

- 1.11 Two organisations are recommended for three-year funding for 2006-2009:
  - Derwent Stepping Stones
  - SUPORT

Derwent Stepping Stones and SUPORT currently receive CGB funding on a one year basis.

- 1.12 The recommendations for one-year funding are:
  - Alternative Activities
  - Asian Advisory Service
  - Austin Community Enterprise
  - Derby Furniture Project
  - Derby Shopmobility
  - Derby West Indian Community Association
  - Derby West Indian Association Credit Union
  - Derby Women's Centre
  - Derby Chinese Welfare Association
  - Play and Recycling Centre.
- 1.13 We will continue to monitor the scoring process and the format of the application and appraisal forms in consultation with the voluntary sector prior to next year's application round.

#### **OTHER OPTIONS CONSIDERED**

- 2.1 Following the appraisal process three broad options were considered to balance the budget ...
  - Reduce all organisations by a certain percentage to fit the available budget.
  - Use total scores achieved for each organisation and fund those organisations who achieved above a certain total score.
  - To continue to fund all currently funded organisations and not bring in any new applicants.
- 2.2 The third option is the recommended proposal. The proposal has the support of Council Cabinet Members and would leave an unallocated balance of £13,861 in the CGB to be retained as a contingency in 2006/07.

## Community Grants Budget 2005/06

#### RECOMMENDATIONS

- 1.1 To approve the allocation of Community Grants Budget CGB grants to voluntary sector organisations for 2005/06 as outlined in this report and detailed in the appendices.
- 1.2 To approve the allocation of the remaining CGB budget from 2004/05 of £6,240 to support the development of the Compact.

#### REASONS FOR RECOMMENDATIONS

- 2.1 All applicant organisations have been appraised against the CGB criteria and in relation to fitness for purpose. Existing three-year funded organisations are recommended to receive a 2.7% inflationary increase. All one-year applicants who received one-year funding in 2004/5 are recommended to receive the same amounts in 2005/06. One new applicant organisation, not previously in receipt of CGB funding, has been recommended for a grant. This retains the 2005/06 grants to voluntary organisations within the assumed CGB budget of £846,323.
- 2.2 There is no other budget provision for supporting the development of the Compact.

#### SUPPORTING INFORMATION

- 3.1 The Community Grants Budget provides core funding for voluntary and community organisations in Derby. Organisations' service areas need to fit within the Council's objectives and within four key CGB themes to be eligible for funding. The themes are to:
  - support the voluntary and community sector infrastructure
  - make communities powerful
  - deliver services relating to social inclusion
  - test out and deliver innovative approaches.
- 3.2 Organisations applying for three-year funding must meet one of two additional criteria:
  - supporting the voluntary and community sector infrastructure, city-wide, for example, providing development support for voluntary or community groups
  - play a strategic role in partnership with the Council in supporting its service areas on a city-wide basis.

- 3.3 There were 24 applications received for 2005/06 funding from the CGB, plus 11 organisations due for continuation of three-year funding approved last year, with a total of £1,539,469 requested. The recommendation process has assumed a base budget of £824,000 plus a 2.7% inflationary increase £846,323. If there were a change to this assumption, the recommendations in this report would need to be reconsidered.
- 3.4 The 2004/05 allocation of £5,750 for the Racial Harassment Project is still unspent. A new project is being worked up by the Community Safety Partnership, which will start during 2005/06. £5,750 has been included for the project in the recommendations.
- 3.5 During the 2004/05 approval round, 11 organisations were recommended for threeyear funding starting from April 2004. We have checked that all necessary monitoring and safety procedures are in place and that work is progressing according to the funding agreements. A full review of these three-year allocations will be carried out after the first full year's grant.
- 3.6 The organisations approved for three-year funding last year, and therefore recommended for continuation of funding, including inflationary increases as stipulated in the three year funding agreement, are:
  - Business in the Community
  - Derby CAB
  - Derby Community Accountancy Service
  - Derby CVS
  - Derby Law Centre
  - Derby Millennium Network
  - Derby REC
  - Derbyshire Association for the Blind
  - Derbyshire Community foundation
  - Derbyshire Housing Aid
  - Disability Direct.
- 3.7 We have implemented a number of changes to the CGB process this year, including wider publicity through Derby Council for Voluntary Service DCVS, Network News and Derby Millennium Network's members' circulation. This active publicity to the voluntary sector led to ten new applications for CGB.
- 3.8 Appraisal Panels met in October 2004 to consider the 24 applications. This year, there have been two officers acting as core members for all panel meetings to support consistency across the appraisal process. The two core members focused on consistency of recommendations in quality of service and the organisations' performance management, and equality of standards for each application. Each individual panel meeting also included two officers with expertise specific to the service area being assessed.

- 3.9 To try and further improve the decision-making process for the CGB, a new system was introduced into the appraisal process following discussion and agreement at the Compact Forum in May 2004. Organisations were rated against six criteria:
  - information about the organisation / service, including fit to intended CGB theme, fit to Council objectives
  - outputs and outcomes
  - project monitoring
  - management
  - financial management
  - equalities.

The Legal Services Commission Quality Mark is a compulsory requirement for all information and advice giving organisations.

- 3.10 The assessment process and the four key CGB themes will be further refined before next year's appraisal process, in full consultation with the Compact Forum.
- 3.11 The organisations which applied for new CGB funding for 2005/6 were:
  - Age Concern Derby and Derbyshire
  - Alternative Activities
  - Asian Advisory Service
  - Austin Community Enterprise Ltd
  - Children First
  - Communications Unlimited
  - Derby Asian Women's Training Association
  - Derby City Mission
  - Derby Furniture Project
  - Derby Shopmobility
  - Derby West Indian Association Credit Union
  - Derby West Indian Community Association
  - Derby Women's Centre
  - Derbyshire Autistic Support Group
  - Derby Chinese Welfare Association
  - Derbyshire Mind Rosehill
  - Derwent Stepping Stones
  - Key to the Edge
  - Multi-Faith Centre
  - Play and Recycling
  - Relate Derby and Southern Derbyshire
  - SUPORT Ltd
  - The Enthusiasm Trust Youth Charity
  - The Ikhlas Foundation.
- 3.12 Two organisations are recommended for three-year funding for 2005-2008 because they meet the CGB criteria and qualify for three-year funding:
  - Communication Unlimited
  - Age Concern Derby and Derbyshire.

- 3.13 Twelve organisations, which received CGB funding for one year in 2004/5 are recommended to receive the same amount in 2005/6, because they continue to meet the criteria and have satisfied the appraisal criteria:
  - Asian Advisory Service
  - Austin Community Enterprise Ltd
  - Derby Asian Women's Training Association
  - Derby Furniture Project
  - Derby Shopmobility
  - Derby West Indian Association Credit Union
  - Derby West Indian Community Association
  - Derby Women's Centre
  - Derby Chinese Welfare Association
  - Derwent Stepping Stones
  - Play and Recycling
  - SUPORT Ltd.
- 3.14 Of these, four organisations:
  - Derby Asian Women's Training Association
  - Derby Women's Centre
  - Play and Recycling
  - Derby Shopmobility

showed areas needing improvement. We are therefore recommending that funding is approved subject to improvement criteria being met within the first six months of the financial year. Should the organisation not meet their conditions, they will then only be granted half of the remaining funding over the next six months. Conditions relate to specific areas of improvement required for that organisation.

- 3.15 Ten organisations were new applicants to CGB who had not received funding in the past. Three of these applications were not considered because the applications were for projects, rather than core funding. These were:
  - Enthusiasm Trust Youth Charity
  - Relate Derby and South Derbyshire
  - Children First.
- 3.16 Three new applications were rejected on appraisal because they did not meet minimum standards for funding:
  - Ikhlas Foundation
  - Derby City Mission
  - Multi-Faith Centre.

3.17 The remaining four new applicants:

- Key to the Edge
- Derbyshire Autistic Support Group
- Alternatives Activity Centre
- Derbyshire Mind Rosehill

were assessed for the allocation of the remaining £14,718 in the available budget provision. Both Key to the Edge and Mind Rosehill were felt to be part of larger, wellfunded organisations with access to other funding. Derbyshire Autistic Support Group was felt to have more of a social care remit than the Alternatives Activity Centre, which provides employment placements for people with learning disabilities. Alternatives was felt to be a robust organisation, delivering a good service, and most likely to achieve its outputs. It was also felt that it would be more effective to allocate the whole amount to one organisation, rather than divide it between four, and the amount available most closely matched the amount they requested in the application.

- 3.18 We will further improve the appraisal process prior to next year's application round. This would include the following:
  - reconsideration of the four key CGB themes
  - refinements to the scoring process
  - taking a strategic overview of services provided by organisations to prevent duplication
  - developing a system to manage those organisations and projects that are under-achieving and to consider the milestones that need to be put in place to support the development of performance
  - agreeing how to develop the process through the Compact Forum.
- 3.19 We propose to use the remaining CGB budget from 2004/05 of £6,240 to support the development of the Compact. Responsibility for matters such as consultation and publicity for the Compact are currently shared between the Council and CVS, so the budget would be allocated between the two organisations as appropriate.

#### OTHER OPTIONS CONSIDERED

4. Not allocating balance of £14,718 at this stage, but to retain as a contingency in 2005/06.

# Approval of Community Grants Budget – CGB – Grants to the Voluntary Sector 2004/05

#### RECOMMENDATIONS

- 1.1 To approve the allocation of Community Grants Budget grants to voluntary sector organisations as outlined in this report and detailed in Appendix 3.
- 1.2 To note that the use of any remaining unallocated funding from the CGB budget will be brought to Cabinet for approval during 2004/05.

#### **REASON FOR RECOMMENDATIONS**

2. All applicant organisations have been appraised against the CGB criteria and in relation to fitness for purpose. Most applicants are recommended to receive a 3% inflationary increase over and above their 2003/04 grant, with some exceptions outlined in this report. This retains the 2004/05 grants to voluntary organisations within the assumed CGB budget of £824,000.

#### SUPPORTING INFORMATION

- 3.1 There were 29 applications received for funding from the CGB, with a total of £1,270,017 requested for 2004/05. The recommendation process has assumed a base budget of £800,000 plus a 3% inflationary increase £824,000. If the Council does not provide a 3% inflationary increase, then the recommendation in this paper would need to be reconsidered.
- 3.2 It should be noted that the 2003/04 recommendation of £5,580 for the Racial Harassment Project is still unspent. Derby Racial Equality Council has not applied for funding for this project this year. A review is currently taking place and there is expected to be a need for funding in 2004/2005. With the 3% inflation, the Racial Harassment project will require £5,750 in 2004/05, and this has been built into the recommendations.
- 3.3 It should also be noted that the grant for the Citizens' Advice Bureau CAB was enhanced for 2003/04 above base budget, with a 'one-off' grant of £27,000 from corporate reserves. This was to meet a specific pressure the organisation was experiencing in supporting their Operations Manager. The recommendation in this report has the effect of bringing the CAB grant back to base budget plus the 3% inflationary increase.

- 3.4 The Council's Voluntary Sector Support Officers carried out an initial appraisal of all applications and produced recommendations based on the assumed available budget, including the 3% inflation, of £824,000. Appraisal Panels of senior officers from across the Council, with expertise in the service areas being assessed, met to appraise applications during December 2003. The Panels considered the following aspects:
  - fit to Council priorities
  - whether the relevant Quality Mark / standard is in place
  - robustness of management structures
  - proposed outputs and outcomes
  - equalities.
- 3.5 Organisations also had to meet one of the CGB themes:
  - support the voluntary and community sector infrastructure
  - make communities powerful
  - deliver services relating to social inclusion
  - test out and deliver innovative approaches.
- 3.6 Consideration has been given to three-year CGB funding agreements for the first time, in line with Council policy, and already implemented by Social Services for appropriate grants. Organisations applying for three-year funding were required to meet one of two criteria:
  - supporting voluntary and community sector infrastructure, city-wide
  - playing a strategic role in partnership with the Council in supporting the Council's services city-wide.

Only those meeting one of these criteria have been recommended for three-year funding.

- 3.7 Part of the requirement for three-year funding will be that, where applicable, organisations maintain the Legal Services Commission Quality Mark. This will be checked through the routine monitoring procedures. All three-year funding agreements will be subject to annual review and conditional upon budget provision being available.
- 3.8 We are proposing that all applicant organisations are recommended to receive a 3% inflationary increase over and above their 2003/04 grant at maximum, with the exception of the following:
  - CAST Trust no grant recommended not previously received a grant.
  - DAHRTI no grant recommended
  - DACP recommendation that grant is provided outside the General Fund
  - Derby Furniture Project 2003/04 base budget recommended with 3% increase pending conditions
  - Victim Support no grant recommended
  - Derbyshire Association for the Blind new grant recommended not previously received a grant.

The reasons for all the recommendations are explained in Appendix 3.

3.9 The total recommendations for all applications are as follows:

2004/05 - £817,760 – 1-year and 3-year recommendations

2005/06 - £578,180 - 3-year recommendations

2006/07 - £595,520 - 3-year recommendations

- 3.10 The financial implications of the above are outlined in Appendix 2, assuming a 3% inflationary increase in the CGB base budget.
- 3.11 The remaining £6,240 will be retained within the CGB budget and considered for allocation within the priorities for 2004/05.

# **OTHER OPTIONS CONSIDERED**

4. Various options were considered in order to retain the grants approvals within budget as part of the appraisal process. This recommendation is felt to be the most equitable way of distributing the grants, taking into account the CGB criteria and the organisations' fitness for purpose.

# **ITEM 13**

## COMMUNITY GRANTS BUDGET FINANCIAL SUPPORT TO VOLUNTARY AND COMMUNITY ORGANISATIONS 2003/04

Report of the Director of Policy

## SUMMARY OF REPORT

- 1.1 Cabinet is asked to approve funding of £823,000 from the Community Grants Budget – CGB – and from corporate resources to voluntary and community organisations for 2003/04, subject to finalisation of the Council's budget.
- 1.2 The Appendix shows the amount we are recommending for each organisation.

## **OPTIONS CONSIDERED**

- 2.1 We received thirty applications for funding from the CGB, totalling £1,305,838. Each application for funding has been appraised by officers against organisational "fit for purpose" and delivery of the Council's corporate objectives. Consideration was given to whether individual organisations met the criteria for the Community Grants Budget, and how to allocate the overall budget among different organisations. The criteria for funding from CGB are to support organisations which:
  - support the voluntary and community sector infrastructure
  - make communities powerful
  - deliver services in line with the remit of the Policy Directorate
  - test out and deliver innovative approaches to service delivery.
- 2.2 Consideration was also given to the difficulties experienced by applicant organisations if the full amount of their application was not met.

#### RECOMMENDATION

3. To approve the payment of funding totalling £823,000 as outlined in the Appendix to this report, subject to finalisation of budget provision by the Council, and subject to the arrangements set out in paragraph 5.7 of this report.

## **REASONS FOR RECOMMENDATIONS**

- 4.1 Community Grants Budget allocations need to be notified to applicant organisations before the beginning of the 2003/04 financial year. The detailed reasons for the recommendations are set out under matter for consideration.
- 4.2 The Community Grants Budget for 2003/04 is fully committed.

#### MATTER FOR CONSIDERATION

- 5.1 This report sets out the recommendations for Community Grants Budget – CGB – funding to be paid to voluntary organisations next year.
- 5.2 A number of organisations have applied for funding this year which have not received CGB funding previously, including Disability Direct, the Asian Advisory Service and Derbyshire Housing Aid. We recommend support to these groups of £9,620, £5,000 and £17,500 respectively. In order to offer support to these groups, which are assessed as providing good quality services, we recommend reduced funding to some established organisations that we funded in 2002/03 or, at the very least, retaining their funding at pre-inflation levels.
- 5.3 We recommend providing £2,500 to the Derbyshire Community Foundation to support their core costs to enable the organisation to be effective in distributing the Community Empowerment Fund grants to the voluntary sector. The Council did not provide funding to this group in 2002/3 but has done so in the past. We are also recommending a small increase to Austin Community Enterprise because of its key position within a priority neighbourhood, and a one-year increase only to the Derby Citizens Advice Bureau to assist on a transitional basis with the organisation's operational shortfall.
- 5.4 We recommend withdrawing funding from two organisations, the Derbyshire Gypsy Liaison Group, because they are not intending to apply for the LSC Quality Mark, and Osmaston Community Association because we do not consider its advice service meets required standards.
- 5.5 We recommend reducing funding to the following organisations from 2002/3 levels on the basis that they have the capacity to diversify their sources of funding:
  - Derby West Indian Community Association
  - Derby Association of Community Partners
  - Business in the Community
  - Derby Furniture Project
  - Derwent Stepping Stones Nursery
  - DAHRTI
  - Derby Shopmobility.
- 5.6 All other organisations are proposed to be funded at 2002/3 levels. We recommend that the funding for the Racial Harassment Advice and Support project is offered only on satisfactory completion of the proposed review of the service to make sure that the service is regarded as effective by all funding partners.

- 5.7 In accordance with the principles approved by the Policy Committee in 1997, and the requirement for organisations giving legal advice to have gained the Legal Services Commission Quality Mark in order to qualify for Council funding, we propose that each CGB grant is offered on the following conditions:
  - the full year's funding be approved in principle and a letter to that effect is sent out as soon as possible
  - six months' funding is released in advance in April 2003
  - all grants to be subject to a written agreement between the organisation and the Council, setting out specific conditions of grant and any additional monitoring requirements
  - all organisations, before being paid the remaining grant for the year, to provide annual accounts and a statement of grant expenditure for 2002/03, to provide ongoing satisfactory quarterly financial monitoring reports and to have a formal review meeting with officers where the organisation has a grant over £10,000
  - all advice-giving organisations, as specified in the Cabinet report of 17 December 2002, to have gained or made a verifiable application for the LSC Quality Mark by 31 March 2003.

## FINANCIAL IMPLICATIONS

6. The level of annual grants recommended in this report can be contained in the Community Grants Budget for 2003/04 of £800,000, plus an additional one-off sum of £23,000 that will be met from corporate budgets for 2003/04.

## **LEGAL IMPLICATIONS**

7. Each organisation receiving a grant will be required to enter into a funding agreement with the Council.
