# **Key Emerging Spatial Issues**

# **The Spatial Strategy**

- Where should major new housing be located and what should the balance between brownfield regeneration and Greenfield suburban extension be?
- What will be the role of Green Wedges and Green Belt within the strategy?
- What 'physical infrastructure' (e.g. roads, utilities etc) will be required to deliver the growth required and how will it be delivered?
- What 'social infrastructure' (e.g. education, health, sport & recreation, local shops and services, community facilities etc) will be required to deliver sustainable growth required and how will it be delivered?
- What 'green infrastructure' (e.g. public open space, nature conservation sites, public realm etc) will be required to deliver sustainable growth and how will it be delivered?
- What should the balance be of different types of housing, such as apartments and family homes?

# **Responding to Climate Change**

- How should the Core Strategy address the need to adapt to increased flood risk?
- How should the Core Strategy address the use of renewable energy sources and minimise energy use within new development?
- How can the Core Strategy encourage sustainable design principles into the planning of new developments?
- How can the Core Strategy help to reduce carbon emissions?
- How should the Core Strategy address waste and recycling?

# Renewing and Improving Neighbourhoods / Meeting Community Needs

- How can the Core Strategy maximise the delivery of affordable housing?
- What existing local deficiencies exist in the provision of 'social infrastructure' and what can the Core Strategy do to address this?
- What existing local deficiencies exist in the provision of 'green infrastructure' and what can the Core Strategy do to address this?
- How can the Core Strategy address the needs of minority communities, including Gypsies, Travellers and Travelling Showpeople?
- How can the Core Strategy promote learning and achievement to ensure people from all neighbourhoods have the best educational opportunities?
- What can the Core Strategy do to help make Derby a healthier City?

#### Protecting and Improving the Environment

- What should the Core Strategy's approach be to the protection of the natural and built heritage, including the City's cultural, historic and archaeological heritage?
- What should the Core Strategy's approach to tackling known areas of pollution and how can it ensure that new development does not create or exacerbate the issue?
- How can the Core Strategy help to promote local distinctiveness through policies on design?

# Maintaining Economic Prosperity

- How much employment land should be provided and where?
- How can the Core Strategy improve job opportunities, especially for people living in high areas of unemployment?
- What should the approach be to the location of new office space in the City?
- Can the City accommodate the RSS requirement for a major rail-linked logistics site?

# The City Centre

- What should the Core Strategy do to help create a healthy & vibrant city centre?
- How can the city centre become more attractive to visitors and investors?
- Is there a role for city centre living? (relates to the overall Spatial Strategy)
- What should the approach be to tall buildings?

# The Transport Strategy

- How can the Core Strategy encourage people to travel in more sustainable ways?
- How can the Core Strategy help to improve accessibility?
- How can the Core Strategy help to tackle existing areas of congestion?
- How can the Core Strategy help to tackle existing road safety issues?
