## Safeguarding and Looked After Children Inspection Improvement Action Plan

## SUMMARY

- 1.1 An inspection of safeguarding and looked after children services took place in May 2011. The findings report was published jointly by Ofsted and the Care Quality Commission (CQC) on 27 June 2011.
- 1.2 An action plan detailing the 24 recommendations and actions required to address areas of improvement was developed and is shown in **Appendix 2.**
- 1.3 The improvement action plan was reviewed by the Children and Young People (CYP) Commission in September 2011 and Corporate Parenting Board in January 2012. This report presents an updated position as requested by the Chair.

## RECOMMENDATION

2.1 To note the updated Improvement Plan.

## REASONS FOR RECOMMENDATION

- 3.1 Local authorities and their partners have a duty to provide appropriate services that protect children in need. They are also required to respond to recommendations made by inspectorates such as Ofsted and CQC.
- 3.2 During any future inspection the Council would need to demonstrate that they have responded and acted upon the recommendations made by Ofsted in an effective and efficient manner.

## SUPPORTING INFORMATION

- 4.1 Local authorities are subject to regular inspections by Ofsted and CQC on services focused on safeguarding and looked after children. The last inspection took place in May 2011.
- 4.2 The overall effectiveness of safeguarding services in Derby was rated as 'adequate', with capacity for improvement assessed as 'adequate'. Services for looked after children were also rated as 'adequate'.
- 4.3 The report highlighted some areas of good performance, including 'staying safe' and 'economic well-being' outcomes for looked after children and care leavers. The report included 24 recommendations for improvement.
- 4.4 Derby City Council and its partners have responded to the inspection report by developing an improvement action plan as shown in **Appendix 2**. Consultation on the plan has involved all stakeholders included and responsible for delivering the actions contained within the plan. The plan included actions and outcomes to be achieved, timescales, lead officers and progress to be made.
- 4.5 The process for delivering and monitoring the improvement plan was led by the Director of Children and Young People, with approval from the Children's Trust and Derby Children's Safeguarding Board.
- 4.6 The improvement plan has been monitored regularly and Corporate Parenting have received regular updates.
