Report of the Cabinet Member for Children and Young People

Derby Child and Family Poverty Commission - Update

SUMMARY

- 1.1 The Derby City and Neighbourhood Partnerships (DCNP) Child and Family Poverty Commission held its inaugural meeting at the end of March 2013.
- 1.2 In addition to finalising the roles and responsibilities of the Commission, including membership (see Appendix 2), the main purpose of the meeting was to review both the areas for action for the Derby Child and Family Poverty Strategy and associated work programme for the Commission (Appendix 3).
- 1.3 The Commission endorsed the proposed areas for action and identified key work streams including:
 - the development of food banks in the city
 - joining up advice and support services in the city
 - challenging the marketing, promotion and positioning of pay day lending companies, to protect the vulnerable
 - promoting the alternatives to the use of pay day lending companies
 - increasing the supply of affordable banking and credit.
- 1.4 The Commission also agreed to carry out a review of:
 - the supply and demand for affordable banking and credit in the city
 - · information and advice services

The results of the two reviews will be considered at the next meeting of the Commission in June/July.

- 1.5 Since the meeting, a number of areas have already been progressed and achievements made. The Cabinet Member for Resources has now finalised a bulk buy energy scheme for Derby residents and is exploring the development of ethical forms of payday support.
- 1.6 The Commission will report back to the DCNP Board at its meeting on the 11 June 2013.

RECOMMENDATIONS

- 2.1 To note and endorse the key work areas for the Derby Child and Family Poverty Strategy.
- 2.2 To embed the key areas for action from the Child and Family Poverty Strategy into Council policy.

REASON FOR RECOMMENDATIONS

3.1 To demonstrate the commitment of the Council to the delivery of the Derby Child and Family Poverty Strategy and actively tackling the causes of poverty in the city.

 - acting as a think tank for generating new and innovative ideas and solutions to tackling poverty in Derby
 - overseeing the delivery of the Derby Child and Family Poverty Strategy
 - utilising the influence and expertise of Commission members to overcome obstacles to change locally, regionally and nationally.
- 4.3 Prior to the inaugural meeting of the Commission a significant amount of work had been undertaken to carry out a Child and Family Poverty Needs Assessment for Derby and produce a Child and Family Poverty Strategy.
- 4.4 The main purpose of the first Commission meeting was to review, strengthen and endorse the areas for action for the Child and Family Poverty strategy and develop a programme for delivery (see Appendix 3).

5.1 None – There is a legal duty on the Council and named partners to publish a Child Poverty Strategy and the Derby Child and Family Poverty Commission has been established to champion and oversee the delivery of the strategy and key work areas.

Terms of Reference

Roles and Responsibilities

Policy

- To give the child and family poverty agenda the profile needed to make an impact in Derby.
- To interpret the impact of national policy and make recommendations to Derby City and Neighbourhood Partnerships (DCNP) Board, Outcome Boards and partner organisations.
- To lobby Central Government to shape national policy.

Shared Direction

- To develop strategy and action to tackle the underlying causes of poverty in the city.
- To create/maintain a continued focus on combatting the causes of poverty.
- To ensure the continued engagement and commitment of all sectors and organisations in the development and delivery of strategy and action to tackle poverty in Derby.
- To review and where necessary challenge the strategy and plans of DCNP, including Outcome Boards, and partner organisations to ensure they are contributing effectively to tackling the causes of child and family poverty in the city.

Knowledge management:

- To utilise knowledge of the city, neighbourhoods and communities to inform strategy to tackle the causes of poverty and review its impact.
- To act as a think tank for generating new and innovative ideas and solutions to tackling poverty in Derby.

Delivery

- To oversee the delivery of the Derby Child and Family Poverty Strategy.
- To influence the thematic strategies and plans of both DCNP and partner organisations to ensure action is being taken to tackle the multiple and complex causes of child and family poverty.
- To harness the passion, motivation and commitment of individuals.
- To utilise the influence and expertise of Commission members to overcome obstacles to change locally, regionally and nationally.

Membership and Meetings

The Commission is a small body comprising civic leaders and passionate, knowledgeable and influential people from all sectors. It co-opts members as and when necessary to reflect the priorities of the Child and Family Poverty Strategy.

Appendix 3 - Areas for Action

Mitigation (short term)

Support for employees of partner organisations who are living in poverty

- Adoption of Living Wage by partner organisations.
- Employee support schemes development of bulk buying energy schemes.

Food and essential items banks

- Support for food banks.
- Basic training and awareness of food bank services for amongst partner employees.
- Strategic coordination of food bank services across the city.
- Increasing donation networks in the city.
- Monitoring of supply and demand.

Movement (medium term)

Doorstep/payday lending

- Challenging the marketing, promotion and positioning of pay day lending companies, to protect the vulnerable.
- Development and promotion of alternative forms of payday support.

Increasing the availability of affordable banking in the city

- Understanding the supply and demand of credit unions in the city.
- Review of credit union development.

Improving the financial literacy of those in poverty

Review of financial literacy support in the city.

Joining up of advice and support services in the city

 Review of information and advice provision in the city, including how services work together and could work better together.
