Late Items to be Introduced by the Chair

The Chair agreed to admit a report entitled "Play Schemes and Junior Activity Schemes" as an item on the grounds that, owing to Community concerns the proposed charges had to be considered before their introduction on 29 July 2002.

As notice of the item had not been given three clear days before the meeting, it was confirmed that, in accordance with Procedure Rule Al27, the Chair of the Lifelong Learning and Culture Overview and Scrutiny Commission had agreed that this key decision be considered.

The Chair also agreed to admit an oral report from the Directors of Corporate Services and Development Services updating the Cabinet on the Riverlights proposals.

Urgent Items to which Call In will not apply

It was reported that, as the following items had to be implemented with immediate effect, the Chair of the relevant Overview and Scrutiny Commission had agreed that they could be treated as an urgent item, and therefore not subject to call in for the reasons outlined below:

Derby Homes – Memorandum and Articles of Association

This matter was urgent as the recommended changes were being considered by the Derby Homes Board on 27 June 2002

Pride Park Phase 2 – Offers for Plot 14.

This matter was urgent as the purchaser aimed to exchange contracts within five working days of the approval of their offer.

42/02 Best Value Review of Front Line Housing Services and Sustainable Estates – Progress Report

The Council Cabinet considered a report from the Director of Derby Homes setting out progress made on the improvement plan completed following the Best Value Review of Front Line Housing Services and Sustainable Estates, and the results of the inspection carried out by the Audit Commission.

The Cabinet expressed their appreciation of the hard work put in by Officers to achieve the 3 star rating.

43/02 Best Value Review of Vehicle Fleet Management Services

The Council Cabinet considered a report from the Director of Commercial Services setting out the terms of reference for the Best Value Review of Vehicle Fleet Management Services.

Urgent Key Decision

44/02 Derby Homes – Memorandum and Articles of Association

The Council Cabinet considered a report from the Chief Executive setting out proposed changes to the Memorandum and Articles of Association of Derby Homes, recommended by its Board. These changes provided for the representation of leaseholders on the Board and created restrictions upon tenants and leaseholders who were two months or more in arrears.

In accordance with procedure rule Al26, the Chair of the Social Care Health and Housing Overview and Scrutiny Commission had been advised that this item would be given consideration although not included in the Forward Plan.

Options Considered

No alternative options were considered.

Decision

To approve the proposed changes to the Memorandum and Articles of Derby Homes being recommended by Derby Homes Board at an Extraordinary General Meeting to be held on 27 June 2002.

Reason

The changes proposed need to be considered in order to adjust the Memorandum and Articles of Derby Homes to reflect the Board's proposed methods for the election of tenants and leaseholders to its membership and for the conduct of its business.

Key Decisions

45/02 National Land Information Services Initiative

The Council Cabinet considered a report from the Director of Corporate Services setting out details of the National Land Information Service (NLIS) Initiative. The initiative aimed to provide a one stop shop service to deliver, electronically, land and property information to solicitors, conveyancers and the general public. The

Government saw initiatives such as this as an important step for Council's in meeting their E-government targets.

The first steps in moving to electronic service delivery were for the Council to sign the NLIS data provider agreement. This sought to:

- approve a differential pricing policy by reducing by 18% the price of local land searches received electronically
- make sure that the Council implemented its local land and property gazetteer by the 31 December 2002
- make sure that the Council could receive local land search application fees by automated bank credit payment.

In accordance with Procedure Rule Al26, the Chair of the Scrutiny Management Commission had been advised that this item would be given consideration although not included in the Forward Plan.

Options Considered

No alternative options were considered

Decision

- 1. To enter into the data provider agreement terms as detailed in the report.
- 2. To approve a differential pricing policy for Local Land Search requests as outlined in the report.
- 3. To increase the cost of a standard search from £77.00 to £80.00 with effect from 1 July 2002.

Reasons

For the Council to work towards meeting its E-government targets by modernising delivery of its Local Land Charges and Searches service.

46/02 Rent Restructuring

The Council Cabinet considered a joint report from the Chief Executive and the Director of Finance setting out government policy on rent restructuring and making recommendations concerning those aspects of information which were open for the City Council to determine.

In accordance with Procedure Rule Al26, the Chair of the Social Care Health and Housing Overview and Scrutiny Commission has been advised that this item will be given consideration although not included in the Forward Plan.

Options Considered

The options considered were set out in the report.

Decision

- 1. To make adjustments towards target rent levels in 10 equal steps.
- 2. To agree that existing and new tenants would pay the same rent for the same property.
- 3. To use discretion to vary by 5% from target rents in order to alleviate the highest increases with such adjustments being determined, and applied for in the National Policy Review in 2005.
- 4. To exclude service charges from the determination of target rents on the same basis as those excluded for rent rebate subsidy limitation purposes or as may be specified in future regulations and guidance.

Reasons

The Council is required to implement rent restructuring to council housing from 2002 and needs to make certain decisions in the manner in which this is implemented.

47/02 Voluntary Playscheme and Special Need Playscheme Organsiations - Grants

The Council Cabinet considered a report from the Director of Education setting out details of eight grant applications received from Voluntary Play Schemes and Special Needs Play Scheme Organisations.

In accordance with Procedure Rule Al26, the Chair of the Lifelong Learning and Culture Overview and Scrutiny Commission had been advised that this item would be given consideration although not included in the Forward Plan.

Options Considered

No alternative options were considered.

50/02 Social Services Inspectorate - Annual Review of Performance 2001-2002 and Star Rating for Social Services

The Council Cabinet received a report from the Director of Social Services setting out the outcome of the Social Services Inspectorate (SSI) Annual Review of Performance 2001 – 2002 and Star Rating for Social Services. The Council's Social Services had been rated with two stars; only eight authorities had gained three stars. The annual assessment letter and report had been positive about the Council's achievement whilst identifying areas for improvement. The findings would feed into the Social Services Inspectorate / Audit Commission Joint Review of Social Services in the autumn.

The Council Cabinet expressed their appreciation for the hard work put in by officers to achieve the 2 star rating.
