Endorsement of the election of Youth Mayor for 2023-24

Purpose

- 1.1 Derby City Council undertook annual citywide elections for the Youth Mayor and Deputy Youth Mayor in January 2023.

Almost 18,000 ballot papers were circulated to 18 secondary schools, of which 10,845 were returned, providing young people across the city with their first experience of the democratic process.

- 1.3 The result saw Muhammad Muntasir of Noel Baker Academy and Harman Kaur of City of Derby Academy elected as Youth Mayor and Deputy Youth Mayor respectively.
- 1.4 The results were announced by Councillor Evonne Williams to the Voices in Action Youth Council at an event held in the Council Chamber on 13 February. Muhammad and Harman are now invited to make their declaration of acceptance of office before the Annual General Meeting of Council.

Recommendations

- 2.1 To thank Omar Aslam and Gloria Osei-Bonsu for the time they have dedicated to representing young people in Derby as Youth Mayor and Deputy Youth Mayor in 2022-23 and to invite them to address Council.
- 2.2 To commend the efforts of all the candidates who participated in the Youth Mayor elections in 2023.
- 2.3 To endorse the election of Muhammad Muntasir and Harman Kaur as Youth Mayor and Deputy Youth Mayor for Derby for the 2023-24 municipal year.
- 2.4 To invite the newly elected Youth Mayor and Deputy Youth Mayor to make a declaration of acceptance of office before Council.

Reason

- 3.1 The council introduced the position of Youth Mayor in 2014. Since then, the role has developed substantially to encompass a wide range of activities representing young people in Derby.

Formal recognition of the election of the Youth Mayor is a demonstration of Council's

ongoing commitment to give young people a stronger voice in local decision making.

Supporting information

- 4.1 Council established the post of Youth Mayor in June 2014 as part of the authority's strategy to improve engagement with children and young people.
- 4.2 The roles were originally reserved for members of the Voices in Action Youth Council, but the process has been extended to involve more young people each year. In 2018, the first citywide elections were held following agreement with secondary school head teachers.
- 4.3 Each secondary school can nominate up to three candidates to apply for the position. In addition, any young person wishing to apply for the position that does not attend a secondary school but fits within the criteria to stand for Youth Mayor are also able to apply. Candidates were asked to make submissions explaining the issues they believed most affected young people in Derby and how they would represent their peers were they to be elected as Youth Mayor.

One candidate per school was selected by a shortlisting panel that included the Head of Democracy, Electoral Services Manager and the Children and Young People's Participation Officer. A hustings event was held at the Museum of Making on 5 December 2022, where the Voices in Action Youth Council selected four candidates to progress to citywide elections.

Videos of the candidates' speeches are provided to each secondary school, together with a ballot box, booth and ballot papers to undertake an election process. A count was then undertaken at the Council House by volunteers from Democratic Services, Electoral Services and Children's Commissioning.

- 4.4 Muhammad and Harman have been elected by their peers, having pledged to tackle issues such as equality, environment, safety, job opportunities, finance and mental health.
- 4.5 Since 2015, the Youth Mayor has taken an active role in decision making, having been invited to attend meetings of Council Cabinet as well as relevant Overview and Scrutiny Boards, and invited to speak on matters under consideration by councillors. The Youth Mayor also attends ceremonial events alongside the Mayor.
- 4.6 The Youth Mayor is the Chair of Voices in Action Youth Council. They are expected to champion the objectives of the group, which are decided by young people annually.

Public/stakeholder engagement

- 5.1 The successful candidates were elected in citywide elections at secondary schools in January 2023, following a shortlisting process through the Voices in Action Youth Council.
