## Work Programme and Topic Review

## Purpose

- 1.1 The Children and Young People Scrutiny Review Board will agree a work programme for the 2022/23 municipal year at its meeting 20 June 2022.

- 2.3 To agree to change the focus of the Topic Review "Off Rolling" to a smaller and more focused review on specific groups of SEND children to analyse the reasons for placement breakdowns for children with an EHCP and to agree defer it to the next municipal year 2023/24 so the Board can discuss whether to undertake it.

## 4.1 Remit and Terms of Reference for Overview and Scrutiny Boards
