Some of these events are incredibly popular with children and as such, aside from applying to hold the events, the applicant also seeks to allow children to attend the events from start to finish.

Currently children are not permitted on the premises past 8pm. The applicant seeks to remove this condition and to amend another condition which requires children to be accompanied by an adult. In replacement the applicant would like to have a more bespoke condition which permits children to be present on the premises when accompanied by an adult for live performances, boxing and wrestling events."

Essentially the application is to add the Licensable activity of Boxing and Wrestling to the PL and remove and/or adjust some annex 2 conditions to allow children into the premises until midnight when there is entertainment ongoing.

I was first made aware of the proposal for this application when the agent of the applicant contacted this office by email on 4th July 2022 at 2318hrs (Page 258) in this email Peter Conisbee set out the proposal of a variation that he was looking at putting forward in the next couple of weeks, and asked if there would be any "glaring concerns"

This email was forwarded to me by our Licensing Clerk on 5 July 2022 and I responded on 8 July, raising concerns, and requesting a meeting to discuss before any application was made. However, I was surprised to find that the application had already been sent to the council and arrived in my office on the 8 July before any consultation could take place.

I replied to this email (Page 255) and requested a meeting to discuss the variation. A meeting was then held on 15 July 2022 at the premises with the DPS and PLH Scott Malcolm. I presented my concerns and at the end of the meeting we agreed that Scott would provide me with further information and risk assessments as to how they would prevent children from coming to harm if they were able to stay in the premises until midnight. I also asked for risk assessments and operating schedules around the organisation and running of the boxing and wrestling events.

At this point Scott told me that they had been approached by a company called Kumite Combat Wrestling, they are currently holding events at another premises in Derby, but having no room inside, are looking for a venue with room inside for the Winter.

I have researched this company and as far as I can see from their facebook page they are a promotion company which puts on age restricted (18+) wrestling matches which as you would expect are inappropriate for under 18s. This appears to contradict the application which states they want children to be able to attend wrestling bouts, and more specifically the email from Peter Conisbee Dated 8 July 2022 stating ". Essentially my client has no interest in children being on the premises but does not want to prevent them from attending gigs and mainly wrestling events, which seem to be more kids based." (Page 256) I have provided to the committee a disk showing the last example of the type of Wrestling Kumitie Combat Wrestling provide in another Derby Venue. (bear in mind this is marketed and upheld as an over 18s show.)

We arranged for a follow up meeting on 22 July 2022 and I requested that any supporting documentation be sent to me before this so I could digest it and make informed decisions.

On 20 July 2022 I received a further email from Peter Conisbee (Page 261) cancelling the meeting as they were awaiting a letter of support from the Music Venues Trust (MVT)

By 3 August 2022 I had not received the letter from the MVT nor, more importantly any risk assessments or operating schedules in relation to the variation so I submitted a representation to the application. (Page 27 - 31)

been recorded between the hours of 2000hrs and 0000hrs. (Pages 50 to 56) This is absolutely not what would be expected of a child friendly venue.

As the result of a lack of consultation with the applicant I have not seen any safeguards and/or changes to the operation of the premises which would make me believe that children would not be subjected to this violence. Further to this, I am not confident that adequate safety measures would be in place to ensure children are not subjected to moral, psychological and physical harm whilst amongst potentially drunk individuals late into the night at a city centre venue. Wrestling and boxing bouts held late into the night have also been proven to cause further violence and agitation in the night-time economy with alcohol fuelled violence increasing around these type of events.

On 15 July 2022 Derbyshire Fire Authority visited the premises and found that people were at risk whilst in the premises, they showed 9 points that need rectification to ensure the safety of customers at the premises. Alarmingly, following an audit last year there are still points which have not been addressed regarding the storage of LPG gas cylinders. On 28/05/2021 (Page 232 - 237) the audit instructed to

"Suggested Action

Re-locate the spare LPG cylinders to a more suitable location. They should be stored in a lockable cage outdoors. It should be stored as per UKLPG Code of Practice No 7 and suitably risk assessed by a competent person.

Reason

The spare cylinders were located indoors, on an escape route/stairway and not suitably ventilated or

protected by fire.

building that is dedicated for LPG.5 If this cannot be achieved, they should be limited to 15kg in no more than two cylinders and kept in a safe, secure and well-ventilated place where they cannot be interfered with, they can be kept upright (with valve protection fitted), they are away from sources of ignition and/or ignitable materials; and are away from any corrosive toxic or oxidant materials. They must never be located on any corridor or stairway or circulation space that will be used as an escape route, this includes escape from the flat that is currently being renovated.

Reason

LPG cylinders are being stored inappropriately and excessively. If a fire were to break out, these cylinders could exacerbate the fire or explode. This would put persons at risk.

If anything it appears that the situation has worsened over the last year. I find it difficult to believe that instructions on how to keep people safe from fire, that were issued a year ago are still being ignored to this day. It further shows that the premises and its management have little regard to the safety of its current customers.

To sum up, I believe I have shown in this statement and supporting documentation that this Premises is unsuitable to have children on site from 2000hrs to 0000hrs the likelihood of the Four Licensing Objectives (FLO) being breached is high and children would be at risk within this venue. There is also no evidence that the venue can show wrestling and boxing matches safely without adversely affecting the FLO.

I respectfully request that the committee refuse this application on that fact that it would negatively impact three of the four Licensing Objectives, those being, The prevention of crime and disorder, the protection of children from harm and Public safety.

Please summarise your concerns about this application:

The applicant, Scott Malcolm, who is also appointed as the Designated Premises Supervisor, has applied for a variation to the Premises Licence of the Hairy Dog, Becket Street, Derby.

The variation seeks the addition of a licensable activity, namely boxing and wresting also the removal of condition 31 which states,

No children are permitted on the premises after 2000 hours,

which would be replaced with

Children under the age of 18 are not permitted on the premises after 2000 hours, except in the following circumstances.

- 1. A live performance or an artist/s, boxing or wrestling event is taking place, and
- 2. They are accompanied by an adult

In the circumstance of 1 & 2 above, they are only permitted on the premises until midnight.

On Behalf of the Chief officer of Police, the Licensing Team have serious concerns that the Licensing Objectives will be undermined should this variation go ahead and therefore I wish to object to the granting of this variation.

The location of the premises is Becket Street, Derby which, is situated in the City Centre and a prominent area of the City Night Time Economy. In the immediate surrounding area, there are numerous other licensed premises which means the area is very busy particularly on Friday and Saturday evenings, with people wishing to enjoy the night-time economy. Unfortunately, this leads to multiple incidents of crime and disorder taking place, which are very often alcohol fuelled, leading to calls for service for the Police but also the Ambulance service and the Street Pastors.

Encouraging under 18's into the night time economy, where they are likely to be subjected to such incidents does not seem responsible and I have grave concerns that granting this variation would increase the possibility that children would come to harm.

The application does not provide adequate assurances that under 18's, who will be entering an adult environment will be protected from harm. The application states that they must be accompanied by an adult however it makes no mention of whether this adult would be known to them. There is no clarification on the lower age limit and a child of any age would be able to enter the premises until midnight and the application makes no mention to the nature of the performance being age appropriate for the audience.

I refer the 182 guidance which states the following.

2.22 The protection of children from harm includes the protection of children from moral, psychological and physical harm. This includes not only protecting children from the harms associated directly with alcohol consumption but also wider harms such as exposure to strong language and sexual expletives (for example, in the context of exposure to certain films or adult entertainment). Licensing authorities must also consider the need to protect children from sexual exploitation when undertaking licensing functions.



I have researched the incidents associated with the Premises is the last 12 months which covers the period since re-opening post covid. The Police system has a total of 37 incidents with 30 relating to violence. This is a high level of incidents for a Premises, especially in relation to violence.

A meeting was held with the applicant on 15 July 2022 to seek further clarification on what measures would be put in place to ensure that children would not come to harm. Following this meeting I requested that they send through their operating schedule and risk assessments relating to this variation. A further meeting was arranged for Friday 22 July to discuss any information they sent to me to see if any agreements could be made in respect of both aspects of the application. I received an email on 20 July 2022 from the agent of the applicant stating the following; "I am informed that you are due to meet again this Friday but, to keep you in the loop, the Music Venues Trust (MVT) a charity who deal with grass roots music venues all over the UK, are taking up the matter and will be writing a letter of support as to how the U18 issue is dealt with at music venues large and small all over the UK."

To date this letter has not been forwarded to me, but even if it had I do not believe that an outside organisation such as this trust, could negate the specific issues and needs of this venue, this would require the aforementioned risk assessments and operating schedules that only the person in day to day control of the premises can provide, these assessments and schedules have also not been sent through as discussed at the meeting on 15th July.

The concerns of the police also relate to the addition of Wrestling and Boxing to the Licence of the premises. Again, with the Premises being in the City Centre and the known rise in incidents when events such as boxing are shown until late into the night I do not believe that the edition of this Licensable Activity to the PL would not undermine the Four Licensing Objectives. There has been no risk assessments or operating schedules put forwards that would mitigate this.

During our informal meeting it was discussed that it may be practicable to reduce the hours of this Licensable Activity with it ending at 2000hrs before the normal night's activities take place. This is certainly one way to avoid further issues, but more details would need to be known around any conditions to bolster this addition. Again no information has been received since the original meeting.

With the lack of supporting evidence from the applicant, and the high number of violent incidents at the premises, 7 of which have happened between the hours of 2000hrs and 2359hrs I do not believe that the three of the four Licensing objectives Specifically those of the Prevention of crime and disorder and the protection of children from harm, would not be undermined if this application were to go through.

As we are unable to reach a compromise which gives the police satisfaction that the licensing objectives will not be undermined, The Chief Officer of Police for Derbyshire respectfully submits this representation in accordance with section 34 (3) of the Licensing act 2003.

A further bundle of supporting evidence for the grounds of this objection will follow.

ANNEX 1 - MANDATORY CONDITIONS

SUPPLY OF ALCOHOL

- No supply of alcohol may be made under the premises licence
 - a. at any time when there is no designated premises supervisor in respect of the premises licence; or
 - b. at any time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

DOOR SUPERVISION

3. Each individual required to be at the premises to carry out a security activity must be licensed by the Security Industries Authority.

MANDATORY CONDITION IMPLEMENTED ON 28 MAY 2014.

- 1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
- 2. For the purposes of the condition set out in paragraph 1 —
- (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
- (b) "permitted price" is the price found by applying the formula P = D + (DxV)Where P = D + (DxV)

- (ii) D is the rate of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
- (i) the holder of the premises licence.
- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "valued added tax" means value added tax charged in accordance with the Value Added Tax Act 1994
- 3. Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- 4. (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
- (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

MANDATORY CONDITIONS IMPLEMENTED 1 OCTOBER 2014

1. (1). The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises."

(2) An irresponsible promotion means any one or more of the following activities, or substantially

similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises –

(a) games or other activities which require or encourage, or are designed to require or

encourage, individuals to -

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective.

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which

carries a significant risk of undermining a licensing objective.;

other person is unable to drink without assistance by reason of a disability).

2. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.

(1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.

(2) The Designated Premises Supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy

- (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
- (a) holographic mark or
- (b) an ultraviolet feature

4. The responsible person must ensure that -

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures –

(i) beer or cider: ½ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises: and

(c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.

MANDATORY CONDITIONS - EXHIBITION OF FILMS

- 1 No film shall be exhibited unless:
 - a. it has received a "U", "PG", "12A", "15", or "18" certificate of the British Board of Film Classification; or
 - b. it is a current newsreel, which has not been submitted to the British Board of Film Classification.
- 2 "18" Films

No person apparently under the age of eighteen years shall be admitted to any exhibition at which there is to be shown any film which has received an "18" certificate from the British Board of Film Classification.

3 "15" Films

No person apparently under the age of fifteen years shall be admitted to any exhibition at which there is to be shown any film which has received an "15" certificate from the British Board of Film Classification.

- 4 "12A" Films
 - No person apparently under the age of twelve years shall be admitted to any exhibition unless accompanied by an adult at which there is to be shown any film, which has received a "12A" certificate from the British Board of Film Classification.
- 5 "PG" Films
 Some scenes contained at which there is to be shown any film, which has received a "PG" certificate from the British Board of Film Classification, may be unsuitable for young children.

- 6 "U" Films
 Films suitable for all is any film, which has received a "U", certificate from the British Board of Film Classification.
- Permission of Licensing Authority
 Notwithstanding the above, a film may be exhibited, or persons, or any class of person,
 may be admitted thereto if the permission of the licensing authority is first obtained and
 any conditions of such permission are complied with.

ANNEX 3 - CONDITIONS SET BY LICENSING SUB-COMMITTEE ON 19/02/16

CONDITIONS RELATING TO CRIME AND DISORDER

- 1) A CCTV system shall be installed and operating at all times. The cameras are to be positioned so as to ensure that all parts of the premises to which the public has access are sufficiently covered (save any toilet areas).
- 2) All recordings will be made in real time and shall be retained for a minimum of 28 days and made available for the view at the reasonable request of a Police Officer or other authorised person as detailed within section 13 Licensing Act 2003.
- 3) The recording system is to be secure and maintained in good working order and any faults repaired as soon as possible.

CONDITIONS RELATION TO PUBLIC SAFETY

- 4) An incident log will be maintained at the premises and all relevant incidents recorded within the log. The log will be written, retained at the premises for a minimum of 12 months and kept on the premises for production upon reasonable request of a Police Officer or other authorised person as detailed within section 13 of the Licensing Act 2003.
- 5) A written drugs policy will be maintained and adhered to at the premises and be available for

- production upon reasonable request of a Police Officer or authorised person as detailed in section 13 of the Licensing Act 2003.
- 6) The requirement for SIA registered door supervisors and toilet attendants is to be risk assessed and agreed with the local Police Licensing Department, a copy of the risk assessment is to be provided to the Licensing Authority. Once agreed, the risk assessment may only be amended with the prior written agreement of the local Police Licensing Department.
- 7) A minimum of two door staff will be on duty every Friday and Saturday evening from 21:00 when the premises are open for licensable activities.
- 8) A minimum of two door staff will be on duty at all times when live entertainment is being held at the premises.
- 9) SIA registered door supervisors employed at the premises will wear high visibility jackets/clothing to distinguish them in their role and make them easily identifiable.
- 10) SIA registered door supervisors shall be equipped with an appropriate method of keeping an accurate record of the capacity levels.
- 11) A daily record of the door supervisors that work at the premises (whether paid or unpaid) will be retained at the premises and will include:
 - start time and finish time of each door supervisor
 - SIA badge number
 - Door supervisor's will sign and print their name in a legible form
 - Each entry will be countersigned by the Designated Premises Supervisor.
- 12) The door supervisors log will be retained at the premises for a minimum of 12 months and kept on the premises for production upon reasonable request of a Police Officer or authorised person as detailed in section 13 The Licensing Act 2003.

- 13)No customer of the premises shall be allowed to take an alcoholic drink from the premises in an open container unless to an external area set aside for consumption as per the plan.
- 14) The first use of the premises for any of the licensable activities the subject of this grant shall not take place until the Premises Licence Holder deposits with each of the Licensing Authority, Derbyshire Fire & Rescue Service and Derbyshire Constabulary, a copy of:
 - i. a suitable fire safety risk assessment (which must be approved by the Derbyshire Fire & Rescue Service), within which a maximum occupancy figure (to include all personnel employed at the premises by the Premises Licence Holder, any performers engaged for an event on the premises, the event organiser (and any representatives of theirs) and patrons) shall be recorded. It shall also include an assessment of the optimal number of staff to be employed on the premises during the hours when licensable activity is ongoing. For the avoidance of doubt, references to staff exclude those personnel to be employed as door supervisors where a need to employ door supervisors arises;
 - ii. Confirmation of compliance with fire safety regulations.
- 15) The premises shall operate with the dispersal policy which was verified on 19 February 2016.
- 16) Notices must be displayed in the premises in prominent position which warn customers about the need to be aware of pick pockets or bag snatchers, and to guard their property.

CONDITIONS RELATING TO PUBLIC NUISANCE

- 17) No noise from regulated entertainment, including repetitive bass noise, shall be audible from within noise sensitive premises with their windows open in a typical manner for ventilation.
- 18) No amplified music or speech shall be relayed externally via loud speakers other than for events with the prior approval of the Licensing Authority.
- 19) The licence holder, Designated Premises Supervisor (DPS) or a suitably trained nominated representative, shall receive and respond to complaints throughout the duration of all noise generating events. A record of all complaints and any action taken as a result shall be maintained in a "complaints logbook" kept specifically for that purpose. The logbook shall be made available for inspection by a Police Officer, or any other authorised person as detailed

within section 13 of The Licensing Act 2003, upon their request.

- 20) The licence holder, Designated Premises Supervisor (DPS) or a suitably trained nominated representative, shall monitor the noise from time to time outside noise sensitive premises, during every event involving amplified music or speech. If as a result of such monitoring, it is considered that the noise levels are excessive, immediate action should be taken to reduce the volume to acceptable levels.
- 21) Sound levels from amplified music shall be set at a level agreed in writing with the Environmental Protection Team, Environment and Regulatory Services, Derby City Council. The agreed level, which will be based on avoidance of noise nuisance to nearby sensitive receptors, shall not be exceeded at any time.
- 22) The Designated Premises Supervisor (DPS) shall ensure that clear prominent and legible notices must be displayed internally at all exits, requesting customers and other users to leave the premises and the area local to the premises quietly and in an orderly manner respecting the needs of local residents.
- 23) Customers or other users of the premises can only smoke in the designated smoking area agreed and outlined on the submitted plan of the premises.

CONDITIONS RELATING TO THE PROTECTION OF CHILDREN FROM HARM

- 24) Full training to be provided to all staff on commencement of employment relating to age restricted sales and any systems and procedures that they are expected to follow in the course of age restricted sales will be provided to them.
- 25) Refresher training will be provided every 12 months.
- 26) Records detailing the training provided will be written and retained at the premises for a minimum of 12 months and kept on the premises for production upon reasonable request of a Police Officer or authorised person as detailed in section 13 of The Licensing Act 2003.
- 27) A challenge 25 policy/ proof of age scheme will be operated at all times.

- 28) Clear signage will be displayed at the entrances/ exits to the premises informing customers of the challenge 25 policy/ proof of age scheme.
- 29) A system of recording sales refused under the challenge 25/ proof of age scheme shall be operated at all times. The system will be written and retained at the premises for a minimum of 12 months and kept on the premises for production upon reasonable request of a Police Officer or authorised person as detailed in section 13 of The Licensing Act 2003.
- 30) Children under 16 must be accompanied by an adult.
- 31) No children are permitted on the premises after 20:00 hours
