# Schools Capital Programme 2017/18

# SUMMARY

- 1.1 The Council is currently awaiting notification from the Department for Education (DfE) for our confirmed School Condition maintenance allocations for 2017-18.
- 1.2 In order to commence scheme development, and to complete essential work during the school summer holiday period, early approval of schemes is necessary. It is therefore proposed to obtain scheme approval in principle, based on indicative allocations. A full breakdown of the indicative Schools capital programme funding for 2017/18 is set out within Appendix 2. Indicative allocations were included in the Council budget agreed by full Council on 1 March 2017. The proposed Schools capital programme schemes for 2017/18, including proposed individual school condition maintenance projects, are outlined in Appendix 3.
- 1.3 The proposal is for funding to be prioritised to deal with essential school condition and maintenance issues across the schools estate. An on-going programme of work is required in school premises to deal with essential condition and health and safety issues to ensure that school buildings remain safe and open.
- 1.4 The DfE are also due to announce confirmation of Basic Need capital allocations (for school place planning) for 2018/19-2019/20 in relation to the Council's statutory duty to ensure sufficient school places. The Council's indicative allocation is £14m. Very careful consideration is being given to the allocation of the remaining funding and priority projects will be developed in due course and reported to Council Cabinet.
- 1.5 This report also provides an update on the Council's successful bid to the DfE for Early Years Capital funding to create free early education entitlement (FEEE) places for eligible three and four year olds to access the new extended entitlement of 30 hours of free childcare. The Council has been successful in its bid for a scheme at Brackensdale Infant School for £207,274. The Council has also recently received confirmation that its bid relating to Alvaston Infant School has also been successful for an additional £241,161.
- 1.6 The DfE have also recently announced new Special Provision funding for improvements to mainstream or special schools for pupils with Education, Health and Care (EHC) plans. Funding will be allocated in a three-year programme running from 2018/19 to 2020/21. Derby will be allocated a total of £825,487. This will be phased equally, with £275,162 in each of the three years running from 2018/19 to 2020/21. This funding is currently being considered and projects will be developed in due

course, and reported to Council Cabinet for consideration.

- 1.7 Derby is also expected to be allocated an additional £246,000 for capital schemes in Voluntary Aided schools as set out in Appendix 4. This funding is ring-fenced for VA schools and the Council is required to co-ordinate the allocation with both dioceses.
- 1.8 This report also provides an update on progress with the PSBP initiative which is managed by the Education Funding Agency, with support of the Council. There were seven schools within the PSBP1 programme, and all have been completed with contractors now offsite.
- 1.9 An update on Derby City Council's two successful bids, for The Bemrose School and Cavendish Close Infant School, for additional capital funding through the PSBP2 initiative is also provided. The DfE timescales for these projects are only indicative at this stage, but construction could begin within the next year.
- 1.10 This report seeks Council Cabinet approval for the Schools Capital Programme 2017/18 as set out within Appendix 3 and Appendix 4.

#### RECOMMENDATION

- 2.1 To approve the Schools Capital Programme priority schemes for 2017/18 as outlined in Appendix 3 and Appendix 4.
- 2.2 To approve scheme commencement and amendment to the approved 2017/18 2018/19 capital programme with proposed scheme allocations, to note that the final allocations will be reported to Cabinet once confirmed.
- 2.3 To amend the 2017/18 2019/20 capital programme to add the new Early Years Capital funding and the Special Provision funding.

# REASONS FOR RECOMMENDATION

- 3.1 An on-going programme of work is required in school premises to deal with essential condition and health and safety issues, across the schools estate, to ensure that school buildings remain safe and open. In order to complete as much work as possible during the school summer holiday period, early approval of schemes is necessary.
- 3.2 In accordance with Financial Procedure Rules, amendments to the Council's capital programme are required to be reported to Cabinet.

# SUPPORTING INFORMATION

- 4.1 Capital investment across the schools estate in Derby is essential to address maintenance and condition issues. There remains a significant backlog of condition issues across the schools estate, which is in excess of £20,000,000 for priority works. This condition backlog only covers building condition issues and excludes costs associated with betterment (unless required under Building Regulations), asbestos identification/removal, work identified as a result of fire risk assessments or any water hygiene remedial work.
- 4.2 The Council's Capital Programme Budget for 2017/18 to 2019/12 was ratified by Council, on 1 March 2017, based on indicative DfE allocations for future years funding. At the time of reporting, the Schools capital programme was estimated to be £36,427,271 for 2017/18 to 2019/120. This consisted of £6,398,542 of approved schemes and £30,028,729 in indicative funding. The indicative Condition funding for 2017/18 has yet to be confirmed by the Department for Education (DfE), but this is expected to be approximately £2,300,000. The DfE will make further announcements on 2018/19 and 2019/20 condition maintenance and school devolved formula capital allocations.

# 4.3 Early Years Capital Fund

The Council have also been notified of the success of its bid to the DfE Early Years Capital Fund for a scheme at Brackensdale Infant School. The scheme is to create free early education entitlement (FEEE) places for eligible three and four year olds to access the new extended entitlement of 30 hours of free childcare.

The successful bid will be for adaptations and an extension to create the new provision. Works will involve the relocation of current SEN provision to allow for refurbishment, and an extension, to provide 26 FEEE places. The scheme will cost £296,106, with £207,274 provided in successful grant funding. The balance of £88,832 will be funded from existing approved Early Years capital programme funding. Part match funding of the works was a criteria of the grant application.

4.4 The Council has also received recent confirmation that its bid for new provision at Alvaston Infant School has also been successful. The scheme at Alvaston Infant was to provide new accommodation to provide 26 FEEE places. This scheme will cost £344,516, with £241,161 provided in successful grant funding. The balance of £103,355 will be funded from existing approved Early Years capital programme funding. Part match funding of the works was a criteria of the grant application.

# 4.5 Special Provision Fund

The DfE have also announced new Special Provision funding for improvements to mainstream or special schools for pupils with Education, Health and Care (EHC) plans. This funding is primarily intended to develop provision for pupils with more complex special education needs in mainstream or special schools, but can also be used for children and young people aged 0 to 25. Funding will be allocated in a three-year programme running from 2018/19 to 2020/21. Derby will be allocated a total of £825,486. This will be phased equally, with £275,162 in each of the three years running from 2018/19 to 2020/21. This funding is currently being considered and projects will be developed in due course, and reported to Council Cabinet for consideration.

## 4.6 Schools Maintenance Capital Programme

It is expected that Derby will be allocated £2,300,000 School Condition maintenance funding for 2017/18, together with an additional £246,000 for Voluntary Aided Schools. The Council is currently still awaiting final confirmation of allocations from the DfE for 2017/18. In order to commence scheme development, and to complete essential work during the school summer holiday period, early approval of schemes is necessary. Once confirmed, final allocations will be reported to Cabinet and the School Capital Programme 2017/18 – 2019/20 amended accordingly.

A full breakdown of indicative Schools Capital Programme Funding for 2017/18 is set out within Appendix 2.

- 4.7 School capital projects for 2017/18 have been prioritised for those schools with the highest level of need, to ensure that buildings are safe by addressing urgent health and safety issues and dealing with buildings at risk issues. The priority condition schemes for 2017/18 primarily fall into one of the following four categories:
  - Window and roof replacement works;
  - Electrical upgrades and replacements;
  - Fire precaution work;
  - Mechanical projects (heating/boiler replacements).

The proposed priority school condition projects for 2017/18 are shown in Appendix 3, including details of the proposed work and budget estimates. These budget estimates are subject to a detailed feasibility, design development and procurement process.

4.8 There are a range of major projects proposed within the Schools Capital Programme 2017/18, detailed in Appendix 3, to address high priority maintenance and condition issues across the schools estate. For example, major schemes are proposed at Littleover Community School (£750,000), St Clare's Special School (£400,000), Pear Tree Infant School (£250,000), Oakwood Junior School (£200,000) and Murray Park School (£100,000). Further summary information on some of the major proposed schemes is set out below.

#### 4.9 Littleover Community School

A £750,000 scheme is proposed at Littleover Community School which consists of a second phase of major condition works to two of the main two storey teaching blocks,

which are in poor condition. This project will include replacement of obsolete boilers to M & N Blocks where failure of heating and hot water could pose a risk of school closure. Works will also include new heat distribution pumps, localised pipe work alterations and new flues. The proposed project will also include upgrading the fire protection to the N block boiler room. The project will also include new replacement windows and external doors to all four elevations of the two storey N Block.

# 4.10 St Clare's Special School

Proposed works include the recovering of the school roof and new high level clearstory windows to the main school hall. The works are designed to address roof leaks and prevent deterioration to the building fabric and structural roof deck. It is proposed to recover the whole school building roof, including a significant number of new roof lights and provide new insulation. The proposed budget is £400,000.

# 4.11 Pear Tree Infant School

The proposal is to continue with Phase 2 of the school reroofing programme following several roof leaks causing damage to the building fabric and finishes. Roofing works will complete the roof recovering of the remaining school building and will also include additional insulation and new roof lights. As part of this scheme it is also intended to undertake phase 1 of the school replacement window programme. Phase 1 window replacement will include high level hall windows and the main playground elevation. The proposed budget is £250,000.

# 4.12 Oakwood Junior School

It is proposed to proceed with phase 2 of 4 phases to rewiring works of the school. Works will include a new fire alarm with automatic detection, new emergency lighting, new power and new lighting within classrooms and corridors to approximately half of the main teaching accommodation. There will be associated work included within this phase, including new suspended ceilings and roof strengthening. The proposed budget is £200,000

# 4.13 Murray Park Community School

The proposed scheme at Murray Park is to continue a phased programme of priority fire risk assessment works, and associated condition remedial work. It is proposed to continue with phase 3 of the works, including building at risk issues highlighted as requiring attention in structural surveys. Fire Risk Assessment works will include new fire barriers, new ceilings, new lighting and reinstatement of fire alarm units. The proposed budget is £100,000.

# 4.14 Locally Co-ordinated Voluntary Aided Programme (LCVAP)

Derby is also expected to receive an allocation of £246,000 for the Local Authority Coordinated Voluntary Aided Programme (LCVAP) for 2017/18. This funding is ringfenced for capital schemes at Voluntary Aided schools. The Council is required to coordinate allocation of LCVAP funding with both Diocese. All funding is allocated directly to the schools/diocese from the DfE. The initial proposed priority schemes are set out in Appendix 4. The individual schools are responsible for completing these projects in conjunction with their diocese. LCVAP projects are funded at 90% levels with a requirement for school governing bodies to make a contribution of 10%.

#### 4.15 Basic Need Programme – Additional School Places

The DfE is still to announce final basic need capital allocations (for school place planning) for 2018/19 and additional basic need funding for 2019/20. Derby City Council has a remaining allocation for 2017/18 and an indicative 2018/19 allocation of £16,129,729. The Council's capital programme also contains provision for an assumed allocation of £3,800,000 in 2019/20. Very careful consideration is being given to the allocation of the remaining funding and priority projects will be developed in due course and reported to Council Cabinet.

#### 4.16 Schools Devolved Formula Capital

The DfE is also still to confirm school Devolved Formula Capital funding for individual schools. This funding is to be used by schools on maintenance and condition projects. This is a small funding stream based on a formulaic allocation of £4,000 per school, and a small per pupil element. Schools prioritise funding in line with the Council's School Asset Management Plan.

It is anticipated that Derby will be allocated  $\pounds 626,626$  for Community, Foundation and Voluntary Controlled schools in 2017/18. In addition, Voluntary Aided schools are expected to be allocated  $\pounds 63,170$ .

# 4.17 Priority Schools Building Programme 1 - update

The Priority Schools Building Programme (PSBP) is a national programme to re-build those schools in the worst condition. All seven schools within the Council's successful PSBP1 bid have now been completed. The following schools have been rebuilt as part of the programme:

Asterdale Primary School Carlyle Infant and Nursery School Cavendish Close Junior School Chaddesden Park Primary School Reigate Park Primary and Nursery School Allestree Woodlands School Lees Brook Community School

# 4.18 Priority School Building Programme 2

Following the success of the Council's bid for the PSBP1 programme for the highest priority schools set out above, the DfE announced in February 2015 that the Council was successful with a further two bids. These bids were for Bemrose School and Cavendish Close Infant School. The PSBP2 will be delivered centrally and managed by the DfE.

#### 4.19 **The Bemrose School** – refurbishment of the main teaching block:

The DfE have completed further detailed feasibility works to determine the most appropriate investment solution, and are now in the process of procuring a contractor for the regional construction framework which Bemrose will sit within. It is anticipated that the DfE will appoint a contractor for the Bemrose School in October 2017, with construction beginning on the new classrooms in January 2018. It is expected that refurbishment of the main teaching block will then begin in April 2019, with construction work completing in September 2020.

4.20 **Cavendish Close Infant School** – replacement of both existing school blocks to build a new school:

The DfE are currently working with the school to develop the scheme to replace the current school buildings with a single new building Final designs for the new school will be confirmed once the DfE have appointed their preferred contractor. This is expected to be confirmed during 2017 and the contractor may begin works on site at the end of 2017.

Further details of the nature and timing of the above PSBP2 schemes are still to be announced by the DfE, as the PSBP2 initiative is scheduled to run until 2021. The Council will continue to work closely with the EFA to establish timescales, and support schools as necessary.

#### OTHER OPTIONS CONSIDERED

5.1 The available capital funding has been prioritised in line with the School Asset Management Plan to deal with the most urgent condition and health and safety issues, and to ensure sufficient school places.

# IMPLICATIONS

#### **Financial and Value for Money**

- 1.1 The Council's school condition maintenance allocation for 2017/18 is expected to be approximately £2,300,000. In addition to this, it is expected that £246,000 will be allocated for the LCVAP programme for Voluntary Aided (VA) schools. The schools Devolved Formula Capital allocation is expected to be £626,622, with and additional allocation of £63,170 expected for Devolved Formula Capital for VA schools. Appendix 2 outlines the overall anticipated funding for the Schools Capital Programme for 2017/18 to be invested across the schools estate. Appendix 3 and 4 outline the proposed school projects. A further update will be reported once the allocations are confirmed.
- 1.2 The DfE Early Years Capital Fund grant to create 26 FEEE places at Brackensdale Infant will be for £207,274. The scheme will cost £296,106, with £207,274 to be provided in successful grant funding and the balance of £88,832 funded from existing approved Early Years capital programme funding.

The DfE Grant for the new 26 FEEE place provision at Alvaston Infant will be for £241,161. The scheme will cost £344,516, with the balance of £103,355 funded from existing approved Early Years capital programme funding.

The match funding element for both schemes will be from existing Early Years capital funding of £197,000 currently available on the Schools Capital Programme. Part match funding of the works was a criteria of the grant application.

1.3 All School Capital Programme schemes will be procured in line with the Council's Contract Procedure Rules.

#### Legal

- 2.1 If any works require planning permission approvals, these will be sought prior to works commencing. Where there is an impact on School Playing Fields being able to provide team game playing field pitches, the Council will consult with Sport England.
- 2.2 The Equality Act 2010 places a duty on all schools and Local Authorities to plan to increase over time the accessibility of schools for disabled pupils.
- 2.3 In principle scheme approval is being sought ahead of notification of final funding allocations being confirmed; the Council will proceed to develop schemes but will not sign contracts that make financial commitments of the indicative allocation, in respect of these schemes, until confirmation of funding allocations is received from the DfE. Until the final allocations are confirmed, only financial commitments will be made which can be funded from existing confirmed capital allocations.

#### **Equalities Impact**

5.1 The Council aims to take reasonable steps to remove, alter or provide reasonable means of avoiding physical features that make it impossible or unreasonably difficult for disabled people. Capital funding has been allocated for disabled access improvements.

6.1 The priority projects are important for Health and Safety reasons and to conform to Building and Workplace Regulations 1992. Health and Safety procedures will be followed in delivering schemes.

7.1 All school capital programme schemes will be carried out in line with the latest Building Regulations on environmental performance.

#### **Property and Asset Management**

8.1 An on-going programme of work is required in school premises to deal with essential condition and health and safety issues to ensure that school buildings remain safe and open. The available funding has been prioritised in line with the key priorities set out in the Schools Asset Management Plan. The Schools Asset Management Plan is developed in line with the Council's Property and Asset Management Plan.

#### **Risk Management and Safeguarding**

- 9.1 The priority projects will reduce the risk of future school closures due to structural, mechanical or electrical failures. It should be noted that that the overall school condition backlog exceeds the funding available, therefore schemes are prioritised where there is greatest risk of school closure in order to ensure schools remain safe and open. Where it has not been possible to prioritise schemes, mitigation plans will be developed in consultation with schools.
- 9.2 All projects will be managed and monitored in line with the Council's project management and risk assessment procedures.

#### Corporate objectives and priorities for change

10.1 This report supports the Council priority outcomes of Enabling individuals and communities, and Raising achievement and skills.
